Introduction

OVERVIEW

The American Rescue Plan (ARP) provides \$5 billion to assist individuals or households who are homeless, at risk of homelessness, and other vulnerable populations, by providing housing, rental assistance, supportive services, and non-congregate shelter, to reduce homelessness and increase housing stability across the country. These grant funds will be administered through HUD's HOME Investment Partnerships Program (HOME).

ELIGIBLE GRANTEES

State and local participating jurisdictions that qualified for an annual HOME Program allocation for FY 2021 are eligible to receive HOME-ARP grants. HOME-ARP funds will be allocated using the HOME Program formula. The HOME-ARP allocations were announced on April 8, 2021. The City of Eau Claire was allocated \$1,140,076 in FY2021 HOME ARP funding.

Describe the consultation process including methods used and dates of consultation:

Consultation with service providers has been an ongoing process. The City of Eau Claire Housing Division takes pride in meaningful connections they have with partners within the community in order to make a larger impact. Consultations have taken place through in person meetings, virtual meetings, phone calls and emails with City staff. These consultations focused on seeing information regarding the programs going on currently within these agencies, their upcoming plans, goals and what gaps they see in trying to make these goals a reality. Summarize feedback received and results of upfront consultation with these entities:

The feedback overwhelmingly points to the need for more permanent and affordable housing for individuals with lower incomes. The current shortage in Eau Claire and across the region of housing solutions that are affordable to low-income individuals has created a significant need for additional housing units that can fulfill this need. Eau Claire's homeless population and populations at risk of becoming homeless continues to increase due to the lack of low-income housing availability. An increase in available low-income housing stock will help fill the gap created by low inventories of low- income housing options. Additionally, many of our people

experiencing homelessness will need supportive services with their housing. Permanent Supportive Housing is a needed housing solution.

A Draft HOME-ARP Allocation Plan was made available for public comment beginning April 22, 2024 and ending May 7, 2024. The plan was available on the City of Eau Claire's website and in the City of Eau Claire Housing Division's office at 203 S Farwell St, Eau Claire, WI. Notice of the comment period and public hearing was made available via public notice in the *Leader Telegram*. The City of Eau Claire's Housing Division held a public hearing on the HOME-ARP Allocation Plan on May 2, 2024 at 11:00 a.m. in the City Council Chamber of City Hall. Written comments were accepted throughout the review period and oral comments were accepted during the public hearing.

Describe the size and demographic composition of qualifying populations within the PJ's boundaries:

Homeless as defined in 24 CFR 91.5

According to the Point in Time (PIT) count conducted during a 24-hour time period on January 22 and 23rd 2022, there are approximately 89 individuals experiencing homelessness in Eau Claire. Of these individuals, 27 identify as female and 62 identify as males. These individuals largely represent the 19 to 65-age range and identify as male. Ten of these individuals are considered chronically homeless and nine (9) are unsheltered individuals. Of these individuals, approximately 83% identify as White, 7% Black or African American, 2% Asian, 2% American Indian, First Nations or Alaska Native, and 6% prefer not to say. Of these, 8% were Hispanic/Latino. These individuals largely represent the 18 to 60-age range with 65% identify as male.

During the PIT count, there were a total of 89 people experiencing sheltered homelessness between Sojourner, Family Promise and Western Dairyland shelters. 11% identify as male, 38% identify as female and 1% were transgender. 75% were adults over the age of 18, and 25% were Children. 76% were White, 10% Black or African American, 2% Asian, 2% American Indian, and 10% Multiple races, 15% were Hispanic/Latino. 24% of those in shelter reported previous history with domestic violence.

At Risk of Homelessness as defined in 24 CFR 91.5

According to the Point in Time (PIT) count, there were four single adult male veterans that were at risk of homelessness. There were nine (9) people were at-risk of homelessness. 22% were adults and 28% were children. 56% identify as male and 44% identify as female. 12% were White, 44% were Black or African American, and 44% were of Multiple Races and none were Hispanic/Latino. 22% reported a history of domestic violence.

Data from the Comprehensive Housing Affordability Strategy (CHAS) data based on 2016-2020 ACS 5- year estimate for the City of Eau Claire shows a total of 12,160 rental units available in Eau Claire. Of those units, 25.9% are affordable to households at-risk of homelessness (at or below 30% area median income (AMI)) and 40.6% are affordable to households at or below 50% AMI. Within the 30% AMI, 83.5% are households with 1 or more severe housing problems.

CHAS data does not tell an accurate story based on current housing needs. 2016-2020 ACS 5-year estimates show a 5.63% vacancy rate for the City of Eau Claire. 2018-2022 ACS 5-year estimates show a 1.98% vacancy rate for the City of Eau Claire. 2018-2022 ACS 5-year estimates have an increase of rental units to a total of 12,772 (+612). With that increase, availability of housing has significantly decreased leading to increased demand and higher prices on all units. This has drastically decreased units available to individuals making less then 50% of CMI.

Fleeing, or Attempting to Flee, Domestic Violence, Dating Violence, Sexual Assault, Stalking, or Human Trafficking, as defined by HUD in the Notice

In our community, our agencies assist approximately 10-13 people per quarter that are in this qualifying population. 85% were Adults, 15% Children, 76% identify as female, 16% identify as male and 8% Other. Of these individuals, approximately 77% identify as White, 5% Black or African American, 3% Asian, 6% Multiple Races, 4% Hispanic and 5% Other. 82% sought shelter for Domestic Violence, 35% Sexual Assault, 4% Human Trafficking and 5% Elder Abuse. Services include but are not limited to: emergency shelter, counseling and advocacy and assistance with orders of protection. Data was not available on overlap in populations.

Other populations requiring services or housing assistance to prevent homelessness and other populations at greatest risk of housing instability, as defined by HUD in the Notice

There were 35 individuals enrolled in rapid re-housing through either Family Promise or Western Dairyland. 49% were Adults and 51% were Children. 26% identify as male and 74% identify as female. 74% were White, 6% Black or African American, 20% were of Multiple Races, and 1% were Hispanic/Latino. 23% reported a history of Domestic Violence.

There were 33 individuals enrolled in Permanent Supportive Housing through Western Dairyland. 79% were adults, 21% children. 73% identify as male and 27% identify as female. 88% were White, 6% Black or African American, 3% were Asian, and 3% were of Multiple Races and 6% were Hispanic/Latino. 15% reported they had a history of Domestic Violence.

According to 2020 5-year American Community Survey data, Eau Claire's median household income was \$59,705 with 30% MHI at \$17,912. Due to Census income breaks, at-risk of being homeless is being calculated at \$24,999 MHI and 19% (5,328 households) of the City of Eau Claire's households are at risk of being homeless. The 2021 Asset Limited Income Constrained Employed (ALICE) report for Eau Claire County shows 24% of households are considered ALICE households, households earning just above the Federal Poverty Level but less than what it costs to make ends meet. ALICE workers often struggle to keep their own households from financial ruin while keeping our communities running. The same report found 12% of households in Eau Claire County are households in poverty. Data for cities in Eau Claire County shows 39% of households in the City of Eau Claire are ALICE households.

Describe the unmet housing and service needs of qualifying populations:

Homeless as defined in 24 CFR 91.5

The homeless in the community need more options for permanent affordable housing. Currently, there are not enough low-income dwellings to accommodate individuals who are unsheltered and seeking housing. Additionally, as the homeless population continues to increase, providing access to more permanent, affordable housing opportunities will help ensure that low-income people experiencing homelessness will have access to housing options that will be sustainable on a limited income.

At Risk of Homelessness as defined in 24 CFR 91.5

Due to the shortage of affordable housing options, many individuals and families in our community are at risk of experiencing homelessness because they are unable to afford the rising cost of housing in our area.

Fleeing, or Attempting to Flee, Domestic Violence, Dating Violence, Sexual Assault, Stalking, or Human Trafficking, as defined by HUD in the Notice

As with other qualifying populations, those fleeing interpersonal violence need access to permanent housing that is affordable.

Other populations requiring services or housing assistance to prevent homelessness and other populations at greatest risk of housing instability as defined by HUD in the Notice

There is a need for supportive services, on-going case management and housing with the homeless or at risk of becoming homeless veterans in the City of Eau Claire. There is a need for increased outreach efforts to help inform people at-risk of programs available to attempt to prevent someone from becoming homeless.

Identify any gaps within the current shelter and housing inventory as well as the service delivery system:

There is a strong need for permanent housing especially for single male adults and family units. Shelters within the city are typically full. The emergency shelter is often near capacity and goes into overflow during extreme weather situations. Low-income housing solutions are needed to help house people experiencing homelessness and reduce capacity concerns at the emergency shelter. Development of affordable housing will enable people experiencing homelessness to have housing options that will be sustainable with low income.

Identify priority needs for qualifying populations:

As stated throughout the allocation plan, priority needs for our community for qualifying populations is the need for low-income housing units.

The City of Eau Claire was able to secure information from the agencies through consultations, but also leveraged information from the Point in Time (PIT) count, along with various agencies yearly summaries of the demographics helped.

HOME-ARP Activities

Our goal is to solicit proposals that would increase available housing options for individuals in all four qualifying populations. We spoke to the local service agencies about this goal which was met with overall acceptance.

Programming will be open to all members of the four qualifying populations. Our justification is that we want to do a "bricks and mortar" type project for those in the qualifying populations to expand affordable housing in our jurisdiction.

The City will prepare a Request for Proposals and accept applications from organizations who are proposing to develop housing units for the qualifying population.

The City of Eau Claire intends to use the HOME-ARP money to assist with the acquisition and rehabilitation or new construction in the area to develop low-income housing. The City of Eau Claire worked diligently to gather data from as many agencies as possible. The City then analyzed the data to assess where the largest gap was, and then, what the biggest need would be to fulfill the gap. They also assessed what cause and effect would come of the different scenarios, and which scenario could help the most people. The consistent feedback that the City received was the need for more affordable housing units.

HOME-ARP Production Housing Goals

The City of Eau Claire estimates that over a 3-year period a total of 16 units for qualifying individuals/families will be produced with the HOME-ARP allocation and they will remain available for a minimum of 15 years. The addition of these units will result in individuals and families maintaining and/or improving their housing stability and self-sufficiency.

Describe the specific affordable rental housing production goal that the PJ hopes to achieve and describe how the production goal will address the PJ's priority needs:

The City of Eau Claire hopes to see multiple units created for low-income individuals with the HOME-ARP funding. The housing units created will help house individuals who are in one of the four qualifying groups.
