# City of Niagara Falls HOME-ARP Allocation Plan

## Background

The American Rescue Plan Act of 2021 appropriated \$5 billion to provide housing, services, and shelter to individuals experiencing homelessness and other vulnerable populations. These funds were allocated by formula to jurisdictions that qualified for funding through the HOME Investment Partnership Program (HOME Program) from the U.S. Department of Housing and Urban Development (HUD). This special round of funding is called the "HOME-ARP" program. In September, 2021, HUD awarded the City of Niagara Falls \$1,624,703 in HOME-ARP funds.

Eligible activities that may be funded with HOME-ARP include: (1) development and support of affordable housing; (2) tenant-based rental assistance; (3) provision of supportive services (such as housing counseling, homelessness prevention, child care, job training, legal services, case management, moving costs, rental applications, and rent assistance; and (4) acquisition and development of non-congregate shelter units.

Funds must primarily benefit individuals and households in the following qualifying populations:

- Experiencing homelessness (as defined in 24 CFR 91.5 "Homeless" (1), (2), or (3))
- At risk of homelessness (as defined in 24 CFR 91.5 "At risk of homelessness")
- Fleeing domestic violence, dating violence, sexual assault, stalking, or human trafficking, (as defined in 24 CFR 5.2003)
- Other populations with high risk of housing instability (including highly cost-burdened low-income households, households who have moved two or more times in the last 60 days, and households living in a hotel/motel)

#### Consultation

Before developing its HOME-ARP allocation plan, the City of Niagara Falls was required to consult with the local Continuum of Care (CoC), homeless and domestic violence service providers, veterans' groups, public housing agencies (PHAs), public agencies that address the

needs of the qualifying populations, and public or private organizations that address fair housing, civil rights, and the needs of persons with disabilities.

## Describe the consultation process including methods used and dates of consultation:

The City of Niagara Falls has prepared our HOME-ARP Allocation Plan to strategically implement the federal program that provides funding for housing activities that will benefit those individuals and families experiencing homelessness, at risk of homelessness, Domestic Violence, Stalking, Human Trafficking, or those with the greatest risk of housing instability within the City of Niagara Falls.

The consultation process entailed one (1) public meeting, as well as discussions with local service providers, the Niagara Falls Housing Authority (NFHA), and the Niagara County Continuum of Care (CoC). The City developed this HOME-ARP Allocation Plan and application document for the use of obtaining Federal Entitlement funding being made available through the HOME-ARP Allocation.

The City of Niagara Falls identified and consulted with all appropriate social service agencies that provide services directly to the identified Qualified Populations, requesting recommendations/feedback for proposed projects as related to the amendment of the 2021 Annual Action Plan to include the HOME-ARP allocation.

The agencies that the City of Niagara Falls requested input from and participated in the consultation process for the HOME-ARP allocation were:

The City of Niagara Falls Office of Community Development staff also spoke at the January 9, 2023 and March 13, 2023, Niagara County Coalition for Homeless Services virtual board meeting regarding the requirements for the HOME-ARP allocation and any proposed activities.

The City of Niagara Falls will submit to the U.S. Department of Housing & Urban Development (HUD) a HOME-ARP Allocation Plan through an amendment to the 2021 Annual Action Plan.

The City consistently confers with the Niagara County CoC to address the needs of persons living with disabilities through participation in monthly CoC meetings.

## Summarize feedback received and results of upfront consultation with these entities:

The comments received ahead of time and during the public information meeting were generally supportive of the information included within the plan, but most recommendations requested that the City try to address as many needs as possible with the funding and try to spread across as many of the eligible populations including the most chronically homeless. Recommendations included; remodeling vacant city owned structures to house those facing chronic homelessness. Several comments encouraged the City to use the funds to build supportive housing for extremely/very low income households, and to partner with non-profits to both develop the housing and provide services to the eventual tenants.

## Public Participation

The public had an opportunity to attend either in person or by teleconference to discuss the HOME-ARP requirements and comment accordingly, including a thirty (30) day comment period.

## Describe efforts to broaden public participation:

During the consultation session, participants were asked to describe what people experiencing or at greatest risk of homelessness say they need, in addition to what professionals understand to be the primary needs and opportunities in the City of Niagara Falls. Participants were encouraged to provide follow-up information or ideas as they arise and to identify any additional stakeholders that would help enhance the process. Additionally, the City of Niagara Falls utilizes its website to inform residents of current news, public meetings as well as all current & new programming.

  - 1. Acquisition, rehabilitation, adaptive reuse, or construction of affordable rental housing, including permanent supportive housing for qualifying populations. Half of the staff said this was #1 and the other half #2.
  - 2. Tenant-based rental assistance (TBRA) to help qualifying populations pay rent, security deposits, and utility deposits and payments. Most of the staff said if they could have two 1's this would be the other one.
  - 3. A broad range of supportive services to prevent homelessness and foster housing stability such as emergency assistance, job training, childcare, and educational services. Staff voted all over for this one. Either in 4<sup>th</sup> or 5<sup>th</sup> spot. They also suggested taking out some of the job training, since that is offered already.
  - 4. Acquisition and development of non-congregated shelter to create private temporary units/rooms for households experiencing homelessness or fleeing abusive situations. Staff voted for this to be number 3
  - 5. Capacity Building & Nonprofit Operating to build capacity and financial stability in local nonprofit organizations serving your community with HOME-ARP activities; Staff mostly said leave it at 5.
  - 6. Administration and planning to hire, train, and support new staff to select, manage, monitor, and evaluate HOME-ARP projects and activities. Everyone said leave it last.
- <u>Joyelle Tedeschi Belmont Housing of WNY</u> The need for affordable housing for low-income families and individuals is at an all-time high. We have always been unable to meet the need but with the housing market as it is now the low stock of quality of affordable housing needs to be at the forefront of where we put our resources. Programs like TBRA could allow families/individuals to stay in place -assuming the units pass HQS inspection, and the landlord works with us- a more expedient way to secure housing

and stabilize families. Support Services that are partnered with housing subsidized are shown to be the most effective. Obtaining housing is task one but to maintain and then move forward for families the supports are needed to help support. For some families providing a low-barrier application for the one-time financial crisis that could cause housing instability has proven to be a way to prevent families from entering the "homeless" system. Non-profits are especially feeling the strain of the recent turnover the job market has experienced. We can't maintain employees when we are not able to provide them with the ability to provide fully for their families. In the past non-profits have leaned on the ability of two-income households being able to "afford" one income earner to earn less. Two-income households are not the norm, Non- Profits have had to figure out how to balance the quality of service and the ability to serve with fewer staff as budgets get tighter. Affordable Housing entities have always had to balance the ability to build and maintain affordable housing with an operation budget that does not necessarily support the operation needs of the building. As mentioned above staffing for all has been a challenge. Companies have had to take steps back as new employees have come on and need to train them to get up to speed while still trying to main the work needed to be done. But proper recruitment and training are essential for the long-term success of these programs.

DeAnna Eason - Housing Opprtunities Made Equal (HOME) - Housing Opportunities Made Equal, Inc. (HOME) is a civil rights organization founded in 1963 whose mission is to promote the value of diversity and to ensure all people an equal opportunity to live in the housing and communities of their choice—through education, advocacy, enforcement of fair housing laws, and the creation of housing opportunities. We hold contract with several local municipalities, Erie County, New York State, and the Department of Housing and Urban Development in an effort to enforce fair housing in Western New York. Although HOME does not possess a contract of this sort with the City of Niagara Falls, we regularly advise it's residents of their rights and responsibilities under fair housing laws, mediate landlord and tenant issues, provide technical assistance when requested, assist families in finding safe and affordable housing, hold fair housing presentations and trainings, and investigate allegations of discrimination. Our work in the City has confirmed that the Buffalo/Niagara metropolitan statistical area is the 6th most segregated region in the United States and this is the result of systemic discrimination. Affirmatively furthering fair housing, enforcement of fair housing laws and providing education on rights and responsibilities is necessary to reverse the decades old prejudices that have led to high numbers of housing instability in BIPOC and disabled populations. We support the City of Niagara Falls' proposal to create more affordable housing opportunities, especially for large families with very low incomes and persons with disabilities. We support tenant based rental assistance and other means of fostering housing stability; and we advocate for fair housing education and outreach so housing providers and home seekers will know their rights and responsibilities and act accordingly.

Describe the size and demographic composition of qualifying populations within the PJ's boundaries:

## Homeless as defined in 24 CFR 91.5

The most recent one-day homeless count that we have data for was conducted in January 2022. That information is included in the table above. The City used PIT, HIC, CHAS, ACS, and local data to determine where the needs in the community were, and also used interviews and the consulting meeting to gather input.

Based on the PIT and HIC data for Niagara County there are 29 households with children and 97 total people in emergency or transitional housing. Of the 97 people, 67 were children. There were 147 Adult Only households in emergency or transitional housing. There are 7 people Unsheltered. There are 7 households, with children only, living in emergency or transitional housing. 8 persons are chronically homeless.

Demographics from the data provided by the CoC identifies on the night of the PIT count 141 individuals were living in emergency or transitional housing in the City of Niagara Falls. Of the 141 individuals, 47 were female, 88 were male, and 6 did not provide data. 66 were White, 50 were Black/African Americans, 1 was Pacific Islander, 1 was American Indian, 1 was Asian American, 18 were multiple races, and 4 did not provide data are living in emergency or transitional housing. Of the 141 individuals, 33 are under the age of 18. There are 120 Non-Hispanics, 9 Hispanics and 12 did not provide data living in emergency or transitional housing. The CoC identifies 1 Male veteran living in an emergency shelter.

Based on the PIT, 56 survivors of domestic violence were in emergency or transitional housing. Of the 56 survivors sheltered, 32 were adults and 18 were under the age of 18, 31 were female and 16 were males. Of the 56 sheltered 24 were White, 19 were African American, 1 was American Indian, and 12 were multiple races. 6 victims were unsheltered which were all females over the age of 24. Of the 6 unsheltered 3 were White, 2 were Black/African American, and 1 was Asian American.

## At Risk of Homelessness as defined in 24 CFR 91.5

The CHAS and ACS data showed the City of Niagara Falls as having 4,265 renter households with incomes at or below 30% AMI. Renters with Extremely Low Income represent 44% of all renter households.

Prevention data provided by the CoC tells us that in the City of Niagara Falls, on the night of the PIT count, 26 individuals were receiving prevention assistance. Of the 26 individuals, 17 were female, 7 were male, and 2 did not provide data. 7 were White, 14 were Black/African Americans, 1 was American Indian, and 4 did not provide data. Of the 26 individuals, 13 were under the age of 18. There were 21 Non-Hispanics, 1 was Hispanic, and 4 did not provide data

# Fleeing, or Attempting to Flee, Domestic Violence, Dating Violence, Sexual Assault, Stalking, or Human Trafficking, as defined by HUD in the Notice

Based on the 2022 PIT data, there were 56 survivors of domestic violence in emergency or transitional housing. Of the 56 survivors sheltered, 32 were adults and 18 were under the age of 18, 31 were female and 16 were males. Of the 56 sheltered, 24 were White, 19 were African American, 1 was American Indian, and 12 were multiple races. 6 victims were unsheltered which are all females over the age of 24. Of the 6 unsheltered, 3 were White, 2 were Black/African American, and 1 was Asian American.

# Other populations requiring services or housing assistance to prevent homelessness and other populations at greatest risk of housing instability, as defined by HUD in the Notice

The current housing situation in the City of Niagara Falls is dire for extremely-low income renters due to the ongoing housing and employment issues related to the COVID-19 pandemic. While several state, federal, and local resources have been allocated to help address the effects of the COVID-19 pandemic, these funds will be available for a limited period of time and it is unclear what the situation will look like once the funding expires.

According to the 2015-2019 CHAS data, there are 9,570 housing units occupied by households earning less than fifty percent of the area median income (AMI) with at least one of four severe housing problems. It is expected that the true number is higher based on the

increased demand for affordable housing in the last couple of years. The lack of affordable housing is becoming an unmet need throughout the City. This includes shortages of emergency shelter and transitional housing beds, long term affordable housing, and housing for seniors and persons living with disabilities.

Identify and consider the current resources available to assist qualifying populations, including congregate and non-congregate shelter units, supportive services, TBRA, and affordable and permanent supportive rental housing (Optional):

The majority of the services enjoyed recently by the community were enhanced or funded by programs and funding sources related to COVID. CARES Act funding, including ESG-CV and CDBG-CV, Emergency Rental Assistance Program (ERAP) dollars were largely spent or will be fully spent in the near term, and the Rental Supplement Program through the Department of Social Services.

Current resources include annual HUD funding for the City, County, and CoC, State/federal funding for affordable and supportive housing, local foundation and private donor support, as well as ongoing support such as Housing Choice Vouchers.

## Describe the unmet housing and service needs of qualifying populations:

## Homeless as defined in 24 CFR 91.5

The City currently has homeless shelters that operate year-round and the homeless community heavily relies on city shelters and the Niagara County Department of Social Services to provide temporary housing and financial assistance.

As of the last PIT count, there were 251 persons within the emergency shelter system. Of these, 29 households were families with children, and 146 were households without children. There were 7 unsheltered persons found during the PIT count in 2022. The need for beds within the shelter system can fluctuate based on season and type of unit needed, but much data shows that a non-congregate shelter of some type is needed within the community. These non-congregate type shelters were established during COVID and were often used for those at the highest risk of transmission or for those that had tested positive. However, the user can be much greater than that and would add to the continuum of services offered in the community.

Additionally, the lack of transportation greatly impacts access to service needs, especially for homeless and low-income based households as there is a shelter capacity issue in the city and an issue for community members access Code Blue shelters to make up for the gap in congregate shelter space.

#### At Risk of Homelessness as defined in 24 CFR 91.5

The data show that there is a shortage of rental housing units affordable to extremely low income (ELI) households. This forces many ELI households to rent more expensive units and pay more than 30% of their income towards housing (cost burdened) or 50% of their income towards housing (severe cost burden). Many of these households also experience other housing issues but have limited options available to remedy those issues. The greatest needs, as indicated by both the consultation meetings and the surveys, were: 1) development of affordable rental housing, 2) supportive services, 3), acquisition and development of noncongregate shelter 4), tenant based rental assistance, and 5) non-profit operating funding and capacity building.

While the lack of housing options was identified by many groups, the majority of participants in the consultation meetings highlighted support services and capacity building as some of the highest needs. Specifically, services such as housing search and placement, documentation gathering and assistance, and case management are in demand.

# Fleeing, or Attempting to Flee, Domestic Violence, Dating Violence, Sexual Assault, Stalking, or Human Trafficking, as defined by HUD in the Notice

Victims of Domestic Violence pose an increased risk throughout the community. Through the consultations it was identidifed that there is a lack of access to affordable housing which can increase the chance of staying in an abusive and dangerous situation. Increasing the number of options for affordable housing and access to services would be a priority for this population.

# Other populations requiring services or housing assistance to prevent homelessness and other populations at greatest risk of housing instability as defined by HUD in the Notice

The CHAS and ACS data showed the City of Niagara Falls as having 4,265 renter households with incomes at or below 30% AMI. Renters with Extremely Low Income represent 44% of all renter households.

# Identify any gaps within the current shelter and housing inventory as well as the service delivery system:

Although there is an adequate amount of shelter beds for homeless individuals requesting assistance, there is a gap within the system related to homeless individuals who are employed on overnight shifts and in need of a place to sleep during daytime hours.

A current issue relating to housing inventories is the recent population growth in the area which has resulted in a decrease in available housing stock, especially affordable housing. Many available apartments are well above HUD's established FMR for our area, and thus unattainable for our CoC

Permanent Supportive Housing and Rapid Re-Housing programs. Programs have been negotiated with area landlords and although they have been somewhat successful, especially in maintaining existing leases, etc., quickly finding housing for homeless individuals and families has been difficult.

Emergency financial assistance for homelessness prevention is offered to households that request it for housing stability, but the influx of funding from the Treasury (ERAP, EPPI) and HUD (ESG-CV) is largely spent. The need for this type of assistance remains high, but funding is limited.

Access to services can be confusing, and gathering materials needed to be approved for services can also be overwhelming. Case management and other supports are often used to help people make their way through the services/housing application processes, and many partners called this out as a difficulty their clients face. These services were the higher priority in our survey and among our consultees. It was noted at our February 16<sup>th</sup>, 2023 consultation, that there is a great need for more supportive services to aid our service delivery systems and more must be done. Lastly, there is a gap in non-congregated shelters, and in the provision of quality, affordable housing for the qualifying populations. During the pandemic, it was identified that there is a lack of non-congregate shelters and low-barrier shelters. The need to have private space for individuals from the homeless population was difficult, and in many cases, hotel rooms were secured. These were temporary solutions, but the need was demonstrated.

Under Section IV.4.2.ii.G of the HOME-ARP Notice, a PJ may provide additional characteristics associated with instability and increased risk of homelessness in their HOME-ARP allocation plan. These characteristics will further refine the definition of "other populations" that are "At Greatest Risk of Housing Instability," as established in the HOME-ARP Notice. According to most measures, affordable housing means only spending 30% or less of a household's income on housing related expenses. Rent burden is defined as spending more than 30% of a household's income on housing expenses. When the share exceeds that threshold, it impacts a household's ability to buy food and support other essentials like healthcare and transportation. A higher rent burden is often associated with a greater risk of eviction, or risk of homelessness. Housing cost burden can therefore be viewed as a strong contributor to homelessness. While the City of Niagara Falls housing costs are not extraordinarily high, extremely low incomes have led to a high number of households facing a rent burden.

Since the end of the various moratoria, rents have increased, and/or landlords and management companies have become more restrictive with whom they are willing to rent. As previously mentioned, many households spend more than 30% of their income on housing costs, and this is seen with greater frequency as incomes decrease. However, finding new housing is harder than ever. Many households/individuals are unable to secure new housing because they do not have perfect credit profiles, and their incomes are not 3-4 times greater than the rent. Housing cost burden can therefore be viewed as a strong contributor to homelessness.

"Other Populations" included with eligible qualifying populations will include households earning no greater than 50% AMI and exhibiting characteristics associated with instability and an increased risk of homelessness, such as a previous history of homelessness, imminent risk of eviction,

- Has moved because of economic reasons two or more times during the 60 days immediately preceding the application for homelessness prevention assistance;
- Is living in the home of another because of economic hardship;
- Has been notified in writing that their right to occupy their current housing or living situation will be terminated within 21 days after the date of application for assistance;
- Lives in a hotel or motel and the cost of the hotel or motel stay is not paid by charitable organizations or by federal, State, or local government programs for low-income individuals;
- Lives in a single-room occupancy or efficiency apartment unit in which there reside more than two persons or lives in a larger housing unit in which there reside more than 1.5 people per room, as defined by the U.S. Census Bureau;
- Is exiting a publicly funded institution, or system of care (such as a health-care facility, a mental health facility, foster care or another youth facility, or a correction program or institution)

# Identify priority needs for qualifying populations:

Priority needs include appropriate, affordable housing units that are readily available to those that need them, and that have support services included for anyone that needs them. This was identified as the number one priority amongst survey respondents and through the consultation process, and it confirms data was reviewed concerning the HIC and population of persons at risk of homelessness due to severe housing cost burden.

The support services, such as ongoing case management, and housing search/counseling (may vary by population), were identified as crucial for successful long-term housing of the qualifying populations. A discontinuity of services exists in our community. Although there are many services available locally, accessing the services is not always straightforward. Services that help individuals leaving institutions and help individuals secure important documents are needed and wrap around services, provided to anyone living in the affordable housing to be developed, are crucial to long-term housing stability of the qualifying populations. Access to services can be confusing, and gathering materials needed to be approved for services can also be overwhelming. Case management and other supports are often used to help people make their way through the services/housing application processes, and many partners called this out as a difficulty their clients face.

Additionally, the provision of a non-congregate shelter within the community was identified as a high priority need. These types of shelters were created during the pandemic, but they have long

been identified as a need within our community. The current shelter system offers many useful and successful interventions and services and provides an emergency lifeline to many who need it. But the current model does not work for everyone, and the innovative approaches deployed during the COVID pandemic showed that alternative options can be successful with the right support. During the pandemic, several hotels were temporarily turned into NCS. These shelters provided both housing and structure to those with the highest risk of COVID transmission. Some of the individuals living in the hotels were moved there as part of a shelter "decompression", while other chronically homeless individuals were moved there from homeless encampments and other locations not meant for human habitation. The hotel NCS model showed that many persons previously unwilling/unable to access the traditional shelter system were willing to try a new model. The temporary NCS model used during COVID showed it could be successful, but that it was not a right fit for everyone, and that it was crucial to have the right support staff and services in place.

Lastly, the lack of transportation greatly impacts access to service needs, especially for homeless and low-income based households. Access to services can be confusing, and gathering materials needed to be approved for services can also be overwhelming. Case management and other supports are often used to help people make their way through the services/housing application processes, and many partners called this out as a difficulty their clients face.

# Explain how the PJ determined the level of need and gaps in the PJ's shelter and housing inventory and service delivery systems based on the data presented in the plan:

The City obtained data from the PIT, HIC, CHAS, ACS, and local data to determine where the needs in the community were, and also used interviews and the consulting meeting to gather input. The data came from information obtained in the annual Point In Time Count and the Housing Inventory Counts conducted in 2022.

Income and housing statistics were taken from various sources, including 2015-2019 ACS and decennial Census Data (2020) from the US Bureau of the Census. Some housing and household data was taken from the 2015-2019 Community Housing Affordability Strategy (CHAS) data.

## **HOME-ARP** Activities

Describe the method(s) that will be used for soliciting applications for funding and/or selecting developers, service providers, subrecipients and/or contractors:

The City of Niagara Falls will pursue applications for funding from the agencies through a Request for Proposal process for HOME-ARP eligible activities to benefit the qualified populations within the City of Niagara Falls that follow Federal and local procurement policies. The City anticipates a 60 day period for proposals to be submitted and reviewed. Proposals will be competitively scored and reviewed by a committee made up of Community Development staff.

The City will also leverage HOME-ARP funds to create suitable rental housing units to serve the City's HOME-ARP qualifying populations

## Describe whether the PJ will administer eligible activities directly:

At this time, the City does not intend to administer eligible activities directly. The City will provide HOME-ARP funds to sub-recipients and non-profit developers to administer eligible activities directly.

Describe how the PJ will distribute HOME-ARP funds in accordance with its priority needs identified in its needs assessment and gap analysis:

The rationale for allocating funding this way is due to the data, consultation meetings, and community needs. After much discussion with each consultation group, the City determined that the above distribution is currently the best fit for the needs of the community. The majority of resources will be dedicated to the Development of Affordable Housing and the creation of Non Congregate shelters, but funding will be available for the other eligible activities. If additional resources become available, or if new research or information proves otherwise, the distribution may be amended in response to that.

Describe how the characteristics of the shelter and housing inventory, service delivery system, and the needs identified in the gap analysis provided a rationale for the plan to fund eligible activities:

A review of the gap analysis for shelter, affordable and supportive housing, as well as feedback and experiences from those working to end homelessness within the City, provide the rationale for funding the acquisition and development of non-congregate shelters and additional affordable rental housing units, as well as supportive services to help end homelessness and those who experience possible homelessness.

There are significant needs in the City of Niagara Falls for HOME-ARP eligible activities. The need for capital improvements or acquisition/development of non-congregate shelters, specifically for homeless men was identified by nearly every respondent.

While safe, decent, and affordable supportive housing can help reduce long-term shelter stays, unsheltered homelessness it also provides a safe space for community members to recover from substance abuse, mental illness, and other disabling conditions. Niagara Falls is aware that existing shelter and housing programs are not adequately funded in operations or services to meet the needs of the population they were created to serve.

The City estimates that it will produce or support 4 affordable rental and permanent supportive housing units for qualifying populations.

The City hopes to fund the support affordable rental housing eith the goal in mind of assisting future housing projects. This will address he need of low-income hosing within the community and with hopes the community can create and sustain more affordable housing projects. The City plans to work with local organizations to identify potential projects and provide affordable housing to qualifying populations within the community.

## **Preferences**

A preference provides a priority for the selection of applicants who fall into a specific QP or category (e.g., elderly or persons with disabilities) within a QP (i.e., subpopulation) to receive assistance. A preference permits an eligible applicant that qualifies for a PJ-adopted preference to be selected for HOME-ARP assistance before another eligible applicant that does not qualify for a preference. "Prioritization. In the context of the coordinated entry process, HUD uses the term "Prioritization" to refer to the coordinated entry-specific process by which all persons in need of assistance who use coordinated entry are ranked in order of priority. The coordinated entry prioritization policies are established by the CoC with input from all community stakeholders and must ensure that ESG projects are able to serve clients in accordance with written standards that are established under 24 CFR 576.400(e). In addition, the coordinated entry process must, to the maximum extent feasible, ensure that people with more severe service needs and levels of

vulnerability are prioritized for housing and homeless assistance before those with less severe service needs and lower levels of vulnerability. Regardless of how prioritization decisions are implemented, the prioritization process must follow the requirements in Section II.B.3. and Section I.D. of this Notice."

#### Referral Methods

#### **HOME ARP Funding**

- Acquisition, rehabilitation, adaptive reuse, or construction of affordable rental housing, including permanent supportive housing for qualifying populations;

Hi Paul

I'm sorry I wasn't able to attend the 2/16 public hearing but appreciate the City's outreach to solicit input on the ARP funding.

Last year, HLS received more than \$100,000 from EFSP to provide rental assistance to struggling households. This funding was in addition to rental assistance support we helped the community access through ERAP. Both ERAP and EFSP money went quickly, an indication of the extent people in our community are struggling to keep up with housing costs. Given the need, it seems reasonable to allocate a % of the ARP money for rental assistance. I would suggest at least 10% (\$160K), which is much less than what is needed but still provides some resources in the absence of funding that is no longer available.

I would also suggest allocating another 10% to funding a "community services navigator" (i.e. case manager) to assist with service coordination for housing-insecure populations that fall outside of services funded for specific populations. One challenge we are finding at Daybreak is that our case manager positions are funded by sources that support specific populations (i.e. homeless services supported by ESG and CoC funding; elderly/disabled population supported by HUD's ROSS program). HLS does not have any sustainable revenue source for providing crisis intervention / case management / service coordination support to people who fall outside of the before-mentioned populations. The community needs such resources (whether stationed at Daybreak or not); a \$160,000 allocation would provide about 3 years of funding for such a position.

Given the lack of affordable housing options, PSH, transitional housing, etc. in Niagara Falls, it seems reasonable to me to allocate the remaining 80% of funding to those needs.

Happy to discuss this further with the Coalition on March 13, but I wanted to at least identify these 2 needs.

Dear Cliff,

I am submitting a public comment on the City's allocation of HOME-ARP funding on behalf of the Homeless Alliance of Western New York (HAWNY). We would like to see a smaller portion of HOME-ARP used towards Supportive Services and a larger portion of it used towards developing affordable housing.

Annually, there are 1050 people experiencing homelessness within the City of Niagara Falls. Through Coordinated Entry efforts, we know that conservatively, there were 37 people in 2022 with higher needs that require permanent housing with supportive services. Currently, there are very few programs that could serve this population and so, we would like to advocate for this funding to prioritize assisting Niagara Falls residents who experience homelessness the longest and have the most serious needs by providing affordable housing and supportive services to them. By prioritizing this population, it addresses the needs of all eligible populations, such as Veterans, individuals and families fleeing domestic violence, the LGBTQ community, and marginalized communities.

This could be achieved by building new/rehabbing units or through Tenant Based Rental Assistance (TBRA). No matter which models are being adopted, supportive services will be needed to address the needs of these most vulnerable community members and ensure they are stabilized in housing. A contingent plan should be created by selected non-profit partners to seek state/local funding to continue supportive services after HOME-ARP ends.

With the City of Niagara Falls allocating funding toward the development of affordable housing and providing supportive services, in the form of ongoing case management to the most vulnerable in the community, individuals and families will remain stably housed and reduce their use of community resources which will reduce overall cost over time.

Supportive Services could also be used to replace the current gaps of Rapid Rehousing needs. Since 2020, there has been additional funding--ESG CV, available to support Rapid Rehousing. This funding will end this September and most Rapid Rehousing agencies have already exhausted their funding. Ongoing funding is needed to provide short to medium term rental assistance along with case management.

Supportive Services under the HOME-ARP promote local participating jurisdictions (PJs) to develop innovative programs to address their community needs. This funding can be used to create an affordable housing centralized database. Allow community partners to hire staff who could assist in housing search, improve housing retention with a Landlord-Tenant Liaison, provide financial assistance toward rent/utilities/move-in costs, and offer a landlord incentive to incentivize and reduce risk.

(HOME) is a civil rights organization founded in 1963 whose mission is to promote the value of diversity and to ensure all people an equal opportunity to live in the housing and communities of their choice—through education, advocacy, enforcement of fair housing laws, and the creation of housing opportunities.

We hold contract with several local municipalities, Erie County, New York State, and the Department of Housing and Urban Development in an effort to enforce fair housing in Western New York. Although HOME does not possess a contract of this sort with the City of Niagara Falls, we regularly advise it's residents of their rights and responsibilities under fair housing laws, mediate landlord and tenant issues, provide technical assistance when requested, assist families in finding safe and affordable housing, hold fair housing presentations and trainings, and investigate allegations of discrimination. Our work in the City has confirmed that the Buffalo/Niagara metropolitian statistical area is the 6<sup>th</sup> most segregated region in the United States and this is the result of systemic discrimination. Affirmatively furthering fair housing, enforcement of fair housing laws and providing education on rights and responsibilities is necessary to reverse the decades old prejudices that have led to high numbers of housing instability in BIPOC and disabled populations. We support the City of Niagara Falls' proposal to create more affordable housing opportunities, especially for large families with very low incomes and persons with disabilities. We have always been unable to meet the need but with the housing market as it is now the low stock of quality of affordable housing needs to be at the forefront of where we put our resources.
- Tenant-based rental assistance (TBRA) to help qualifying populations pay rent, security deposits, and utility deposits and payments; Programs like TBRA could allow families/individuals to stay in place-assuming the units pass HQS inspection, and the landlord works with us- a more expedient way to secure housing

Affordable Housing entities have always had to balance the ability to build and maintain affordable housing with an operation budget that does not necessarily support the operation

Administration and planning to hire, train, and support new staff to select, manage, monitor, and evaluate HOME-ARP projects and activities. As mentioned above staffing for all has been a challenge. Companies have had to take steps back as new employees have come on and need to train them to get up to speed while still trying to main the work needed to be done. But proper recruitment and training are essential for the long-term success of these programs.

I apologize for my delayed response but thank you so much for reaching out.

Niagara County agrees with the following priorities that you have identified:

- · Acquisition, rehabilitation, adaptive reuse, or construction of affordable rental housing, including permanent supportive housing for qualifying populations;
- Tenant-based rental assistance (TBRA) to help qualifying populations pay rent, security deposits, and utility deposits and payments;
- A broad range of supportive services to prevent homelessness and foster housing stability such as emergency assistance, job training, childcare, and educational services;
- Acquisition and development of non-congregate shelter to create private temporary units/rooms for households experiencing homelessness or fleeing abusive situations;

We continue to see the need for more shelter space as Community Missions is frequently at capacity. The lack of affordable housing in the City is a barrier for those who are ready to move out of shelter.

Our Rental Supplement Plan in Niagara County opened on 10/17/22 and was for individuals or families that were either homeless or facing imminent loss of housing. To date we "received approximately 450 applications and of those 450 applications, 90 applications were approved and receiving a monthly ongoing supplement. As of 3/1/23, the funding for the program has been exhausted so no new households are being approved for this rental supplement. I will share as well that on 1/25/23 for the PIT, we had 85 homeless individuals placed in motels by DSS.
