Organizations consulted:

Summarize feedback received and results of upfront consultation with these entities: Meetings with homeless service providers and Westland Housing Commission resulted in positive discussion regarding City of Westland proposed use of HOME ARP funds, expanding Rental Rehabilitation Program. Westland Housing Commission will implement recommendation to add homeless preference for project based programs (Westgate Towers and Norwayne Veterans.)

Public Participation

Describe the size and demographic composition of qualifying populations within the PJ's boundaries:

Homeless as defined in 24 CFR 91.5

The most recent homeless census, or annual point in time (PIT) survey, was conducted on January 29, 2022. The total number of sheltered homeless people counted in the Continuum of Care during the survey was 260. Of the 239 sheltered homeless persons counted, 165 were persons in households with adults and children and 74 were persons in households with only adults. No households had only children (less than 18 years of age). There were three chronically homeless families with children and 31 total chronically homeless individuals reported.

At Risk of Homelessness as defined in 24 CFR 91.5

The Black/African American group experiences a disproportionately greater need in terms of the following: housing problems in the 30-50% AMI category (83% versus 71% as a whole) and severe housing problems in the 0-30% AMI category (82% versus 69% as a whole).

The City of Westland has developed an extensive network of housing and service partners which have enabled it to stretch the reach and effectiveness of its housing and community development programs

The City has prioritized affordable housing as a basic human necessity, along with neighborhood revitalization and supportive services. These priorities, when implemented together, provide a synergistic strategy for community development.

Explain how the PJ determined the level of need and gaps in the PJ's shelter and housing inventory and service delivery systems based on the data presented in the plan:

The City determined the level of need by analyzing the data in the Consolidated Plan and input for partner organization.

HOME-ARP Activities

Describe the method(s) that will be used for soliciting applications for funding and/or selecting developers, service providers, subrecipients and/or contractors: Rental Rehabilitation Program:

Rental Rehabilitation Program:

- 1. Applications from Rental Owners Westland will solicit applications from Westland rental owners to determine interest in the Rental Rehabilitation Program. Westland will give priority to properties in the Norwayne and Carver subdivisions. Rental owners must be current in mortgage payments, property insurance, property taxes and water bills.
- 2. Applications from Developers Westland does not intend to solicit applications from developers.
- 3. Applications from Service Providers Westland will solicit applications from service providers to provide home care classes for tenants. Westland will rank applications based

on fee, experience and recommendations. Westland will advertise solicitation via MiTN and minority/women owned businesses publications.

4. Applications from Contractors – Westland will prepare rehabilitation specifications and request for proposals from contractors. Based on approved rental owner applications, Westland will bundle several rehabilitation projects into one bid package. Westland will rank applications based on fee, experience, recommendations. Westland will advertise solicitation via MiTN and minority/women owned businesses publications.

Describe whether the PJ will administer eligible activities directly: Westland will administer the HOME ARP allocation directly.

Describe how the PJ will distribute HOME-ARP funds in accordance with its priority needs identified in its needs assessment and gap analysis:

Westland will distribute HOME ARP funds to rental owners under the Rental Rehabilitation Program. Westland will require rental owners to rent affordable units to qualified populations, with referral from the Continuum of Care agencies. The Westland Housing Commission will provide housing vouchers to ensure affordability.

Describe how the characteristics of the shelter and housing inventory, service delivery system, and the needs identified in the gap analysis provided a rationale for the plan to fund eligible activities:

The gap analysis identifies the need for affordable rental housing for the qualified populations. The Rental Rehabilitation Program, coupled with housing vouchers from the Westland Housing Commission, will increase the supply of affordable rental housing in Westland.

HOME-ARP Production Housing Goals

Estimate the number of affordable rental housing units for qualifying populations that the PJ will produce or support with its HOME-ARP allocation:

Westland estimates that it will produce 30 affordable rental units for qualifying populations.

Describe the specific affordable rental housing production goal that the PJ hopes to achieve and describe how the production goal will address the PJ's priority needs:

Westland's priority goal is to increase the amount of affordable rental housing, primarily in the Norwayne and Carver subdivisions. The HOME-ARP production goal is to renovate 30 affordable rental units, based on the production provided with the HOME-ARP funding. The production goal will address Westland's priority need by producing additional affordable rental housing in these areas, providing investment in Westland's most economically challenged areas and encouraging investment by other property owners.

Preferences

A preference provides a priority for the selection of applicants who fall into a specific QP or category (e.g., elderly or persons with disabilities) within a QP (i.e., subpopulation) to receive assistance. A *preference* permits an eligible applicant that qualifies for a PJ-adopted preference to be selected for HOME-ARP assistance before another eligible applicant that does not qualify for a preference. A *method of prioritization* is the process by which a PJ determines how two or more eligible applicants qualifying for the same or different preferences are selected for HOME-ARP assistance. For example, in a project with a preference for chronically homeless, all eligible QP applicants are selected in chronological order for a HOME-ARP rental project except that eligible QP applicants that qualify for the preference of chronically homeless are selected for occupancy based on length of time they have been homeless before eligible QP applicants who do not qualify for the preference of chronically homeless.

Please note that HUD has also described a method of prioritization in other HUD guidance. Section I.C.4 of Notice CPD-17-01 describes Prioritization in CoC CE as follows:

"Prioritization. In the context of the coordinated entry process, HUD uses the term "Prioritization" to refer to the coordinated entry-specific process by which all persons in need of assistance who use coordinated entry are ranked in order of priority. The coordinated entry prioritization policies are established by the CoC with input from all community stakeholders and must ensure that ESG projects are able to serve clients in accordance with written standards that are established under 24 CFR 576.400(e). In addition, the coordinated entry process must, to the maximum extent feasible, ensure that people with more severe service needs and levels of vulnerability are prioritized for housing and homeless assistance before those with less severe service needs and lower levels of vulnerability. Regardless of how prioritization decisions are implemented, the prioritization process must follow the requirements in Section II.B.3. and Section I.D. of this Notice."

If a PJ is using a CE that has a method of prioritization described in CPD-17-01, then a PJ has preferences and a method of prioritizing those preferences. These must be described in the HOME-ARP allocation plan in order to comply with the requirements of Section IV.C.2 (page 10) of the HOME-ARP Notice.

In accordance with Section V.C.4 of the Notice (page 15), the HOME-ARP allocation plan must identify whether the PJ intends to give a preference to one or more qualifying populations or a subpopulation within one or more qualifying populations for any eligible activity or project.

- Preferences cannot violate any applicable fair housing, civil rights, and nondiscrimination requirements, including but not limited to those requirements listed in 24 CFR 5.105(a).
- The PJ must comply with all applicable nondiscrimination and equal opportunity laws and requirements listed in 24 CFR 5.105(a) and any other applicable fair housing and civil rights laws and requirements when establishing preferences or methods of prioritization.

While PJs are not required to describe specific projects in its HOME-ARP allocation plan to which the preferences will apply, the PJ must describe the planned use of any preferences in its HOME-ARP allocation plan. This requirement also applies if the PJ intends to commit HOME-ARP funds to projects that will utilize preferences or limitations to comply with restrictive eligibility requirements of another project funding source. If a PJ fails to describe preferences or limitations in its plan, it cannot commit HOME-ARP funds to a project that will implement a preference or limitation until the PJ amends its HOME-ARP allocation plan. For HOME-ARP rental housing projects, Section VI.B.20.a.iii of the HOME-ARP Notice (page 36) states that owners may only limit eligibility or give a preference to a particular qualifying population or segment of the qualifying population <u>if the limitation or preference is described in the PJ's HOME-ARP allocation plan</u>. Adding a preference or limitation not previously described in the plan requires a substantial amendment and a public comment period in accordance with Section V.C.6 of the Notice (page 16).

Identify whether the PJ intends to give preference to one or more qualifying populations or a subpopulation within one or more qualifying populations for any eligible activity or project: Westland does not intend to give preference to a subpopulation of the qualifying populations.

If a preference was identified, explain how the use of a preference or method of prioritization will address the unmet need or gap in benefits and services received by individuals and families in the qualifying population or subpopulation of qualifying population, consistent with the PJ's needs assessment and gap analysis: Not applicable.

Referral Methods

PJs are not required to describe referral methods in the plan. However, if a PJ intends to use a coordinated entry (CE) process for referrals to a HOME-ARP project or activity, the PJ must ensure compliance with Section IV.C.2 of the Notice (page10).

A PJ may use only the CE for direct referrals to HOME-ARP projects and activities (as opposed to CE and other referral agencies or a waitlist) if the CE expands to accept all HOME-ARP qualifying populations and implements the preferences and prioritization <u>established by the PJ in its HOME-ARP allocation plan</u>. A direct referral is where the CE provides the eligible applicant directly to the PJ, subrecipient, or owner to receive HOME-ARP TBRA, supportive services, admittance to a HOME-ARP rental unit, or occupancy of a NCS unit. In comparison, an indirect referral is where a CE (or other referral source) refers an eligible applicant for placement to a project or activity waitlist. Eligible applicants are then selected for a HOME-ARP project or activity from the waitlist.

The PJ must require a project or activity to use CE along with other referral methods (as provided in Section IV.C.2.ii) or to use only a project/activity waiting list (as provided in Section IV.C.2.iii) if:

- 1. the CE does not have a sufficient number of qualifying individuals and families to refer to the PJ for the project or activity;
- 2. the CE does not include all HOME-ARP qualifying populations; or,
- 3. the CE fails to provide access and implement uniform referral processes in situations where a project's geographic area(s) is broader than the geographic area(s) covered by the CE

If a PJ uses a CE that prioritizes one or more qualifying populations or segments of qualifying populations (e.g., prioritizing assistance or units for chronically homeless individuals first, then prioritizing homeless youth second, followed by any other individuals qualifying as homeless, etc.) then this constitutes the use of preferences and a method of prioritization. To implement a CE with these preferences and priorities, the PJ **must** include the preferences and method of prioritization that the CE will use in the preferences section of their HOME-ARP allocation plan. Use of a CE with embedded preferences or methods of prioritization that are not contained in the PJ's HOME-ARP allocation does not comply with Section IV.C.2 of the Notice (page10).

(Optional): Westland will accept referrals from Wayne County Continuum of Care participating agencies, on a first come, first served basis, as the application process for the qualifying populations. Westland will not use a coordinated entry process.

- Within the qualifying populations, participation in a project or activity may be limited to persons with a specific disability only, if necessary, to provide effective housing, aid, benefit, or services that would be as effective as those provided to others in accordance with 24 CFR 8.4(b)(1)(iv). A PJ must describe why such a limitation for a project or activity is necessary in its HOME-ARP allocation plan (based on the needs and gap identified by the PJ in its plan) to meet some greater need and to provide a specific benefit that cannot be provided through the provision of a preference.
- For HOME-ARP rental housing, section VI.B.20.a.iii of the Notice (page 36) states that owners may only limit eligibility to a particular qualifying population or segment of the qualifying population <u>if the limitation is described in the PJ's HOME-ARP allocation plan</u>.
- PJs may limit admission to HOME-ARP rental housing or NCS to households who need the specialized supportive services that are provided in such housing or NCS. However, no otherwise eligible individuals with disabilities or families including an individual with a disability who may benefit from the services provided may be excluded on the grounds that they do not have a particular disability.

In addition, in the case of properties owned and occupied by moderate-income (not low-income) families, an assessment or charge may be made against the property for public improvements financed by a source other than CDBG funds if the jurisdiction certifies that it lacks CDBG funds to cover the assessment.
