Technical Requirements

To fully participate in this training, you will need the latest version of Adobe Flash Player. To ensure you have the latest version, please visit [Adobe Flash Player webpage](#).

Overview of the HOPWA Financial Management Online Training

The training consists of nine modules (8 content modules and 1 introduction module).

To Access the Training

1. Select **Go to Training**, on the right-hand side of your screen
Note: This will take you to OneCPD Learn
2. If prompted, enter your existing OneCPD username and password
*Note: To create an OneCPD account, select **Create an Account***
3. Select **HOPWA Financial Management Training Course**, on the right-hand side of your screen
4. Select any of the nine modules, to begin your training

Training Status

The current status of each module is listed below the module name. The explanation of each status is below:

Status	Definition
Not Attempted	Learner has not yet launched the module
In Progress	Learner has launched the module and is in the process of completing the module but has not yet passed the module exam with a proficiency of 80% or better
