Why Was the RGC Created?



Public Law 105-276 (October 21, 1998) directs HUD to create an RGC to:


- Facilitate informational services, technical assistance, training, and investment capital.
- Benefit local rural, state, and regional organizations.
- Support efforts to rebuild and preserve healthy, productive communities.
- Act as a screen/filter for private sector organizations to establish economic development-based initiatives.



Originally Established by Congress in 1998



The RGC's core statutory focus is America's underserved and rural areas.



- Lower Mississippi Delta River Region
- Appalachia's Distressed Counties
- Colonias
- Federally recognized Indian tribes
- Seasonal farmworkers
- "Other" rural populations (essentially any "underserved" area)

What Is HUD's Rural Gateway Clearinghouse (RGC)?



- A peer-to-peer network for local development agencies. Information sharing among regional, state, and local economic development agencies. Group discussions, conferences, panels.
- A "U.S. government-wide" information source. A repository of information from federal economic development agencies.
- A source of technical assistance for rural agencies. Direct technical assistance, including via a 1-800 telephone number.







What Are the Objectives of the RGC?



- 1. Build capacity of organizations working on housing, economic, and infrastructure development.
- 2. Serve as a promoter and screen/filter of private sector-based partnerships to support housing, economic development, infrastructure, and capacity-building activities.
- 3. Improve and streamline access of these organizations to different sources of government, nonprofit, and for-profit sources of investment capital, technical assistance, and training and information.

What Are the Guiding Tenets of the RGC?



- 1. Serve as a facilitator (not a direct provider) of information, technical assistance, and funding as provided by federal, state, and local government agencies, nonprofits, and forprofit entities.
- 2. Ensure that the technical assistance and information provided is based on best practices.
- 3. Be proactive in pursuing partnerships with the private sector and building capacity of intermediaries.

What Types of "Economic Development" Are Targeted?



The RGC collects resources that support:

- Public infrastructure
- Project finance
- Community facilities
- Capacity building



What Are Considered "Rural"?



Definition of *Rural:* Different government agencies have different definitions of "rural." Some are optimized for academic studies, while others are optimized for policy-based funding allocations, and still others for agency management purposes. The Office of Rural Housing and Economic Development (ORHED) will place a page on RGW with links to different definitions and descriptions of their use. The agency will not select one definition but will support tools to access the different maps and datasets.




Technical Assistance and 1-877-RURAL-26

Peer-to-Peer Forums



Through the RGC, HUD sponsors public online meetings to rural economic development agencies. These calls support networking and information sharing among rural organizations. Participants share experiences, challenges, and solutions. Developing a peer network helps to minimize the sense of isolation often felt by rural organizations.

Technical Assistance and Training



ORHED will perform the following tasks:

- Create clear definitions for "capacity" and "capacity building."
- Identify the training most asked for by regional entities.
- Create and maintain a page for resource links to free online training on these topics specifically.
- Identify the training topics that seem to have the least free online resources—that is, the training topics that ORHED believes are priority unmet needs.
- Sponsor a page of the "best free online training" courses to encourage the development of more and better training that is free and available.
- Create and maintain a working paper on RGW that discusses these issues, inviting peer-to-peer comment, such as with online bulletin boards.



Rural Case Studies



HUD provides case studies on projects initiated by rural serving organizations. Case studies are designed to be capacity-building oriented, scalable, replicable, and require little internal funds. They emphasize linking housing, economic development, business.
