## HUD AWARDS \$990,000 TO FIGHT COVID-19

Grants were awarded to support and promote fair housing nationwide.

As part of the Coronavirus Aid, Relief, and Economic Security (CARES Act) (Public Law 116-136, approved March 27, 2020), The U.S. Department of Housing and Urban Development (HUD) awarded \$990,000 (see grant chart below for full list of recipients) under its *Fair Housing Initiatives Program (FHIP)* Education and Outreach Initiative (EOI) Component in supplemental grant funding for creating and disseminating fair housing education and outreach materials as a result of COVID-19.
