Create an Account on the HUD Exchange

1. Go to the HUD Exchange (www.hudexchange.info).
2. Click **Login** (at the upper right).
3. Click **Create an Account**.
4. Fill out the form, and click the **Create Account** button.
Your account has been created. You will receive a confirmation email.

If you have ***already registered*** for a HUD Exchange account:

1. Select a "Register Now" link in the table above.
2. Enter your Username and Password; select **Log in**.

3. If prompted to fill out additional information, please do so, and select **Update**.
4. You will be brought directly to the course detail page in HUD Exchange.
5. Select the checkbox next to the class name and location and then select **Enroll in this Class**.
