ORDER OF DISMISSAL

On July 13, 2023, the Tribunal received Petitioner's *Hearing Request* wherein Petitioner disputed the existence of the debt claimed by the Secretary of the U.S. Department of Housing and Urban Development ("HUD"). Thereafter, the Tribunal ordered the Secretary and Petitioner to file documentary evidence in support of their respective positions. The Secretary complied with the Tribunal's order and filed a Secretary's Statement and supporting evidence on September 12, 2023. Petitioner did not comply or otherwise respond.

Having not received a timely filing from Petitioner, the Tribunal ordered Petitioner to show cause as to why their appeal should not be dismissed. Again, Petitioner did not comply or respond.

When a party fails to comply with an order of the Tribunal, the Tribunal may impose a sanction that reasonably relates to the severity and nature of the failure. 24 C.F.R. § 26.4. If a party fails to prosecute or defend an action, dismissal of the matter or a decision against that party may also be imposed. Id. at § 26.4(d).

To date, Petitioner has not complied with the Tribunal's orders or otherwise produced evidence in support of their position that they do not owe the alleged debt. Accordingly, this matter is **DISMISSED**, and the stay of proceedings issued on August 31, 2023, is hereby VACATED.
