

Navigating Disaster Recovery: Strategies in Winter and Spring



A Webinar Presented by HUD's Office of Lead Hazard Control and Healthy Homes and the Healthy Homes Partnership March 4, from 2:00 pm -3:30 pm EST

This webinar will focus primarily on the recovery and rebuilding phases following the winter storm disaster in Texas and adjacent states. The purpose is to assist stakeholders (see audiences below) who are, or will be, interfacing with residents, especially low income families. The information to be provided can better inform clean-up activities for several types of housing; improve repair and restoration of damaged homes so that they are done in ways that are healthy for the workers and for the families; and help your community prepare for other natural disaster events that may occur this spring.

Extended power outages and extreme cold have resulted in burst plumbing and major water damage for so many homes that qualified contractors and materials will be in short supply, and restoration costs high. The insurance claim time will likely compel many to rely on do-it-yourself, volunteer and inexperienced (or worse, fraudulent) labor.

Compounding the disaster are high energy bills and the COVID-19 pandemic. These factors complicate the recovery challenge. It is important to educate all involved in the restoration process, while also protecting health and increasing resilience.

We encourage you to share the information and resources to be presented – all aimed at helping families and individuals in the disaster recovery and rebuilding process. Professionals assisting residents will learn from two nationally recognized experts in post-disaster restoration, tailored for this winter storm.
