Welcome to the National Healthy Homes Month Webinar Program. Each June, HUD's Office of Lead Hazard Control and Healthy Homes (OLHCHH) and our partners celebrate National Healthy Homes Month. NHHM was established to focus national attention on ways to keep people of all ages safe and healthy in their homes. An important part of our outreach includes the webinar program, offered in conjunction with USDA's National Institute of Food and Agriculture, National Healthy Homes Partnership (USDA/NIFA). We're glad to have expert presenters and a balanced mix of topics, designed to appeal to a wide range of OLHCHH grantees, and additional stakeholders and partners.

The webinars support National Healthy Home Month's theme of *Growing Up Safe and Healthy - 5 Minutes to a Healthy Home.* This overarching theme promotes awareness of potential indoor environmental health hazards, and simple actions that residents can take in a short time to address many of them. Residents may live in rural or urban settings, may be owners or renters, and can have widely different lifestyles and habits. These self-assessments can be done with little or no equipment and without a housing professional being present. More intensive assessments can be held as follow-ups.

Our May 28 kickoff features many ways stakeholders can use resources to reach new partners in just five minutes. Content will help attendees with National Healthy Home Month's community implementation throughout June and beyond. There will be ample time for Q&As following all our webinars. After National Healthy Homes Month ends, attendees will be able to apply the webinars' material in their own professional settings and communities.

June 4 at 2:00 pm Using Valuable Resources from the Healthy Homes Partnership –Presenter is Michael Goldschmidt, AIA, LEED, BD+C, USDA National Institute of Food and Agriculture Healthy Homes Partnership, and National Program Coordinator of the HHP.

Target Audience-All stakeholders who work with homeowners and residents; those who are unfamiliar with the Healthy Homes Partnership.

Improving Your Home Environment - Presenter is Selina Lujan, MSW, Senior Indoor Air Quality Specialist, Healthy Homes Program, City of Fort Collins Environmental Services Department, Fort Collins, Colorado.

Target Audience- OLHCHH grantees; a wide range of stakeholders who work with and assist residents.

In 2017, the City of Fort Collins, Colorado, launched a Healthy Homes Do-It-Yourself Assessment tool designed to be used by residents or owners to assess the indoor air quality of their homes. This program/tool was a 2018 awardee of the HUD Secretary’s Award for Healthy Homes. The tool, in Plain Language, walks through each room of the home, identifying potential hazards, and gives low cost or no cost solutions.

- Content focuses on home-assessment checklist/tool, on how to access to the actual tool, and how it works.
- We cover solutions that may be best for the top hazards usually contributing to Healthy Homes.
- We wrap up with links for more information.

Theme Focus: Indoor Air quality can be addressed with home assessment; how to get started in 5 minutes!

June 6, at 2:00 pm HUD’s Lead Paint Safety Field Guide – Presenters are Warren Friedman, PhD, CIH, Senior Advisor to the Director, OLHCHH; and Bruce Haber, Division Director, Program and Regulatory Support Division, OLHCHH.

Target Audience: OLHCHH grantees; Federal agencies; maintenance contractors; building maintenance staff; local public housing staff; contractors working in Federally-assisted housing; property managers.

This webinar will focus on the new version of the publication, released by HUD/OLHCHH in February 2019.

- Learn how to do a home fix up activity in a way that is lead-safe, within just five minutes.
- We will cover the purpose of the new guide, benefits, where to find it, and the range of potential users.
- The webinar also covers how the publication was developed, and what has changed.
- We review an example of information that could be looked up in the guide and demonstrate how to use it.

June 11, at 11:00 AM Home Visits are Needed to Address Asthma Health Disparities in Adults – Presenters are Joy Hsu, MD, MS, FAAIAI, Medical Officer in CDC’s Asthma and Community Health Branch, Division of Environmental Health Science and Practice; Helen Margellos-Anast, MPH, Senior Research Director/Senior Epidemiologist at Sinai Urban Health Institute; and David Turcotte, ScD, MS, Research Professor in the Department of Economics, University of Massachusetts, Lowell.

Target Audience - OLHCHH grantees; health care providers; insurance providers; case managers and home visitors.

- We frame the issue by talking about: Is there a difference between child and adult asthma? What are triggers for adult asthma? Home assessments can help how? What is the impact of home interventions on adults? What’s the advantage of using community health workers?
- The webinar reviews how OLHCHH has funded research in this area.
- Additional coverage on an asthma trigger checklist and other CDC resources and links for more information.
- We discuss how the findings of this research can be used to inform home intervention programs.

Theme Focus: Addressing asthma in adults includes home assessment too; how to get started in 5 minutes!

June 18, at 11:00 am Implementing Healthy Homes Principles and Practices in Disaster Recovery and Rebuilding - Presenters are Michael Goldschmidt, Director – National Healthy Homes Partnership; Graham McCaulley, Lisa Goldschmidt, and Kandace Fisher-McLean, University of Missouri.

Target Audience – Diverse range of potential stakeholders, especially those involved in the rebuilding phase; OLHCHH grantees; Federal agencies involved in disaster recovery and rebuilding.

This webinar will cover the new disaster recovery/rebuilding curriculum developed by USDA NIFA, as well as other resources available to the disaster recovery community. The webinar will feature the OLHCHH Disaster Recovery App.

- Content includes who is typically involved in developing resources and how to access them.
- We review the most accessible resources and who they are best suited for.
- We go through the app and how to navigate to what is most important to you.
- Content includes ways on how we can collaborate effectively to further on improve disaster recovery/rebuilding, as exemplified by hurricanes impacting Puerto Rico and US Virgin Islands, the recent flooding in the Midwest, and resulting from other types of natural disasters.
 - Types of resources typically needed
 - Access of information
 - Importance of timely communication to, and coordination with key POCs.

This webinar will highlight four new tribal publications and related app being developed through OLHCHH and USDA NIFA, with extensive input from a cross section of stakeholders and tribes. The webinar will briefly describe the process used to develop these educational materials and the prototype tribal app, and delivery/dissemination plan.

- Content includes a 15-minute review of the scope of the outreach effort/publications; and how the materials are tailored to four audiences across Indian Country.
- We provide a New Tribal App Sneak Peek.

- Content also includes 5 minutes on the prototype of the tribal app and how it will work, and benefits.
- We cover how to access, contribute and use these resources.
