USE:

Moderate and heavy traffic in Single and Multi-Family Dwelling Units (Type I – Classes 1 and 2).

DESCRIPTION:

This carpet is a tufted broadloom constructed of polyester (PET) bulk continuous filament (BCF) with a minimum of 3.0 denier per filament (DPF).

PRODUCT CERTIFICATION:

This certification program shall be in accordance with the Use of Material Bulletin, UM 44d, HUD Building Product Standards and certification Program for Carpet, except as modified by the provision of this Materials Release (MR) Bulletin. The Administrator shall certify that the carpet(s) described above conform to the requirements of this Bulletin and the following requirements:

1. The Administrator shall issue to the carpet manufacturer: 1) a certification statement of conformance to this MR; and 2) a label, stamp, or mark containing the Administrator's validation mark OR the manufacturer's name or code identifying the manufacturing plant location.
2. This certification label, stamp, or mark shall be applied to each carpet at least every six (6) feet, and not less than one (1) foot from the edge of the carpet.
3. Each product tested and certified under an initial certification program shall undergo physical testing as follows: three (3) samples are to be submitted annually based on the initial certification from each of the facilities listed below and at four month and eighth month interim intervals prior to the annual field sample submittal. All samples shall be submitted to the Administrator for testing in a laboratory accredited by the National Laboratory Accreditation Program (NVLAP) of the U.S. Department of Commerce.
4. The Administrator shall also visit each listed production facility every six (6) months and review the manufacturer's quality assurance procedures to assure the manufacturer follows its procedures.
5. If changes are made to the products covered by this MR, the approved third-party company shall notify HUD, within 30 days, with these changes with suggestions to keep/maintain, revise, or suspend this MR.

MANUFACTURER'S RESPONSIBILITIES:

Issuance of this MR commits the manufacturer to fulfill as a minimum, the following:

1. Produce the products in strict accordance with the terms of this MR.
2. Label the carpet at least every six (6) feet and not less than one (1) foot from the edge of the carpet. Label should include the Administrator identification number.
3. Provide necessary corrective action in a timely manner for all cases of justified complaint, poor performance or failure reported by HUD.
4. When requested, assist the Office of Manufactured Housing Programs, HUD Headquarters, obtain a representative list of properties in which the material, product or system has been used, including complete addresses or descriptions of locations and dates of installation.
5. Inform HUD of changes in production facilities, methods, design or materials used for this product, company name, ownership, or mailing address, within 30 days from the date the changes are made.
6. If in the interval between the Administrator's quality assurance audits, changes are made to the product, HUD and the Administrator shall be informed within 30 days of formal implementations of these significant changes.

7. Records of the Administrator's audit visits report shall be made available.

WARRANTY:

Mohawk Industries, Inc. warrants carpeting produced in accordance to this MR against manufacturing defects for a period of 10 years, and stain resistance for 10 years, depending on the specific carpet from the date of installation.

Mohawk warrants that the surface pile will not be worn by abrasion more than 10% in five years when used in an indoor residential installation. If within the warranty period, the pile weight of the carpet, when compared to un-trafficked area loses more than 10% of its weight, Mohawk will provide a replacement carpet of comparable value for the affected area only (the worn and adjacent areas extending to the nearest wall, doorway, or entrance).

The Mohawk warranty does not, in any way, relieve the builder of responsibility under the term of the Builder's Warranty required by the National Housing Act or under any provisions applicable to any other housing program. A copy of Mohawk Industries, Inc. warranty shall be furnished by the builder to the owner upon completion of the property.

EVALUATION:

This MR shall be valid for a period of three years from the date of initial issuance or most recent renewal or revision, whichever is later. The holder of this MR shall apply for renewal or revision 90 days prior to the Review Date printed on this MR. Submittals for renewal or revision shall be sent to:

If the Department determines that a proposed renewal or supplement constitutes a revision, the appropriate User Fee for a revision will need to be submitted in accordance with the Code of Federal Regulations 24 CFR 200.934, "User Fee System for the Technical Suitability of Products Program," and current User Fee Schedule

CANCELLATION:

Failure to apply for a renewal or revision shall constitute a basis for cancellation of the MR. HUD will notify the manufacturer that the MR may be canceled when:

1. conditions under which the document was issued have changed so as to affect production of, or to compromise the integrity of the accepted material, product, or system;
2. the manufacturer has changed its organizational form without notifying HUD; or,
3. the manufacturer has not complied with responsibilities it assumed as a condition of HUD's acceptance.

However, before cancellation, HUD will give the manufacturer a written notice of the specific reasons for cancellation and the opportunity to present views on why the MR should not be canceled. No refund of fees will be made on a canceled document.
