# Ballot Item VI-3: Log 154 - Section § 3280.607(b)(3)(i) Plumbing fixtures

**Tim O'Leary** - I believe it is important to identify ANSI 117.1 as a code of reference for not only this log item but as a reference standard for all accessibility issues in our product. I voted to disapprove this item with the understanding that a new reference be incorporated into the MHCCS in compliance with federal law. As it stands now, I believe we are out of compliance with the rules for accessibility.

**Joseph Sadler** - I believe if a consumer requests an accessible home, you should have a standard for the construction of such options. I would guess that the ADA would have a issue if this was not available. The ANSI A-117 Standard used in the ICC Codes seems the best avenue for how these accessible baths should be constructed.

**Dave Anderson** - The rational for the proposal to create an exception to fire-resistance rating in two-family units was that it created uniformity between the HUD Code and the International Residential Code. However, the proposal failed to introduce any evidence that it was equally appropriate for manufactured housing and site-built housing to have such an exception. The proposal simply assumes it to be true.

**Dave Anderson** - It is important to improve the energy efficiency and affordability of manufactured housing in both the short term (construction) and long term (operations). Achieving both will certainly require policy changes beyond those possible within the context of the HUD Code. Given that proposals we are dealing with relate only to the HUD Code, we should look for energy efficiency standards that balance short-term and long-term affordability, and provide information and alternatives for consumers.

### Negative - 2

**Tim O'Leary** - I believe it to be important to incorporate the recommendations of the MH Working Group into the HUD standards as recommended by Mr. Roy. Improving the efficiency of our product is essential to our keeping up with changes in technology and our understanding of building science as has been done in the ICC codes. Except for a manufacturer's lobbyist, the members of the MH Working Group are a who's who of energy professionals from all over the United States. These professionals did

a magnificent job of defining the improvements that could be done cost effectively while maintaining affordability of the product. The MHCC was not given a copy of their report as stated in the body of the Log item that I assume would have detailed the specific language changes and improvements associated with the proposal. The log item states that these documents were sent to Home Innovation as part of the proposal. The MHCC members should have been given a copy of this document so we could have studied them and been ready to vote on the proposal. This appears to have been a bait and switch tactic played on us. If the MHCC members would have been given all the facts, perhaps the outcome would have been different.

Joseph Sadler - After reviewing data I had available, I revised my view on energy efficiency requirements. Although, I do not have the information, yet, that we have requested n the approved motions listed in Ballot Items VI-34 & VI-35, it would seem the cost for energy efficiency would be offset by the benefit to the consumer with regards to heating and cooling costs. The Energy Star program seems to support this conclusion. This should, at the very least, be an option for a consumer.
