Dear Mr. Logan:

This letter certifies that the State of Kansas is in compliance with the requirement of section 1616(e) of the Social Security Act. The Kansas Department for Aging and Disability Services (KDADS) and the Kansas Department of Health and Environment (KDHE) are responsible for licensing facilities for populations which include recipients of Supplemental Security Income as indicated below.

KDADS is responsible for licensing the following adult care facilities:

- Nursing facilities
- Nursing facilities for mental health
- Intermediate care facilities for individuals with intellectual disabilities
- Assisted living facilities
- Residential health care facilities
- Home plus facilities
- Boarding care homes
- Adult day care facilities


KDHE is responsible for licensing the following child care facilities:
