

7. Employee Justification (attach additional pages if necessary)

FHA Single Family requires that all Properties with pending Mortgages or endorsements in Presidentially-Declared Major Disaster Areas (PDMDA) have a damage inspection report that identifies and quantifies any dwelling damage. The damage inspection report must be completed by an FHA Roster Appraiser even if the inspection shows no damage to the Property, and the report must be dated after the Incident Period (as defined by FEMA). At this time, FEMA has designated the incident period for the Hawaii Kilauea Volcanic Eruption and Earthquakes (DR-4366) as ongoing. FEMA defines the Incident Period in 24 CFR 206.32(f) as: "The time interval during which the disaster-causing incident occurs. No Federal assistance under the Act shall be approved unless the damage or hardship to be alleviated resulted from the disaster-causing incident which took place during the incident period or was in anticipation of that incident. The incident period will be established by FEMA in the FEMA-State Agreement and published in the Federal Register." While FHA insurance is not Federal Assistance under the Stafford Act, FHA's requirements adopt FEMA's definition to ensure properties are not endorsed during the time interval in which disaster causing incidents are ongoing. FHA believes that the situation in lava flow zones 3-9 has stabilized to the extent that further damage to properties appears unlikely despite FEMA not having closed its Incident Period for the PDMDA. As the risk of further property damage subsequent to the effective date of this waiver appears unlikely and the inability to begin inspections may be causing harm to consumers, FHA is waiving this requirement that the incident period be closed by FEMA in order to inspect.
