Re: FY21 Certification of Compliance with the "Keys Amendment"

Dear Mr. Scott Logan:

This letter is regarding Minnesota's certification of compliance with Section 1616 (e) of the Social Security Act (known as the "Keys Amendment"). The following constitutes the State of Minnesota's certification of compliance with the requirements of Section 1616 (e) for fiscal year 2021.

This letter certifies that the Minnesota Department of Human Services has established, maintains, and ensures the enforcement of standards for categories of residential services in which significant numbers of Supplemental Security Income (SSI) recipients reside or are likely to reside.

The Department of Human Services, Division of Licensing, is responsible for the licensure of residential programs, as defined under Minnesota Statutes, section 245A.02, subdivision 14. Please note that the Minnesota Department of Health regulates health facilities, in which SSI recipients may reside, and are not included within the scope of this certification.

A list of Department of Human Services' statutes and rules governing the licensure of residential programs have been submitted to the Social Security Administration in the past as part of the certification of compliance process. The statutes included the Human Services Licensing Act (Minnesota Statutes, chapter 245A), the Human Services Backgrounds Studies Act (Minnesota Statutes, chapter 245C), the Home and Community-Based Services Standards (Minnesota Statutes, chapter 245D), and the Substance Use Disorder Services (Minnesota Statutes, chapter 245G).

Because of the volume of paper associated with these chapters of Minnesota Statutes, I am not enclosing paper copies of the statutes. Instead, I am identifying all sections of Minnesota Statutes, chapters 245A, 245C, 245D and 245G that were amended in 2020. Please see the attachment for these amendments.


