I am sending this letter as the annual certification of compliance with Section 1616(e) of the Social Security Act (the Keys Amendment). The State of Oklahoma is in full compliance with this provision, and has developed State standards for safe and appropriate residential settings for Supplemental Security Income (SSI) recipients, limiting the use of SSI funds for substandard facilities; and publicize standards and enforcement procedures for these facilities as a means of including public monitoring.

Designation of State authority to establish and enforce standards for residential facilities where significant number of SSI recipients reside, or are likely to reside.
