<b>Description:</b>	The Federal Housing Administration’s (FHA) National Servicing Center will review guidance for servicing FHA-insured <u>forward</u> mortgages located in a Presidentially-Declared Major Disaster Area

(PDMDA). Topics for discussion include: identifying a PDMDA, foreclosure moratorium requirements, and available loss mitigation options.
