SUBJECT: Remediation Plan to Address Overdue Appropriations Reports

DATE: March 5, 2018

Background:

Each fiscal year the House and Senate Committees on Appropriations ("Committee") direct the Department of Housing and Urban Development (HUD) to provide formal reports on numerous subject matter areas. Such reports provide an opportunity to update our congressional stakeholders on our operations, programs, policies, and research. Appropriations reports are not optional, and the Committees use these reports to inform their decisions in the annual appropriations process.

The Department currently has over 100 overdue appropriations reports dating back to 2014. The backlog of overdue reports must be corrected. It is also essential to take steps to improve the timely delivery and content of our reports to ensure that HUD is fully responsive to the reporting requirements identified in the appropriations act. As you know, the subject matter area of these reports can have implications across the Department. Each office must take the appropriate steps to improve report quality and ensure timely submission. I am committed to implementing a remediation plan that will address the overdue reports and establish a solid foundation for processing future requirements. This new process will emphasize monitoring internal deadlines, effective tracking, and quality control. For this effort to be successful, we need the senior leadership in each office to commit to the new process and work collaboratively with the Office of the Chief Financial Officer (OCFO) to enforce internal deadlines.

We will begin with implementing the process below immediately in order to remediate our overdue report backlog. We expect to have an enacted Fiscal Year 2018 Appropriations law by late March, and the process for completing the 2018 reports will include the same steps outlined below. These processes and procedures will apply to all congressionally requested reports contained in subsequent annual appropriations bills. This will ensure that we will not continue a pattern of late or insufficient responses going forward.

Remediation Plan for Overdue Appropriations Reports:

I have designated the OCFO Budget staff as the principal office for implementing the remediation plan and the primary points of contact for this process are ACFO for Budget Emily Kornegay and Appropriations Liaison Division Director Eric Rios.

The key elements of the plan are as follows:

- **1. Designate Point of Contact:** All offices with overdue and upcoming 2018 reports shall designate a point of contact to assist OCFO in assigning reports, tracking status, and enforcing internal deadlines.
- **2. Verify Report Status:** It is possible overdue appropriations reports have been fulfilled as part of a larger annual report prepared by the Program Office. This verification process is needed to document these cases and inform the Appropriations Committee staff. For 2018 reports, Program Office staff should verify the report is appropriately assigned to their office and inform OCFO Budget staff if the report will be provided as part of a larger annual report.
- **3. Modernize Tracking System:** The verified master tracking list of overdue reports will be uploaded to SharePoint and access will be provided to Program Office points of contact. By late March, OCFO Budget staff anticipate having the full list of 2018 reports uploaded to SharePoint for Program Office review.
- **4. Seek clarification from Appropriations Committee -** OCFO Budget staff will provide the list of overdue reports to the Committee staff (as required quarterly by HUD's appropriations law). The Committee staff will provide any necessary clarification on fulfilling overdue quarterly reports from prior years. For 2018 reports that require additional clarification, OCFO Budget staff will consult with the Appropriations Committee to clarify intent.
- **5. Program Offices Prepare Reports** For overdue and upcoming 2018 reports, OCFO requests names of the offices responsible for preparing reports, reviewing officials and internal due dates for each step shown below. This information will be included in the SharePoint master tracking list. This information will allow OCFO and Program Offices to document steps in the process that are prone to delay.
 - 1. Responsible office prepares report
 - 2. Reviewing officials approve the report
 - 3. Departmental clearance, as necessary
 - 4. OCFO Budget final review and transmittal
- **6. Monitoring Progress -** OCFO staff will convene a bi-weekly meeting with Program Office points of contact to discuss the status of overdue reports and identify logistical or content related concerns. If a report is delayed, OCFO Budget staff will assign a reason code to document the delay. The status of overdue reports and any challenges identified will be reported to the CFO. The CFO will provide monthly updates to the Deputy Secretary on the status of the overdue appropriations reports.
- **7. Quarterly Updates to Appropriations Committee** For all reports, OCFO Budget staff will provide the Appropriations Committee with timely quarterly updates on the status of appropriations reports.
