- 1. <u>This Transmits:</u> HUD Handbook 6509.2 REV-7 CHG-4, *Community Planning and Development Monitoring Handbook.*
- 2. Explanation of Significant Changes: The primary purpose of this revision is to provide updated direction for monitoring supplemental funding made available under the *Coronavirus Aid*, *Relief, and Economic Security Act* (CARES Act). A new chapter, Chapter 36, is being added and includes Exhibits that address unique requirements for supplemental funding used to prevent, prepare for, and respond to coronavirus for the Community Development Block Grant (CDBG), Housing Opportunities for Persons With AIDS (HOPWA), and Housing Opportunities for Persons With AIDS Competitive (HOPWA-C) programs and Emergency Solutions Grants (ESG) programs. The purpose of the Exhibits is to supplement existing program guidance when there are requirements unique to supplemental funding provided under CARES Act. These unique requirements are now added to a new Chapter 36.

3. Description of Specific Changes:

- a. Table of Contents: Conforming changes have been made, where necessary, to reflect the modifications noted here.
- b. <u>Chapter 1 INTRODUCTION</u> Section 1-3 APPLICABILITY is being updated to include supplemental funding provided under the Coronavirus Aid, Relief, And Economic Security Act.
- c. <u>Chapter 2 MANAGEMENT OF MONITORING ACTIVITIES</u> Section 2-3 USE OF RISK ANALYSIS is being updated to reference updated Notice Implementing Risk Analyses for Monitoring Community Planning and Development Grant Programs in FY 2022. Section 2-5 PREPARING FOR MONITORING is being updated to align with the Notice.
- d. <u>Chapter 36 CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY</u>
 <u>SUPPLEMENTAL FUNDING CARES ACT (CDBG-CV, HOPWA-CV, HOPWA-C-CV, ESG-CV)</u> The introductory text has been added to include instructions on how to use

the Exhibits. There are Exhibits for each of the programs with CARES Act related Exhibits including the Community Development Block Grant Entitlement (CDBG) and Community Development Block Grant State (CDBG) programs; and Housing Opportunities for Persons with Aids (HOPWA), and Housing Opportunities for Persons with Aids Competitive (HOPWA-C) programs; and Emergency Solutions Grant (ESG-CV) programs. A description of the new Exhibits includes:
