**ORDER DISMISSING PROCEEDINGS DUE TO SETTLEMENT**

By Notice of Suspension dated February 19, 2019, the Department of Housing and Urban Development (“HUD”) notified Respondent Gregory J. Darr, that HUD was suspending him immediately from future participation in procurement and nonprocurement transactions as a participant or principal with HUD and throughout the Executive Branch of the Federal Government. On October 17, 2019, HUD issued a Notice of Proposed Debarment to Gregory J. Darr, for a three-year period from February 19, 2019, the date of Mr. Darr’s suspension.

On September 30, 2021, Government Counsel Joel Foreman submitted Government’s Motion for Dismissal and Imposition of 3-Year Debarment, including electronic jpeg files, consisting of two pages of a Settlement Agreement, upon which Respondent initialed page one and signed page 2. The Debarring Official has executed a counterpart of this settlement agreement (with changes made to the footer to identify the correct Respondent), effective October 1, 2021. Copies of these signed electronic files are attached hereto.

Therefore, as the Settlement Agreement has been signed by both Parties in counterpart electronic versions, and the Government has moved to dismiss the proceedings, this matter is hereby dismissed. Respondent’s debarment will be noted for the three-year period from the date of the Respondent’s suspension, February 19, 2019, terminating on February 19, 2022.
