ORDER DISMISSING HEARING DATE AND SUBMISSION DEADLINES

By Notice of Proposed Debarment and Suspension dated September 12, 2019, (“Notice”), the Department of Housing and Urban Development (“HUD”) notified Respondent Harold DeWayne Ennis, a/k/a Harold DeWayne Ennis, Jr., that HUD was suspending him and proposing his debarment from future participation in procurement and nonprocurement transactions as a participant or principal with HUD and throughout the Executive Branch of the Federal Government for three years from September 19, 2019, the date of his suspension. On October 23, 2019, HUD received an undated letter from Mr. Ennis concerning the suspension and proposed debarment, which requested an informal hearing but did not debate the facts of the matter. On September 1, 2021, an Order Setting Hearing Date and Submission Deadlines was issued, setting a hearing date of October 27, 2021, and a briefing schedule for the Government and Respondent. On September 17, 2021, Government Counsel Terri L. Román submitted Government’s Motion for Issuance of Notice of Debarment and to Dismiss, including an email that Respondent sent to Government’s Counsel on September 14, 2021, wherein he noted that he wished to withdraw his hearing request.

As Mr. Ennis has withdrawn his request for an informal hearing on the suspension and proposed debarment, and the Government has moved to cancel the hearing and submission deadlines, I therefore order the following:

The informal hearing, scheduled for October 27, 2021, at 10:00 am is hereby dismissed.

The submission schedule for the Government and Respondent is hereby canceled.

I recommend to the Debarring Official that a Final Notice of Debarment be issued, terminating as of September 11, 2022, three years from the date of the Respondent’s suspension.
