- 14 -17. Reviewer's Signature: Enter the legible signature and title of the Supervisory M&M Contractor/M&M COR/Closing Agent COR or designee, date of preparation, and phone number of the individual reviewing the form.
- 18 -19. **Approver's Signature:** Enter the legible signature of the HOC Director or designee, and date of approval and submission.
