

## Alaska

**Alaska Housing Finance Corporation (AHFC)** is awarded a HOPWA permanent supportive housing renewal grant of \$924,965 to continue providing permanent housing, comprehensive case management, and short-term housing assistance to persons living with HIV/AIDS in the northern interior and in southeast Alaska. The AHFC serves individuals and families in rural, hard-to-reach locations. AHFC will continue to partner with Interior AIDS Association and the Alaska AIDS Assistance Association. This collaborative effort will annually provide tenant-based rental assistance to 12 households, short-term rent, mortgage and utility assistance to 25 households, supportive services to 50 households, and permanent housing placement to 7 households.

## Alabama

**AIDS Alabama, Inc.** is awarded a HOPWA permanent supportive housing renewal grant of \$987,317 to continue providing 14 households with permanent supportive housing. AIDS Alabama targets HIV positive persons with severe mental illness who are linked to medical care, case management, psychiatric assessment/treatment, social services, transportation, and basic living skills training. An estimated 16 households annually will receive these wrap around supportive services in order to promote housing stability. Additionally, 35 households will receive housing information services, and 14 will receive permanent housing placement annually.

**Health Services Center, Inc.** is awarded a HOPWA permanent supportive housing renewal grant of \$915,881 to continue providing 12 households with facility-based permanent supportive housing, 30 households with short-term rent mortgage and utility assistance annually, and 80 households with supportive services annually. The program has a particular focus on homelessness prevention through the provision of supportive housing inclusive of housing case management and the development of individualized housing plans. Program participants are provided with employment training, counseling, and transportation assistance in coordination with local resources in order to promote and sustain housing stability. The program specifically targets homeless persons, including chronically homeless and families with children.

## Arizona

**Cochise County** awarded a HOPWA permanent supportive housing renewal grant of \$643,013. This collaborative effort of housing and supportive services will annually provide tenant-based rental assistance to 20 households, short-term rent, mortgage and utility assistance to 10 households, permanent housing placement to 4 households, housing information services to 90 households, and comprehensive supportive services and case management to 28 households.

**Pima County** is awarded a HOPWA permanent supportive housing renewal grant of \$1,425,283 to continue providing 9 units of facility-based housing and tenant-based rental assistance (TBRA) to 40 households annually. Individualized comprehensive case management and supportive services will assist 49 households annually. The project is a collaborative effort with the Southern Arizona AIDS Foundation.

## California

**Alameda County** is awarded a HOPWA permanent supportive housing renewal grant of \$1,561,072 to continue providing Tenant Based Rental Assistance (TBRA) to 79 households and client centered case management services to 101 households annually. The project is a collaborative effort with AIDS Project of East Bay and Bay Area Community Health.

## Georgia

**City of Savannah, Daniel Flagg Villas** is awarded a HOPWA permanent supportive housing renewal grant of \$261,995 to continue providing 10 units of facility-based housing for chronically homeless persons in Savannah and Chatham County through their Daniel-Flagg Villas project. The program also provides on-site substance abuse counseling and housing referral services for 60 households annually. The project is a partnership with the Chatham County Health Department and Union Mission, Inc.

**City of Savannah (Project House Call)** is awarded a HOPWA permanent supportive housing renewal grant of \$692,757 to continue providing 10 units of facility-based housing for chronically homeless persons in addition to homeless prevention activities through the use of Short-term Rent, Mortgage, and Utility assistance to 30 households annually. The program also provides on-site substance abuse counseling and healthcare follow-up to 100 households annually. The project is a partnership with Union Mission, Inc.

## Hawaii

**The Maui AIDS Foundation**, a nonprofit organization based in Maui County, is awarded a HOPWA permanent supportive housing renewal grant of \$1,520,103 to continue the provision of tenant-based rental assistance to 44 households annually. The program also provides 15 households with short-term rental assistance to prevent homelessness, 458 households with supportive services and housing information services annually. This project is an integral collaboration between the Maui AIDS Foundation, Malama Pono Health Services, and the Hawaii Island HIV/AIDS Foundation. A comprehensive case management approach allows persons living with HIV/AIDS to maintain housing stability and to prevent homelessness.

## Illinois

**The AIDS Foundation of Chicago, Re-entry Housing for Health Partnership**, is awarded a HOPWA permanent supportive housing renewal grant of \$1,483,450 to continue providing scattered-site tenant-based rental assistance to 33 post-incarcerated individuals annually. The project is a partnership with: Christian Community Health Center, The Boulevard of Chicago, and The Center for Housing and Health, in the provision of coordinated supportive services to ensure that clients have successful housing outcomes.

**The AIDS Foundation of Chicago (AFC) Chicago Housing for Health** project is awarded a HOPWA permanent supportive housing renewal grant of \$1,422,571 to continue providing supportive housing to persons living with HIV/AIDS in Chicago. The program is designed to

improve the health outcomes of those living with HIV/AIDS through the effective coordination of health care with the delivery of housing assistance. Annually, the program will provide tenant-based rental assistance to 33 households. The program will support project-dedicated case managers at each housing agency with the goal of providing intensive, highly individualized case management that will link an anticipated 33 households with a comprehensive array of supportive services and 3 households annually with permanent housing placement. This collaboration includes the following organizations: Housing Opportunities for Women, Christian Community Health Center, and The Center for Housing and Health.

**University of Illinois, College of Medicine** is awarded a HOPWA permanent supportive housing renewal grant of \$1,311,404 to continue providing 56 households with tenant-based rental assistance and supportive services and 30 households with permanent housing placement services (PHP) for persons living with HIV/AIDS annually. The project provides services in a 15-county area and will target those households receiving Ryan White benefits that have a housing need.

### **Kentucky**

The **Lexington-Fayette Urban County Government** is awarded a HOPWA permanent supportive housing renewal grant of \$1,506,791 to continue operation of its partnership with AIDS Volunteers Kentucky, Inc. This program provides housing assistance, supportive services, housing information services, and permanent housing placement for low-income individuals living with HIV/AIDS in Central and Eastern Kentucky who are homeless, imminently homeless, or precariously housed. The program consists of two components: a housing facility that will assist 7 households annually and 8 scattered site tenant-based rental assistance units. Supportive services including case management, will be provided to 35 households annually.

### **Massachusetts**

**Action, Inc.** is awarded a HOPWA permanent supportive housing renewal grant of \$1,300,585 to provide 22 households with Tenant-Based Rental Assistance (TBRA) and 24 individuals with supportive services in Essex County over annually. Action, Inc. offers comprehensive supportive services and nutritional services to all clients.

### **Minnesota**

**The Salvation Army, Hope Harbor and Harvest Hills Project** is awarded a HOPWA permanent supportive housing renewal grant of \$473,084 to provide providing 14 units of facility-based supportive housing, Tenant-Based Rental Assistance (TBRA), Permanent Housing Placement (PHP) and Supportive Services to 16 households annually to individuals and families living with HIV/AIDS. This comprehensive housing and case management program supports families with children and individuals with multiple barriers and needs, including homelessness.

**Clare Housing** is awarded a HOPWA permanent supportive housing renewal grant of \$431,806 to provide 32 units of facility-based housing and 44 households with supportive services

annually. Permanent supportive housing is provided to very low-income individuals who have experienced homelessness or are at significant risk of homelessness.

**Clare Housing** is awarded a HOPWA permanent supportive housing renewal grant of \$994,072 to provide 23 units of facility-based housing and 45 households with supportive services. Permanent supportive housing is provided to very low-income individuals who have experienced chronic homelessness or are at significant risk of homelessness.

### **Mississippi**

**Grace House** is awarded a HOPWA permanent supportive housing renewal grant of \$1,266,240 to continue providing scattered-site tenant-based rental assistance and facility-based housing to individuals living HIV/AIDS within the Jackson metro area. Annually, the program will provide tenant-based rental assistance to 10 homeless individuals, 16 units of facility-based permanent housing, supportive services to 66 individuals, permanent housing placement to 10 households and short-term rental mortgage and utility assistance to 15 households annually. annually.

### **Montana**

The **State of Montana, Department of Public Health and Human Services**, in partnership with the states of North Dakota and South Dakota, is awarded a HOPWA permanent supportive housing renewal grant of \$1,512,514. This program is an innovative collaboration that supports the housing and supportive services needs of eligible individuals living in predominately rural areas across this three-state region. Annually, 76 households will receive tenant-based rental assistance, 23 households with short-term rent, mortgage, and utility assistance to prevent homelessness, and 113 households with comprehensive supportive services including: health/mental health assessment, day care, nutritional services, drug/alcohol abuse treatment, and counseling, as well as other needed services. The program will also support 14 households with permanent housing placement assistance each year in Montana and South Dakota. This collaborative partnership includes the following organizations: Open AIDS Alliance, District 7 Human Resource Development Council Billings, the Sioux Falls Housing and Redevelopment Commission, and Community Action Region VII.

### **New Hampshire**

**Harbor Homes, Inc.** is awarded a HOPWA permanent supportive housing renewal grant of \$512,470 to continue providing housing assistance to persons living with HIV/AIDS in Hillsborough County, as well as Derry, Windham, and Londonderry in Rockingham County. The program provides program participants with housing case management, counseling support, and auxiliary services to sustain housing stability. The program will serve 3 households annually with short-term, mortgage, rent and utility assistance and 11 households annually with tenant-based rental assistance, 30 households with Supportive Services and 3 households annually with Permanent Housing Placement (PHP).

**The City of Nashua, Division of Public Health and Community Services** is awarded a HOPWA permanent supportive housing renewal grant in the amount of \$1,532,092 to continue

providing tenant-based rental assistance and supportive services for up to 31 chronically homeless households living with HIV/AIDS within Hillsborough County annually. Additionally, the project continues its provision of permanent housing placement services to 8 households and 31 households receive supportive services that include transportation, mental health and substance abuse counseling, and food vouchers. The city will continue to work in partnership with Harbor Homes, Inc.

**Oregon Health Authority**, Oregon Statewide Supportive Community Re-entry (OSSCR) program, is awarded a HOPWA permanent supportive housing renewal grant of \$1,453,052 to continue providing scattered-site Tenant-Based Rental Assistance (TBRA) to 45 households, housing information services to 20 households, and supportive services to 45 households annually. The program is a collaborative partnership with the Cascade AIDS Project in the provision of housing assistance and services to post incarcerated individuals living with HIV/AIDS.

### **Tennessee**

**Kingsport Housing and Redevelopment Authority** is awarded a HOPWA permanent supportive housing renewal grant of \$1,133,529. The program will continue to annually provide 63 households with tenant-based rental assistance and supportive services, 10 households with Housing Information Services and 10 households with Permanent Housing Placement annually. Supportive services include case management, benefits counseling, educational opportunities, and other services will assist 63 households annually. The program is a collaborative partnership with Unity Housing.

### **U.S. Virgin Islands**

**Meeting the Needs of Our Community Inc.** is awarded a HOPWA permanent supportive housing renewal grant of \$1,510,082 to continue providing a continuum of housing assistance ranging from emergency to permanent housing, for persons living with HIV/AIDS in the U.S. Virgin Islands. This program targets a number of populations including chronically homeless, rural and minority populations with varying housing needs. Annually, the program will support 28 master-leased units, short-term rent, mortgage, and utility assistance to 9 households, permanent housing placement to 2 households, comprehensive supportive services, and case management to 48 households.

### **Vermont**

The **Vermont Housing and Conservation Board (VHCB)** is awarded a HOPWA permanent supportive housing renewal grant for \$1,497,540 to continue a statewide HIV/AIDS housing and supportive services program. This innovative program provides long-term rental assistance, short-term emergency housing assistance, the provision of supportive services and case management through regional AIDS service organizations. The program integrates housing, health care, and a range of supportive services into a single statewide delivery system. This project will support 30 individuals annually with tenant-based rental assistance and 98 households with short-term rent, mortgage and utility assistance. Additionally, 274 individuals

will receive supportive services annually. This collaborative partnership includes the following organizations: Vermont Committee for AIDS Resources, Education and Services, AIDS Project of Southern Vermont, Vermont State Housing Authority, and HIV/HCV Resource Center.

### **Wisconsin**

**Vivent Health**, is awarded a HOPWA permanent supportive housing renewal grant of \$1,387,961. The program will annually provide 37 households with tenant based rental assistance, supportive services and housing information services throughout the State of Wisconsin annually.
