<sup>1</sup> PHAs will be funded based upon an estimate in January, February, March & April. Only projects in the inventory will receive funding based upon an estimate. The inventory is derived from PIC.

<sup>2</sup> The following AOS MTW PHAs are required to submit their form HUD-52723 no later than February 7, 2022: PA001, PA002, DE004, MD002, IL002, WA001, OR002, CT004, MA003. HUD does not pre-populate data for AOS MTWs in the manner that it does for other PHAs. Therefore, these PHAs can calculate their eligibility almost entirely independent of the publication of the form HUD-52723. The AOS MTW PHAs should calculate their Op Fund grant eligibility before HUD publishes the form HUD-52723s, and then complete and submit their form HUD-52723, along with supporting documentation, promptly after HUD publishes the Excel tools. More specifically, PHAs should submit their calculations of OpFund grant eligibility to their FO, along with any supporting documentation, no later than January 21, 2022. This will provide HUD more time to review these submissions, which is needed to ensure accurate funding because of the complexity of the AOS calculation.

<sup>3</sup> Pursuant to 24 CFR 990.315, PHAs are required to prepare an operating budget and have it reviewed and approved by resolution by its Board of Commissioners. The PHA Board Resolution (the form HUD-52574) approving the PHA's operating budget must be submitted in the Operating Fund Web Portal.
