March 30-31, 2021 <u>Indian Housing Plan/Annual Performance Report (IHP/APR)</u> ONLINE

Description: The Association of Alaska Housing Authorities is hosting a two (2) day virtual training on Indian Housing Plan

(IHP)/Annual Performance Report (APR). This online workshop will provide participants with a comprehensive understanding of the IHP and APR requirements, the process for developing the local IHP, tracking activities for the APR, step-by-step process for completing the report template and current reference materials related to the IHP and APR. The workshop also incorporates discussion and case studies to facilitate networking and to

assist participants in being prepared to complete their IHP and APR.

This training will emphasize the development of local self-monitoring plans that are appropriate and effective for the size

and needs of the recipient's program. The training will provide participants with the most current

information on the requirements as well as the tools that are available to support recipient self-monitoring.

Description: AAHA will host a three (3) day intensive online training, presenting energy-efficient building techniques for

builders, designers, planners, and homeowners. It is an excellent opportunity to learn the latest construction methods related to residential energy efficiency. This course meets the State of Alaska Division of Occupational Licensing educational requirements that qualify general contractors to take the state Residential Endorsement exam (to be eligible, participants must be online/present for the entire training). The building technologies introduced are based on energy conservation through the use of insulation, air/vapor retarders, insulating

windows, and controlled ventilation systems, among other methods.

Description: AAHA is hosting an exciting and interactive three (3) day online training with a half day (04/30/2021) being

available for participants to schedule a one-on one session with the trainer. The training will provide attendees with a comprehensive introduction to the Native American Housing Assistance and Self Determination Act of 1996 (NAHASDA). Participants will become familiar with latest regulations, program guidance, and PIH Notices. A thorough review of eligible families and eligible activities including rental housing, homebuyer programs, rehabilitation and housing and crime prevention services will be provided. Other major topics to be addressed include the Indian Housing Block Grant (IHBG) formula, calculating income eligibility and adjusted gross income,

moderate-income family assistances, income verification.

by the new rule and the applicable conforming regulations of the 2 CFR Part 200 for the following HUD/ONAP

regulations, 24 CFR 1000 (IHBG) and 24 CFR 1003 (ICDBG). To support the Tribes/TDHEs during the implementation stage, the training will emphasize the practical changes recipients must make to their administrative and/or management systems (i.e. policies, operating procedures, and other internal control

processes) to ensure ongoing compliance with the new Uniform Guidance (2 CFR Part 200)

Some of the policy topics include: Applicable Alaska Law, Application Process, Eligibility and Ineligibility, Waiting Lists, Verification, Maintenance and Inspections, Hoarding,

Collections, and Termination.

Participants are encouraged to have calculators and a copy of their Admissions and Occupancy policies so they can practice applying them to case studies and role-playing exercises presented during this course.

Tribes. The training will deliver highlights of best practices to ensure that the management and accounting of the NAHASDA funds are being observed and practiced in accordance with the regulations. Participants will be given resources and tools that the HUD/ONAP program recipients (Tribes and TDHEs) can utilize to prepare for and be "audit ready" for their annual audit of their Financial Statements and Single Audit. The training will include a review of relevant sections of the 2 CFR Part 200 Uniform Guidance on audit requirements, review of internal controls, expenditure compliance, financial record keeping, the latest OMB Compliance Supplement for

the NAHASDA program, and Year-end closing processes.

Entities (TDHE) must understand the housing needs in the communities to be able to fairly and effectively distribute NAHASDA funds to achieve housing goals of homeownership, rentals, repairs and housing services programs. To increase affordable, energy efficient housing within their regions, it is critical that these tribes and TDHEs have access to solid data to help make informed decisions on where to invest, what types of housing program to develop and which funding programs to target. Knowledge derived through housing needs analysis

can also assist by achieving a compelling funding case for outside investors.

Description: AAHA will host a three (3) day training that will provide attendees with a comprehensive introduction to the

roles and responsibilities of Board of Commissioners and Tribal Council members with regard to the Native American Housing Assistance and Self Determination Act of 1996 (NAHASDA). Topics to be addressed include; Fiduciary Responsibilities; Conflict of Interest; Procurement; Compliance and Monitoring; Admissions Requirements; Policy Requirements; and Decision Making. This course provides the foundation for Board of Commissioner and Tribal Council members to be successful in applying applicable rules and policies to conflict

resolution and decision-making. Case studies, group discussions, and hands-on exercises will be applied to

reinforce NAHASDA concepts.

toxic chemical compounds that become airborne and deposit onto walls, ceilings, appliances, floors and carpet,

mattresses and any personal possessions exposed. The presence of these chemicals poses a health risk to

occupants and a potential liability to property owners. AAHA is hosting a two (2) day training on

Methamphetamine Decontamination. This training course will cover aspects of meth lab and meth user

(smoking) site decontamination/remediation and clean up. Attendees of the course will learn the tools and skills

necessary to decontaminate a building or dwelling where meth has been smoked or produced.
