Sept 26-28, 2022 <u>Environmental Review Report (ERR) Workshop</u> ONLINE

Description: The purpose of this online, 3-day Environmental Review training is to provide HUD recipients with the necessary skills to

ensure full compliance with the requirements of 24 C.F.R. Part 58. Participants will become familiar with: responsibilities of entities, achieving compliance with NEPA and related laws, Executive orders, and regulations; preparing environmental review records; making environmental review determinations, identifying environmental impacts; the consultation process,

public notice and comment periods; and processing the request of the release of funds.

Description: AAHA is hosting a four (4) day online workshop to provide an **overview** of PATHWAYS HOME: A NATIVE HOMEOWNERSHIP

GUIDE, to bring Native communities resources needed to make homeownership a reality.

Pathways Home is a curriculum to help Tribes and TDHEs develop a comprehensive housing counseling program focusing on assisting tribal members to qualify for leasing, purchasing, and owning a home. Pathways Home is a program that can be tailored to each community's needs.

This overview of the PATHWAYS HOME curriculum will provide participants with tools to implement a housing counseling program. Topics include, but are not limited to: Overview of Housing Counseling; Budgeting and Credit; Affordability; the Loan Process; Debt Management; Protecting Your Assets; and more. Participants will analyze scenarios requiring an assessment of a family's financial situation and preparation of a plan designed to achieve the family's housing goals.

The training will provide attendees with a comprehensive introduction to the Native American Housing Assistance and Self Determination Act of 1996 (NAHASDA). Participants will become familiar with latest regulations, program guidance, and PIH Notices. A thorough review of eligible families and eligible activities including rental housing, homebuyer programs, rehabilitation and housing and crime prevention services will be provided. Other major topics to be addressed include the Indian Housing Block Grant (IHBG) formula, calculating

income eligibility and adjusted gross income, moderate-income family assistances, income verification.

This virtual training will emphasize the development of a strategic plan that is appropriate and effective for the size and needs of the recipient's programs. Data development and analysis, recognizing critical issues and identifying goals and implementation will be included in the

covered topics.

Description: AAHA is hosting an exciting and interactive three (3) day training with November 18th (11/18/2022) being

available for participants to schedule a one-on one session with the trainer. The course will cover Admissions and Occupancy program management with topics to include the application and selection process, eligibility for housing assistance, calculating annual income, determining monthly rental or homeownership payments, occupancy standards, effective communication techniques with residents, lease agreement compliance, and collections. The course will also examine how maintaining high standards in the Admissions and Occupancy program affects the overall management of tribal housing programs. Participants are encouraged to have calculators and a copy of their Admissions and Occupancy policies so they can practice applying them to case

studies and role-playing exercises presented during this course.

Description: The Uniform Guidance establishes the administrative and financial management requirements for all Federal grants in

accordance with 2 CFR 200. The Uniform Guidance requirements encompass management standards, procurement, reporting, record keeping, allowable costs, audits and much more. In addition to the Uniform Guidance, specific program requirements are established by statute or regulation which supersedes the Uniform Guidance. This three (3) day online training will provide participants with a comprehensive overview of the administrative and financial management requirements for the Indian Housing Block Grant (IHBG) pursuant to the Native American Housing Assistance and Self Determination Act (NAHASDA) including the Uniform Guidance. The training will emphasize practical applications of the

Uniform Guidance to the NAHASDA program requirements.

Description: AAHA will host a four (4) day online training on Basic Financial Management & Audit Preparation for Small Tribes. The

training will deliver highlights of best practices to ensure that the management and accounting of the NAHASDA funds are being observed and practiced in accordance with the regulations. Participants will be given resources and tools that the HUD/ONAP program recipients (Tribes and TDHEs) can utilize to prepare for and be "audit ready" for their annual audit of their Financial Statements and Single Audit. The training will include a review of relevant sections of the 2 CFR Part 200 Uniform Guidance on audit requirements, review of internal controls, expenditure compliance, financial record keeping, the

latest OMB Compliance Supplement for the NAHASDA program, and Year-end closing processes.

Description: Manufacturing or smoking methamphetamine (meth) contaminates residential properties with dangerous and toxic

chemical compounds that become airborne and deposit onto walls, ceilings, appliances, floors and carpet, mattresses and any personal possessions exposed. The presence of these chemicals poses a health risk to occupants and a potential liability to property owners. AAHA is hosting a two (2) day training on Methamphetamine Decontamination. This training course will cover aspects of meth lab and meth user (smoking) site decontamination/remediation and clean up. Attendees of the course will learn the tools and skills necessary to decontaminate a building or dwelling where meth has been smoked or

produced.

To increase affordable, energy efficient housing within their regions, it is critical that these tribes and TDHEs have access to solid data to help make informed decisions on where to invest, what types of housing program to develop and which funding programs to target. Knowledge derived through housing needs assessments can also assist by achieving a compelling funding case for outside

investors.
