<sup>1</sup> PHAs may be funded based on an estimate in January, February, and March. If funding is based upon an estimate, only projects in the inventory will receive funding. The inventory is derived from PIC.

<sup>2</sup> The following MTW PHAs with Alternative Operating Fund Formula (AOFF) are required to submit their form HUD-52723 no later than 10/11/2024: PA001, PA002, DE004, MD002, IL002, WA001, OR002, CT004, MA003. HUD does not pre-populate data for AOFF MTWs like other PHAs. Therefore, these PHAs can calculate their eligibility almost entirely independent of the publication of the form HUD-52723. The AOFF MTW PHAs should calculate their Operating Subsidy grant eligibility before HUD publishes the form HUD-52723s and then complete and submit their form HUD-52723, along with supporting documentation. More specifically, PHAs should submit their calculations of Operating Subsidy grant eligibility to their FO, along with any supporting documentation, by 9/27/2024. This will give HUD more time to review these submissions, which is needed to ensure accurate funding because of the complexity of the AOFF calculation.

<sup>3</sup> For CY 2025 Op Sub, PHAs must obtain approval for their operating budget from their board before the start of their 2024 FY (FYB). PHAs that do not submit their FYB 2024 operating budget may not receive initial funding, until the budgets are submitted.
