SUBJECT: Publication of IHBG-CARES Implementation Notice

Dear Tribal Leader:

On March 27, 2020, the President signed the Coronavirus Aid, Relief, and Economic Security (CARES) Act (Public Law 116-136), which provides additional funding to prevent, prepare for, and respond to the COVID-19 pandemic. The CARES Act included \$200 million for the Indian Housing Block Grant (IHBG-CARES) program, as well as providing HUD the authority to waive and establish alternative requirements for the IHBG program.

On April 3, 2020, HUD published IHBG-CARES funding allocations for all Indian tribes and Tribally Designated Housing Entities (TDHEs) that are eligible to receive funding. The funding allocations can be found at: www.hud.gov/codetalk.

On April 10, 2020, HUD published Notice PIH 2020-05, which describes in detail the waivers and alternative requirements that apply to new IHBG-CARES funds and Fiscal Year 2020 IHBG formula funds (IHBG recipients are reminded that these waivers and alternative requirements do not apply to IHBG funds appropriated in any other prior year). Today, HUD published the IHBG-CARES Implementation Notice, which provides instructions on how to apply for IHBG-CARES funding and other program requirements. This Notice can be found at: www.hud.gov/coronavirus and www.hud.gov/codetalk.

HUD has worked to streamline the application process as much as possible, while ensuring that all IHBG-CARES funds will be used to prevent, prepare for, and respond to COVID-19, as required under the CARES Act. In order to receive IHBG-CARES funds, the Indian tribe or TDHE must first submit an Abbreviated Indian Housing Plan (IHP) and to its Office of Native American Programs (ONAP) Area Office.
