The NOFO announced the availability of approximately \$76.5 million for competitive grants with instructions on how to apply. Applicants have until 11:59:59 p.m. Eastern Daylight Time (EDT) on October 25, 2021, to submit applications. In addition, on August 24, 2021, HUD published the NOFO for the **Indian Housing Block Grant (IHBG) Competitive program**. The NOFO announced the availability of approximately \$95 million for competitive grants with instructions on how to apply. Applicants have until 11:59:59 p.m. Eastern Standard Time (EST) on December 1, 2021, to submit applications.
