Stability Vouchers Award Invitations Issued

On Monday, April 17, HUD's Office of Public and Indian Housing (PIH) invited 139 PHAs to accept an allocation of HUD Stability Vouchers based on Registrations of Interest submitted in the Fall of 2022. This funding opportunity was a part of a first-of-its-kind package of resources to address unsheltered homelessness and homeless encampments. PHAs that received an invitation letter are reminded to reply to HUD by **Friday, April** 21st to accept the awards, in accordance with the letter instructions.

Notice on Remedies PHAs have for Poor Performing Owners in the Housing Choice Voucher and Project-Based Voucher Programs

PIH recently published <u>Notice PIH 2023-06</u>, which reminds PHAs of the remedies they have available when owners fail to comply with HCV and PBV policies and procedures, particularly those requirements that relate to the safety of the unit. This notice also reminds PHAs when owners must be prohibited from participating in their HCV and PBV programs, and when PHAs may exercise discretion to prohibit owners from participating in their programs.

NSPIRE goes live for the Housing Choice Voucher (HCV) program October 1, 2023



In preparation for this date, the NSPIRE team has been testing the app that inspectors will use for the protocols and conducted side by side Housing Quality Standards (HQS) and NSPIRE inspections with the Chicago Housing Authority and the New York City Department of Housing Preservation and Development. PHAs and owners can get ready for the effective date by watching the training-for NSPIRE for HCV on the HUD Exchange. FUNDING OPPORTUNITIES

HUD Announces \$30.3 billion in HCV Funding

Last week, PHAs received notification of their 2023 HCV Contract Renewal funding amount. These Contract Renewal amounts represent a combined \$26.3 billion. This is a \$2.3 billion (10.5 percent) increase over 2022 funding levels, which is intended to help PHAs adjust to recent inflationary pressures and serve more households. On Monday, March 20th, HUD announced the availability of up to \$10,000,000 in FY 2022 and FY2023 funding through its Distressed Cities Technical Assistance (DCTA) Program NOFO. Through this NOFO, HUD is announcing the availability of at least one award for the \$5 million in FY 2022 funding and one award of up to \$5 million in FY 2023 funding to provide technical assistance (TA) to units of general local government (UGLGs) and their non-profit partners serving communities experiencing economic hardship.

HUD-VASH Mid Cycle Registration of Interest

The FY 2023 HUD-Veterans Affairs Supportive Housing (HUD-VASH) Mid-Cycle Registration of Interest (ROI) – <u>PIH Notice 2023-09</u> – makes available approximately \$94.4 million in HUD-Veterans Affairs Supportive Housing (HUD-VASH) supporting approximately 11,000 new HUD-VASH vouchers. As in prior years, PHAs will be provided an opportunity to self-identify interest in receiving vouchers. Interested PHAs will be required to provide written letters of support from their partnering VAMC to be considered no later than Wednesday, **May 10, 2023**.
