Changes from the 2020 version of the TRG posting

This is the first posting of the TRG for the 2024 version of the forms. This section describes changes from the TRG for the 2020 version of the forms posted at the same time as the 2024 version of the TRG.

General notes:

- o For the most part, updates to the forms have yet to be developed in HIP as of this TRG publication. This means that these items are not yet available for testing. The HIP team will let software vendors know once items are ready to test.
- Some items, including new or updated codes, are not final until development has been completed.
- There are a few updates to JSON names and paths so that the data element can continue to be used across the versions of the forms (e.g., trying to make the JSON name more generic). Since the 2024 version of the TRG is not yet final due to development not being completed, items like this that may also affect the 2020 version of the TRG will appear here but in the 2020 version of the TRG will retain the current information and will just note the upcoming change. This way current testing of the 2020 version of the forms can continue.
- In cases where the line numbers differ on the forms, this document will say the question label but the TRG will continue to also contain the line numbers.

- Throughout the document adjustments are made to program type and action type information to comply with updates to those fields.
- o Where possible, the same validations (error codes) that are being used on the 2020 version of the 50058 forms will be used for the 2024 version of the forms. This is being done by using the "Form Version Date" in the header of the form submission and designating that the 2024 version of the form is being submitted (or 2020 for the 2020 version of a form).

• Section 1:

- O Updated program types to reflect that each voucher type now has its own program type code, so that we are no longer using VO for all three voucher types.
- Updated Unit Real Estate ID Number to reflect that it will be used by all submission types.
- Removed the Voucher Type field due to voucher program types being separate program type codes now.

- o Removed the Passbook rate field because it does not need to be submitted and won't be validated for the 2024 version of the forms.
- o Removed the Imputed asset income field because it has been removed from the 2024 version of the forms.
- o Final asset income, updated information to match the 2024 version of the forms.
