

Sample Tribal Resolution Language- HUD ONAP ICDBG-ARP Applications

ICDBG-ARP Implementation Notice, [PIH Notice 2021-22](#), requires as part of the grant application Tribal Resolutions to evidence citizen participation and, if applicable, evidence a Tribe's Authorization for a Tribal Organization to apply on its behalf.
