**Title: Update to PIH Notice 2020-15, Revised Loan Limits for the Section 184 Indian Housing Loan Guarantee Program**

**Purpose:** The purpose of this Notice is to update PIH Notice 2020-15, Revised Loan Limits for the for the Section 184 Indian Housing Loan Guarantee program (Section 184) to include eight counties in the state of Arkansas recently approved as expanded Section 184 lending areas.

**Background:** The Department of Housing and Urban Development (HUD) is authorized to set Section 184 maximum loan limits pursuant to 12 U.S.C. § 1715z-13a(b). HUD has recently approved an expansion request by the Choctaw Nation to expand the Section 184 program into eight counties in the state of Arkansas. Specifically, Little River, Sevier, Polk, Scott, Howard, Montgomery, Logan, and Yell counties. These counties are now eligible for Section 184 guaranteed loans. With this Notice, the Section 184 loan limits are amended to include the corresponding loan limits to serve these counties. This Notice makes no additional changes.

**Applicability:** This Notice is effective for Section 184 case numbers issued on or after the date of this Notice.
