This letter obligates **\$161** of Operating Fund subsidy for Federal Fiscal Years 2016-2019 in the amounts of, **\$3** for 2016, **\$140** for 2017, **\$10** for 2018, and **\$8** for 2019, representing the amounts that Public Housing Authority (PHA) projects were underfunded due to calculation errors. The amount of the obligations was determined by making formula error corrections in each year of the error and determining the amounts each project was underfunded.
