SUBJECT: Revision to Deadline for submitting Revised Operating Subsidy forms related to the Small and Rural Frozen Rolling Base

1. <u>**Purpose</u>:** This Notice provides updated guidance to Public Housing Agencies (PHAs) on the processing of 2021 Operating Subsidy Eligibility. Specifically, this Notice revises Notice PIH-2021-04 and establishes a separate category of allowable revisions and deadline for submitting revisions to form HUD-52723 and form HUD-52722 for revisions related to the Small Rural (SR)-Frozen Rolling Base (FRB) program (SR-FRB program).</u>

2. <u>Background</u>: HUD provides Operating Fund (OpFund) grants for Public Housing at the project level on a calendar year basis. The OpFund Grant program is authorized under Section 9(e) of the United States Housing Act of 1937 (42 U.S.C. 1437g(e)). Regulatory requirements for the OpFund Grant program are located at 24 CFR Part 990. For CY 2021, funding for the OpFund Grant program was allocated by Congress through the Further Consolidated Appropriations Act, 2020 (enacted Dec. 19, 2020).

PHAs must electronically submit separate OpFund grant calculations for each project identified in HUD's Inventory Management System - Public and Indian Housing (PIH) Information Center (IMS-PIC). PHAs submit this information using electronic versions of the forms HUD-52722 and HUD-52723, which are referred to as "Excel tools."

3. <u>Revisions Related to the Small and Rural Frozen Rolling Base (SR-FRB) Program</u>: Section 12 of Notice PIH-2021-04 established four categories for which PHAs may submit revisions to their Form HUD-52722 and/or Form HUD-52723. It establishes a deadline of August 16, 2021, for submitting such revisions. This notice adds an additional category for which PHAs may submit a revision to Form HUD-52722 and Form HUD-52723 and establishes a different deadline for the submission of such revisions. The additional category for which PHAs may submit a revision is any revision related to the SR-FRB program as detailed in Notice PIH-2020-30. The deadline for submitting Form HUD-52722 (and associated Form HUD-52723) which contain a revision related to the SR-FRB Program is August 27, 2021. HUD will review revisions in accordance with the requirements of Notices PIH-2020-30, PIH-2021-17, and PIH-2021-04. For revisions approved by HUD, revised eligibility will be posted on the Operating Fund Web Portal. HUD will notify PHAs by email when revised eligibility is available for their review.

12. <u>Paperwork Reduction Act</u>: The information collection requirements contained in this notice are approved by the Office of Management and Budget (OMB) under the Paperwork Reduction Act (PRA) of 1995 (44 U.S.C. 3520). In accordance with the PRA, HUD may not conduct or sponsor, and a person is not required to respond to, a collection of information unless the collection displays a currently valid OMB control number. The active information collections contained in this Notice are approved under the PRA OMB Control Number 2577-0157.
