Description:	The Federal Housing Administration will provide training on two of FHA’s key programs available to assist homeowners in recovery efforts following a major disaster. Content includes a detailed review of the eligibility and underwriting requirements for originating FHA-insured forward mortgages in Presidentially-Declared Major Disaster Areas using FHA’s 203(h) Mortgage Insurance for Disaster Victims Program and 203(k) Rehabilitation Mortgage Insurance Program.
Special Instructions:	This training is open to all FHA-approved mortgagees, but you must register online. Seating is limited and is on a first-come, first-served basis. On-site registration begins at 8:15 AM, with the training beginning at 8:45 AM. Note: This training is being held in a government facility. Be advised that the on-site security screening is like an airport security screening. Attendees must provide a valid, government-issued photo I.D. and course registration confirmation at the guard station. Please allow extra time to go through the screening process.
