# Mortgagee Review Board: Administrative Actions Notice Published in Federal Register

Today, the Federal Housing Administration (FHA) published a notice in the *Federal Register* (<u>Docket No. FR-6097-N-01</u>) of all completed administrative actions taken by the U.S. Department of Housing and Urban Development's (HUD) Mortgagee Review Board during the period from October 1, 2016, through September 30, 2017. The notice provides a description of, and the cause for, the Mortgagee Review Board's administrative actions against HUD-approved mortgagees in 20 fact-based cases and 75 annual recertification violations.
