Transaction Layer Security 1.0 Technical Support for HUD Ends on Sunday, August 19, 2018

Today, the Federal Housing Administration (FHA) announced that effective Sunday, August 19, 2018, the Transaction Layer Security 1.0 (TLS 1.0) support for all Department of Housing and Urban Development (HUD) applications — including FHA Connection (FHAC), and all applications accessed through FHAC — will end. If you are using TLS 1.0 after the effective date, access to all HUD applications will be denied.

You are encouraged to contact your technical support if you have questions about which version of TLS you are currently using. Only TLS 1.1 and TLS 1.2 will be supported after the August 19th effective date.
