FHA Suspends Effective Date of Downpayment Assistance and Operating in a Governmental Capacity Guidance

Today, the Federal Housing Administration (FHA) published Mortgagee Letter (ML) 2019-10, which announced the suspension of the effective date of Mortgagee Letter 2019-06, "Downpayment Assistance and Operating in a Governmental Capacity," until further notice.

Mortgagees are advised to continue following the guidance published in the *Single Family Housing Policy Handbook* 4000.1 (SF Handbook) Section II.A.4.d.ii. regarding this matter.
