60-Day Notice for Condominium Project Approval Questionnaires Published in *Federal Register* and Posted on Single Family Housing Drafting Table

Under the provisions of the Paperwork Reduction Act (PRA), the Federal Housing Administration (FHA) on January 31, 2020, published *Federal Register* (FR) Notice, *Project Approval for Single Family Condominiums* (Docket No. FR-7027-N-06).

The 60-day PRA Notice seeks public comment on the renewal and revision of data collection forms <u>HUD-9991</u>, *FHA Condominium Loan Level/Single-Unit Approval Questionnaire*, and <u>HUD-9992</u>, *FHA Condominium Project Approval Questionnaire*. These forms are necessary to determine eligibility status for FHA single-unit or condominium project approvals.

Interested parties wishing to review the two forms can do so by visiting the <u>Single Family Housing Drafting Table</u> on hud.gov. Comments will be accepted through the method outlined in the <u>FR Notice</u> through March 31, 2020.
