The U.S. Department of Housing and Urban Development (HUD) issues this Notice of Funding Opportunity (NOFO) to invite applications from eligible applicants for the program and purpose described within this NOFO. You, as a prospective applicant, should carefully read all instructions in all sections to avoid sending an incomplete or ineligible application. HUD funding is highly competitive. Failure to respond accurately to any submission requirement could result in an incomplete or noncompetitive proposal.

In accordance with <u>Title 24 part 4, subpart B</u> of the Code of Federal Regulations (CFR), during the selection process (which includes HUD's NOFO development and publication and concludes with the award of assistance), HUD is prohibited from disclosing covered selection information. Examples of impermissible disclosures include: 1) information regarding any applicant's relative standing; 2) the amount of assistance requested by any applicant; and 3) any information contained in the application. Prior to the application deadline, HUD may not disclose the identity of any applicant or the number of applicants that have applied for assistance.

I. FUNDING OPPORTUNITY DESCRIPTION

A. Program Description

The Green and Resilient Retrofit Program (GRRP) is authorized and funded by Section 30002 of the Inflation Reduction Act of 2022, (Public Law 117-169) (the "IRA"), titled "Improving Energy Efficiency or Water Efficiency or Climate Resilience of Affordable Housing." The program seeks to amplify recent technological advancements in utility efficiency and energy generation, bring a new focus on preparing for climate hazards by reducing residents' and properties' exposure to hazards, and protecting life, livability, and property when disaster strikes. GRRP is the first HUD program to simultaneously invest in energy efficiency, greenhouse gas emissions reductions, energy generation, green and healthy housing, and climate resilience strategies specifically in HUD-assisted multifamily housing. All the investments under the GRRP will be made in affordable housing communities serving low-income families in alignment with the Administration's Justice40 initiative. GRRP investments will directly benefit residents of HUD-assisted housing, each a Justice40 disadvantaged community, by improving the quality, health, safety, and comfort of their housing, by strengthening their homes to be more resilient against extreme weather events, and by enhancing their ability to remain in their homes during the recovery from such events. Further, GRRP will advance the Administration's environmental justice efforts by investing in the quality and resilience of HUD's rent-assisted portfolio, properties serving the lowest-income Americans and a disproportionate number of older adults and persons with disabilities, often living in communities disproportionately vulnerable to the impacts of climate change.

HUD is offering GRRP funding through three separate cohorts designed to meet the different needs of HUD's assisted multifamily portfolio. The three cohorts of awards will be implemented through three parallel Notices of Funding Opportunity (NOFOs), as follows:

- The Elements NOFO provides modest awards designed to add proven and highly impactful climate resilience and carbon reduction measures to the construction scopes of in-progress recapitalization transactions.
- The Leading Edge NOFO provides funding to owners aiming to quickly meet ambitious carbon reduction, renewable energy generation, use of building materials with lower embodied carbon, and resilience goals without requiring extensive technical assistance from HUD.
- The Comprehensive NOFO provides funding to initiate recapitalization investments designed from inception around deep retrofits, focused on innovative energy efficiency and greenhouse gas emissions reductions, green and healthy housing measures, renewable energy generation, use of building materials with lower embodied carbon, and climate resilience investments. Comprehensive Awards are designed for the widest range of properties, including those that have not yet developed a recapitalization plan.

To the greatest extent feasible, these approaches will:

- Substantially improve energy and water efficiency and reduce emissions, including moving properties toward net zero, zero ready, or zero over time energy and emissions performance standards;
- Address climate resilience, including synergies that can be achieved between efficiency, emissions reduction, and resilience investments;
- Enhance indoor air quality and resident health;
- Implement the use of zero-emission electricity generation and energy storage;

- Minimize embodied carbon and incorporate low-emission building materials or processes; and
- Support building electrification.

This NOFO makes available approximately \$140,000,000 for the Elements Awards and describes the eligibility and process to select properties for this funding. Housing Notice H 2023-05 describes the program requirements that will govern properties and the use of funds after selection. This NOFO is designed to target eligible properties that are pursuing a recapitalization, but have not yet closed on financing, and have an opportunity to make these transactions greener and more climate resilient through targeted upgrades of specific building components. These awards, provided in the form of GRRP Grants or Surplus Cash Loans, will enable owners to include proven and highly impactful climate resilience, energy efficiency, and emission reduction measures in their construction scopes of work.

Applications for eligible properties which are submitted in a timely manner will be ranked based on priority categories as set forth in this NOFO.

Applicants selected for funding under this NOFO will receive a commitment letter with a conditional funding award up to the lesser of a) \$40,000 per unit at the property, b) \$750,000, or c) the cost of eligible GRRP program investments. Funding shall be available to include proven, high-impact climate resilience strategies, utility efficiency investments, emission reduction measures, and energy generation technologies in their construction scopes of work, which items must be selected from the options set forth in the rules governing this NOFO.

After selection, the applicant will be subject to the terms and requirements set forth in Housing Notice H 2023-05. Generally, 1) the project must reach financial closing, including the execution of grant and/or loan agreements and other required closing documents, within the timelines set forth in the Notice, 2) property rehabilitation must begin promptly after the financial closing, and 3) the owner must provide information to HUD to confirm completion of the eligible program investments and support ongoing program evaluation. HUD resources may be available to support the Owner's required benchmarking activities.

An owner must select which cohort is most appropriate for any particular property and may submit an eligible property to only one of the NOFOs available under the GRRP. Once an application for an eligible property has been accepted for review under one of the GRRP NOFOs, any other applications under the GRRP NOFOs for the same property will be considered ineligible. Within a single NOFO, the most recent complete application submitted shall be reviewed and previously submitted applications under the same NOFO are considered invalid. If an owner determines they would like to submit an application under a different NOFO, the owner must withdraw the pending application prior to submitting a new one for a different NOFO. An eligible property cannot receive an award under more than one NOFO. Housing Notice H 2023-05 provides more detail to guide an owner in choosing a NOFO.

Further program guidance is provided in Housing Notice H 2023-05, which all potential applicants should review alongside this NOFO. Capitalized terms used but not defined in this NOFO shall have the definitions ascribed to them in Housing Notice H 2023-05.

2. HUD and Program-Specific Goals and Objectives

This NOFO supports <u>HUD's Strategic Plan for Fiscal Years (FY) 2022-2026</u> to accomplish HUD's mission and vision. Each of the five goals in the <u>Strategic Plan</u> include what HUD hopes to accomplish, the strategies to accomplish those objectives, and the indicators of success. However, of the five goals only those applicable to this NOFO are identified below.

You are expected to align your application to the applicable strategic goals and objectives below. Use the information in this section to describe in your application the specific goals, objectives, and measures that your project is expected to help accomplish. If your project is selected for funding, you are also expected to establish a plan to track progress related to those goals, objectives, and measures. HUD will monitor compliance with the goals, objectives, and measures in your project.

Applicable Goals and Objectives from HUD's Strategic Plan

1. 2B: Improve Rental Assistance

Improve rental assistance to address the need for affordable housing.

2. Strategic Goal 4: Advance Sustainable Communities

Advance sustainable communities by strengthening climate resilience and energy efficiency, promoting environmental justice, and recognizing housing's role as essential to health.

3. 4A: Guide Investment in Climate Resilience

Invest in climate resilience, energy efficiency, and renewable energy across HUD programs.

4. 4B: Strengthen Environmental Justice

Reduce exposure to health risks, environmental hazards, and substandard housing, especially for low-income households and communities of color.

All properties selected under this NOFO will be required to comply with the requirements in Housing Notice H 2023-05, and will make investments to achieve some or all of the following objectives:

- Lower carbon emissions and improve energy and water efficiency.
- Incorporate renewable energy use, where appropriate.
- Further climate resilience to better withstand the impacts of natural hazard events and protect residents.
- Reduce resident exposure to health risks and environmental hazards.
- Improve the quality of HUD-assisted multifamily housing for residents.
- Support long-term housing preservation through extended affordability requirements.

3. Changes from Previous NOFO

GRRP Elements NOFO Update, August 2023

- 1. Expansion of eligibility for recent Section 202/811 Capital Advance awardees
 - Edit: "An entity is an Eligible Applicant and may apply under this NOFO if it ... Is the Sponsor or owner of a property under development through the Section 202 or Section 811 Capital Advance programs and has not yet reached firm commitmentinitial closing."
 - Justification: Multifamily Production has been issuing Section 202 firm commitments contingent upon finding additional funding. The GRRP funding may be a portion of the strategy to close this gap. This language change provides

projects more flexibility with respect to when they can apply for and close a GRRP award and gives HUD a greater opportunity to green recent Capital Advance awardees.

- 2. Clarification on cost sharing
 - Edit: "This Program does not require cost sharing or matching. The Program does require that the Owner be pursuing a recapitalization transaction as described in Section III.D. Owners receiving a GRRP award will be required to cover costs of property rehabilitation that are not covered by the GRRP funding. These requirements are detailed in Housing Notice H 2023-05. Cost sharing or leverage is not a rating factor in selecting applications for participation in the program."
 - Justification: Provides additional clarity that the recapitalization transaction required in Section III.D. applies.
- 3. Addition to instructions for submitting the application materials, specifically asking for application attachments to include the iREMS reference number in the file name.
 - Edit: Add "Include the property iREMS number in all file names."
 - Justification: This change ensures that each file included in an applicant's submission is identified by property.
- 4. Clarification of the documentation required to support Better Buildings Challenge ranking status
 - Edit: "Applicants that submit their BBC Sponsor's Better Buildings Challenge partnership agreement for their portfolio the subject property."
 - Justification: The NOFO ranks applicants by their commitment to different climate initiatives. One of the categories is participation in the Better Buildings Challenge. The Better Buildings Challenge is a portfolio-wide commitment rather than a commitment at a single property. The current language is inaccurate and confuses applicants.
- 5. Shortened the grace period for uploading environmental review documents into HEROS
 - Edit: "HUD will provide the applicant 14 30 days from the NOFO due date for the applicant to submit the environmental documentation through HEROS. Failure to submit environmental documentation through HEROS by the NOFO application due date or within 14 30 days of the NOFO application due date will cause the NOFO application to be considered incomplete."
 - Justification: The NOFO expects applicants to submit their environmental review documents into the HEROS on-line portal. However, for applicants who have trouble doing so before the application due date, the NOFO permits them to submit PDFs of their environmental review documents provided they upload the documents to HEROS within a grace period after the application deadline. Currently, the grace period is 30 days, which has the potential to cause unnecessary delays in the application review process. Two weeks is a more reasonable grace period, balancing leniency for applicants that have trouble getting access to HEROS or uploading the documents into HEROS with the need for rapid application reviews.

- 6. Addition of IEER specification for heat pumps in the menu of acceptable Elements investments
 - Edit: "Electric air source or ground source heat pumps rated at least 18 SEER, or 18 HSPF, or 22.5 IEER."
 - Justification: The Elements NOFO specifies investments that GRRP will fund, and the amount of funding provided. Heat pumps are currently in the list and will remain so. Currently, only two measures of efficiency are listed – SEER or HSPF. Heat pumps above 65,000 BTU/hour have their efficiency measured in IEER rather than SEER or HSPF. The 22.5 IEER benchmark is roughly equivalent to 18 SEER and 18 HSPF.
- 7. Clarification of ASTM standards
 - Edits:
 - "Phase I Environmental Site Assessment (ESA) Report: The Findings, Opinions, and Conclusions sections of the Phase I ESA must be completed by an Environmental Professional in accordance with ASTM E 1527-13 for applications submitted by or before February 13th, 2024 or ASTM E 1527-21 for applications submitted after February 13th, 2023"
 - "(1) Recognized Environmental Conditions (REC), suspect REC, historical REC, and/or de minimis conditions (with all such terms as described in ASTM E 1527-13 or ASTM E1527-21 as applicable),"
 - Justification: New ASTM standards roll out early 2024 and applications should adhere to the standards in place at the time of submission.
- 8. Additional specifications for Administrative, National and Departmental Policy Requirements and Terms for HUD Applicants and Recipients of Financial Assistance Awards
 - 31. Compliance with 41 U.S.C. § 4712, which includes informing your employees in writing of their rights and remedies, in the predominant native language of the workforce. Under 41 U.S.C. § 4712, employees of a contractor, subcontractor, grantee, subgrantee, and personal services contractor may not be discharged, demoted, or otherwise discriminated against as a reprisal for disclosing information that the employee reasonably believes is evidence of gross mismanagement of a Federal contract or grant, a gross waste of Federal funds, an abuse of authority relating to a Federal contract or grant, a substantial and specific danger to public health or safety, or a violation of law, rule, or regulation related to a Federal contract (including the competition for or negotiation of a contract) or grant.  - \circ $\;$ Justification: Updated language to match current HUD requirements.

4. Definitions

a. Standard Definitions

Affirmatively Furthering Fair Housing (AFFH) means taking meaningful actions, in addition to combating discrimination to overcome patterns of segregation and foster inclusive communities free from barriers that restrict access to opportunity based on protected

characteristics. Specifically, affirmatively furthering fair housing means taking meaningful actions that, taken together, address significant disparities in housing needs and in access to opportunities, replacing segregated living patterns with truly integrated and balanced living patterns, transforming racially and ethnically concentrated areas of poverty into areas of opportunity, and fostering and maintaining compliance with civil rights and fair housing laws. The duty to affirmatively further fair housing extends to all program participant's activities and programs relating to housing and urban development.

Assistance Listing number refers to the unique number assigned to each Federal assistance program publicly available in the Assistance Listing, which is managed and administered by the General Services Administration. The Assistance Listing number was formerly known as the Catalog of Federal Domestic Assistance (CFDA) number.

Authorized Organization Representative (AOR) is a person authorized to legally bind your organization and submit applications via Grants.gov. The AOR is authorized by the E-Business Point of Contact (E-Biz POC) in the System for Award Management (see E-Biz POC definition). An AOR may include an Expanded AOR and/or a Standard AOR.

Expanded Authorized Organization Representative is a user in Grants.gov who is authorized by the E-Biz POC to perform the functions of a Standard AOR, initiate and submit applications on behalf of your organization, and is allowed to modify organization-level settings and certifications in Grants.gov.

Standard Authorized Organization Representative is a user in Grants.gov who is authorized by the E-Biz POC to initiate and submit applications in Grants.gov. A Grants.gov user with the Standard AOR role can only submit applications when they are a Participant for that workspace.

Consolidated Plan is the document submitted to HUD that serves as the comprehensive housing affordability strategy, community development plan, and submission for funding under any of the Community Planning and Development formula grant programs (e.g., CDBG, ESG, HOME, and HOPWA). This Plan is prepared in accordance with the process described in 24 CFR part 91. This plan is completed by engaging in a participatory process to assess their affordable housing and community development needs and market conditions, and to make data-driven, place-based investment decisions with funding from formula grant programs. (See 24 CFR part 91 for HUD's requirements regarding the Consolidated Plan and related Action Plan).

Contract means, for the purpose of Federal financial assistance, a legal instrument by which a recipient or subrecipient purchases property or services needed to carry out the project or program under a federal award. For additional information on contractor and subrecipient determinations, see <u>2 CFR 200.331</u>.

Contractor means an entity that receives a contract as defined above and in <u>2 CFR 200.1</u>.

Cooperative agreement has the same meaning defined at <u>2 CFR 200.1</u>.

Deficiency, with respect to the making of an application for funding, is information missing or omitted within a submitted application. Examples of deficiencies include missing documents, missing or incomplete information on a form, or some other type of unsatisfied information requirement. Depending on specific criteria, a deficiency may be either Curable or Non-Curable.

A Curable Deficiency is missing or incomplete application information that may be corrected by the applicant with timely action. To be curable, the deficiency must:

- Not be a threshold requirement, except for documentation of applicant eligibility;
- Not influence how an applicant is ranked or scored versus other applicants; and
- Be remedied within the time frame specified in the notice of deficiency.

A Non-Curable Deficiency is missing or incomplete application information that cannot be corrected by an applicant after the submission deadline. A non-curable deficiency is a deficiency that is a threshold requirement, or a deficiency that, if corrected, would change an applicant's score or rank versus other applicants. If an application includes a non-curable deficiency, the application may receive an ineligible determination, or the non-curable deficiency may otherwise adversely affect the application's score and final funding determination.

E-Business Point of Contact (E-Biz POC) is an organization applicant who is responsible for the administration and management of grant activities for his or her organization. The E-Biz POC is likely to be an organization's chief financial officer or authorizing official. The E-Biz POC authorizes representatives of their organization to apply on behalf of the organization (see Authorized Organization Representative definition). There can only be one E-Biz POC per unique entity identifier (see definition of Unique Entity Identifier below).

Eligibility requirements are mandatory requirements for an application to be eligible for funding.

Environmental Justice means investing in environmental improvements, remedying past environmental inequities, and otherwise developing, implementing, and enforcing laws and policies in a manner that advances environmental equity and provides meaningful involvement for people and communities that have been environmentally underserved or overburdened, such as Black and Brown communities, indigenous groups, and individuals with disabilities. This definition does not alter the requirements under HUD's regulations at <u>24 CFR 58.5(j)</u> and <u>24</u> <u>CFR 50.4(1)</u> implementing <u>Executive Order 12898</u>. E.O. 12898 requires a consideration of how federally assisted projects may have disproportionately high and adverse human health or environmental effects on minority and/or low-income populations. Equity has the meaning given to that term in Section 2(a) of Executive Order <u>13985</u> and means the consistent and systematic fair, just, and impartial treatment of all individuals, including individuals who belong to underserved communities that have been denied such treatment, such as Black, Latino, and Indigenous and Native American persons, Asian Americans and Pacific Islanders and other persons of color; members of religious minorities; lesbian, gay, bisexual, transgender, and queer (LGBTQ+) persons; persons with disabilities; persons who live in rural areas; and persons otherwise adversely affected by persistent poverty or inequality.

Federal Award, has the meaning, depending on the context, in either paragraphs (1) or (2) of this definition:

(1)

(a) The Federal financial assistance that a recipient receives directly from a Federal awarding agency or a subrecipient receives indirectly from a pass-through entity, as described in <u>2 CFR 200.101</u>; or

(b) The cost-reimbursement contract under the Federal Acquisition Regulations that a non-Federal entity receives directly from a federal awarding agency or indirectly from a pass- through entity, as described in 2 CFR 200.101.

(2) The instrument setting forth the terms and conditions. The instrument is the grant agreement, cooperative agreement, other agreement for assistance covered in paragraph (2) of the definitions of Federal financial assistance in <u>2 CFR 200.1</u>, and this NOFO, or the cost-reimbursement contract awarded under the Federal Acquisition Regulations.

(3) Federal award does not include other contracts that a Federal agency uses to buy goods or services from a contractor or a contract to operate Federal Government owned, contractor operated facilities (GOCOs).

(4) See also definitions of Federal financial assistance, grant agreement, and cooperative agreement in 2 CFR 200.1.

Federal Financial Assistance has the same meaning defined at <u>2 CFR 200.1</u>.

Grants.gov is the website serving as the Federal government's central portal for searching and applying for Federal financial assistance throughout the Federal government. Registration on Grants.gov is required for submission of applications to prospective agencies unless otherwise specified in this NOFO.

Historically Black Colleges and Universities (HBCUs) are any historically Black college or university that was established prior to 1964, whose principal mission was, and is, the education of Black Americans, and that is accredited by a nationally recognized accrediting agency or association determined by the Secretary of Education to be a reliable authority as to the quality of training offered or is, according to such an agency or association, making reasonable progress toward accreditation. <u>A list of accredited HBCUs can be found at the U.S. Department of Education's website</u>.

Minority-Serving Institutions (MSIs) are

- (1) a part B institution (as defined in <u>20 U.S.C. 1601</u>);
- (2) a Hispanic-serving institution (as defined in 20 U.S.C. 1101a(5));

(3) a Tribal College or University (as defined in <u>20 U.S.C. 1059c</u>);

(4) an Alaska Native-serving institution or a Native Hawaiian-serving institution (as defined in <u>20 U.S.C. 1059d(b)</u>);

(5) a Predominantly Black Institution (as defined in <u>20 U.S.C. 1059e</u>);

(6) an Asian American and Native American Pacific Islander-serving institution (as defined in $\underline{20}$ U.S.C. 1059g); or

(7) a Native American-serving nontribal institution (as defined in <u>20 U.S.C. 1059f</u>).

Non-Federal Entity (NFE) means a state, local government, Indian tribe, Institution of Higher Education (IHE), or non-profit organization that carries out a federal award as a recipient or subrecipient.

Primary Point of Contact (PPOC) is the person who may be contacted with questions about the application submitted by the AOR. The PPOC is listed in item 8F on the SF-424.

Racial Equity is the elimination of racial disparities, and is achieved when race can no longer predict opportunities, distribution of resources, or outcomes – particularly for Black and Brown persons, which includes Black, Latino, indigenous, Native American, Asian, Pacific Islander, and other persons of color.

Recipient means an entity, usually but not limited to non-Federal entities, that receives a federal award directly from HUD. The term recipient does not include subrecipients or individuals that are beneficiaries of the award.

Resilience is a community's ability to minimize damage and recover quickly from extreme events and changing conditions.

Small business is defined as a privately-owned corporation, partnership, or sole proprietorship that has fewer employees and less annual revenue than regular-sized business. The definition of "small"—in terms of being able to apply for government support and qualify for preferential tax policy—varies by country and industry. The U.S. Small Business Administration defines a small business according to a set of standards based on specific industries. See <u>13 CFR Part 121</u>.

Subaward means an award provided by a pass-through entity to a subrecipient for the subrecipient to carry out part of a federal award received by the pass-through entity. It does not include payments to a contractor or payments to an individual that is a beneficiary of a Federal program. A subaward may be provided through any form of legal agreement, including an agreement that the pass-through entity considers a contract.

Subrecipient means an entity, usually but not limited to non-Federal entities, that receives a subaward from a pass-through entity to carry out part of a federal award but does not include an individual that is a beneficiary of such award. A subrecipient may also be a recipient of other federal awards directly from a federal awarding agency.

System for Award Management (SAM) is the Federal Repository into which an entity must provide information required for the conduct of business as a recipient. As a result, the total awards may be greater or lesser than the amount listed.

B. Number of Awards

HUD expects to make approximately 200 awards from the funds available under this NOFO.

The amounts listed above represent the funds available for GRRP Grants or Surplus Cash Loans to support the green and resilient retrofits. - The owner must be current in the submission of audited or owner-certified Annual Financial Statements (AFS) for the subject property, if applicable, and must not have any outstanding findings.
- Based on its most recent AFS submission, the property either a) must not have frequent delinquencies (three or more times a year) on an FHA-insured mortgage and must not have a debt service coverage ratio less than 1.0, excluding owner contributions, or b) if a condition identified in (a) is present, the owner has submitted a plan satisfactory to HUD to resolve such condition.
- The owner must not have provided a 120-day notice of intent to opt-out of the program providing rental assistance for the subject property (see Section 8 Renewal Guide, section 11-4 G) or, if a notice has been provided, the owner must withdraw the notice and notify the tenants that the notice has been withdrawn prior to application for this program.
- The owner of a property assisted under a Section 202 Direct Loan must not have submitted a request for repayment of a Section 202 Direct Loans or, if a request has been submitted, the owner must withdraw the request.

"Received by Grants.gov" means the applicant received a confirmation of receipt and an application tracking number from Grants.gov. Grants.gov then assigns an application tracking number and date-and timestamp each application upon successful receipt by the Grants.gov system. A submission attempt not resulting in confirmation of receipt and an application tracking number is not considered received by Grants.gov.

Applications received by Grants.gov must be validated by Grants.gov to be received by HUD.

"Validated by Grants.gov" means the application has been accepted and was not rejected with errors. V. APPLICATION REVIEW INFORMATION

A. Review Criteria

There will be four application review periods for Elements Awards. All applications received before 11:59:59 PM Eastern time on 06/29/2023 shall be considered during the First Application

Period. All applications received before 11:59:59 PM Eastern time on 09/28/2023, including applications from the First Application Period that were not previously selected for funding, shall be considered during the Second Application Period. All applications received before 11:59:59 PM Eastern time on 01/04/2024, including applications from the First Application Period and the Second Application Period that were not previously selected for funding, shall be considered during the Third Application Period. All applications received before 11:59:59 PM Eastern time on 03/28/2024, including applications from the First Application Period, the Second Application Period, and the Third Application Period that were not previously selected for funding, shall be considered during the Third Application Period that were not previously selected for funding, shall be considered during the Fourth Application Period. Each such grouping is referred to below as an Application Period.

HUD shall make approximately \$35,000,000 available for applications from the First Application Period, based on using up to \$14,000,000 of available program subsidy funds. HUD shall make approximately \$35,000,000 available for applications from the Second Application Period, based on using up to \$18,000,000 of available program subsidy funds. HUD shall make approximately \$35,000,000 available for applications from the Third Application Period, based on using up to \$18,000,000 of available program subsidy funds. Any remaining funding shall be available for applications from the Fourth Application Period. Any funding remaining after the Fourth Application Period shall be available for GRRP awards under a separate NOFO.

Ranking and Selection of Applications for Elements Awards. If the applications in any Application Period request more funding than is available, eligible applications will be ranked in the following order:

- Applicants that submit a certification signed by the owner and the architect with respect to their respective areas of expertise stating that the owner has assembled financing which, in the owner's reasonable professional judgment, will be adequate when used together with an Elements Award to fully construct or rehabilitate the property according to project plans which the architect has prepared specifying construction or rehabilitation which, in the architect's reasonable professional judgment, will achieve one of the following green certifications: DOE Zero Energy Ready Home; Zero Energy Ready Multifamily; National Green Building Standard Silver, Gold, or Emerald; LEED V4.1; Enterprise Green Communities Plus, Greenpoint Gold or Platinum; Earthcraft Gold or Platinum; Passive House; International Living Institute; Well Building Standard; RELi; or FORTIFIED Silver or Gold.
- Applicants that submit a certification from the project's architect that the property currently uses gas or oil for heat, hot water, or appliances in the residential units, but if rehabilitated according to plans and specifications, will be fully electrified at completion of the rehabilitation or construction.
- Applicants that submit their BCC Sponsor's Better Climate Challenge partnership agreement for their portfolio.
- Properties that are located in a Priority Energy Community. <u>https://energycommunities.gov/priority-energy-communities/</u>
- Applicants that submit their BBC Sponsor's Better Buildings Challenge partnership agreement for their portfolio.
- All other eligible applications.

Within each ranking category, properties will be ranked by the lowest amount of requested award per HUD-assisted unit. In the event of a tie in the requested award per HUD-assisted unit properties will be ranked by highest proposed rehabilitation costs per assisted unit.

By way of illustration, consider a scenario where eligible applications from the First Application Period achieving a green certification request funding that, in total, represents \$10,000,000 in available subsidy while applicants pursuing electrification request a total of \$14,000,000 in available subsidy. This is a total of \$24,000,000, which is greater than the amount of subsidy available in the First Application Period. In this case, HUD would first fund the requests of all applicants achieving a green certification. It would next rank applicants pursuing electrification, ranking those applicants first who requested the lowest amount of award funding per assisted unit. If there are any remaining ties, properties would be ranked by highest proposed rehabilitation costs per assisted unit. HUD would fund properties in rank order, pending set-asides as described below, until all the funds for the First Application Period are used.

Within each Application Period, HUD will rank properties as described above and select eligible properties for award in rank order provided that HUD will skip over properties as necessary to meet the following set-aside criteria to ensure diversity among HUD regions, between metropolitan and non-metropolitan areas, and among affiliated applicants:

- At least 5% of properties awarded shall be in each of the 10 HUD regions.
- At least 15% of properties awarded shall be in non-metropolitan areas based on county categorization using HUD's Metropolitan Area Look-Up Tool found at https://www.huduser.gov/portal/datasets/geotool/select_Geography.odn.

VI. AWARD ADMINISTRATION INFORMATION

A. Award Notices

Following the evaluation process, HUD will notify successful applicants of their selection for funding. HUD will also notify other applicants, whose applications were received by the deadline but were not chosen for award. Notifications will be sent by email to the person listed as the AOR in item 21 of the SF-424.

1. Final Grant

After HUD has made selections, HUD will finalize specific terms of the award and budget in consultation with the selected applicant. If HUD and the selected applicant do not finalize the terms and conditions of the award in a timely manner, or the selected applicant fails to provide requested information, an award will not be made to that applicant. In this case, HUD may select another eligible applicant. HUD may also impose specific conditions on an award as provided under <u>2 CFR 200.208</u>.

2. Adjustments to Funding

To ensure the fair distribution of funds and enable the purposes or requirements of a specific program to be met, HUD reserves the right to fund less than the amount requested in an application.

a. HUD may fund no portion of an application that:

- (1) Is ineligible for funding under applicable statutory or regulatory requirements;
- (2) Fails, in whole or in part, to meet the requirements of this notice;
- (3) Duplicates activities funded by other federal awards; or
- (4) Duplicates activities funded in a prior year.

b. HUD may adjust the funding for an application to ensure funding diversity, geographic diversity, and alignment with HUD administrative priorities.

c. If an applicant turns down an award offer, or if HUD and an applicant do not finalize the terms and conditions of the award in a timely manner, HUD may withdraw the award offer and make an offer of funding to another eligible application.

d. If funds remain after all selections have been made, remaining funds may be made available within the current fiscal year for other competitions within the program area, or be held for future competitions (if allowable in accordance with the applicable appropriation or authorizing statute), or be used as otherwise provided by authorizing statute or appropriation.

e. If, after announcement of awards made under the current NOFO, additional funds become available either through the current appropriations, a supplemental appropriation, other appropriations or recapture of funds, HUD may, in accordance with the appropriation, use the additional funds to provide additional funding to an applicant awarded less than the requested amount of funds to make the full award, and/or to fund additional applicants that were eligible to receive an award but for which there were no funds available.

3. Funding Errors

4. Nature of Awards. The Applicant shall indicate in the application the form in which the award shall be provided, which may include, without limitation, a grant or a loan repayable by a share of the property's surplus cash, with the options, timing, and method for determining the nature of the award as set forth in Housing Notice H 2023-05.

5. Confirmation of Amount and Nature of Awards. Applicants selected for an award under this NOFO will receive a commitment letter with a funding award based on the eligible green and resilient elements that the owner is pursuing and HUD's determination that the funding is necessary to implement the elements into the property's recapitalization. After award, with HUD approval, the owner may pursue alternative elements included in Appendix III without exceeding the overall award amount.

6. Grants to reimburse owners for eligible costs associated with benchmarking of selected properties. Pursuant to Housing Notice H 2023-05, selected properties will be required to submit benchmarking data into EPA's Portfolio Manager and make that data available to HUD. At HUD's discretion, HUD may either provide direct support to the owner to secure and input benchmarking data or offer reimbursement to the owner of certain costs of utility benchmarking, up to \$2,500 per property conditioned on the data meeting the standards in Appendix II. HUD will provide each selected applicant instruction within the Award Letter.

Environmental Review

Compliance with environmental requirements, including regulations at 24 CFR part 50 or 58:

This program is subject to the National Environmental Policy Act of 1969 (NEPA) and related Federal environmental authorities and regulations at 24 CFR part 50.

Properties selected under this NOFO will be subject to an Environmental Review under Part 50 and will be required to submit environmental documents as outlined in Housing Notice H 2023-05. HUD will not finalize an award of funds if the project plan does not meet the environmental review requirements described in Housing Notice H 2023-05.

Once an awardee has applied under this NOFO for a specific project, they may not make any choice limiting actions before the completion of the environmental review. A choice limiting action means an action that may have an adverse impact on the environment or limit the choice of reasonable alternatives. A choice limiting action may include, but is not limited to, real property acquisition, demolition, disposition, rehabilitation, repair, new construction, site preparation or clearance, ground disturbance beyond minimal soil borings, and leasing.

As part of a review of an application under this NOFO, HUD will perform a preliminary environmental screen to assess major adverse environmental conditions. To complete this preliminary environmental screen, HUD requires all applicants to submit the environmental documentation listed below. All documentation must be submitted into the HUD Environmental Review Online System (HEROS). All documents submitted into HEROS must be prepared by an environmental consultant with prior HEROS experience and HEROS access. Please note that HEROS is operational between the hours of 7:00 AM to Midnight Eastern Time, Monday through Saturday. Users will not be able to log in outside of those times/days.

After the HEROS submission is complete, assign it in the system to Kara Williams-Kief, <u>kara.s.williams-kief@hud.gov</u>. Applicants must provide a reference to the Project Name in HEROS, HEROS submitter name, and HEROS submitter email address in the application form.

For new HEROS users, please allow up to 2-3 weeks for your access to be processed. In the event that an applicant is unable to submit environmental documents through HEROS at the time of submission of their NOFO application, the applicant must still provide the required documents as a separate PDF with their application. HUD will provide the applicant 14 days from the NOFO due date for the applicant to submit the environmental documentation through HEROS. Failure to submit environmental documentation through HEROS by the NOFO application due date or within 14 days of the NOFO application due date will cause the NOFO application to be considered incomplete.

The purpose of HUD's preliminary environmental screen at the application processing stage is to identify any adverse environmental conditions that cannot reasonably be mitigated. It does not constitute HUD's environmental approval of the property site. Any adverse environmental conditions that cannot reasonably be mitigated will result in the rejection of the application. Examples of such occurrences would be a project that proposes a Risk Based Corrective Action Plan or Complete Clean Up Plan, but lacks likely approval of such by the relevant regulatory authority; a project that would result in destruction of a valuable wetland; a property located in a Superfund area without an EPA comfort letter; a property located in a flood channel/floodway; or a project for which a noise barrier to reduce noise to acceptable levels appears to be necessary but is not proposed in the application and/or does not appear to be achievable.

The following environmental documentation is required to be submitted via HEROS:

a. Preliminary HEROS submission, including Related Laws and Authorities as identified below. Applicants must complete the following screens in HEROS:

b. Phase I Environmental Site Assessment (ESA) Report: The Findings, Opinions, and Conclusions sections of the Phase I ESA must be completed by an Environmental Professional in accordance with ASTM E 1527-13 for applications submitted by or before February 13th, 2024 or ASTM E 1527-21 for applications submitted after February 13th, 2024. (ASTM standards cited in this NOFO are available for a fee through <u>https://www.astm.org/</u>.) The Findings section shall list and discuss all:

(1) Recognized Environmental Conditions (REC), suspect REC, historical REC, and/or de minimis conditions (with all such terms as described in ASTM E 1527-13 or ASTM E 1527-21, as applicable), and

(2) Vapor Encroachment Conditions (VEC), suspected VEC, or instances where VEC cannot be ruled out (pursuant to ASTM E 2600-15). The opinions section shall discuss each of these conditions as to whether each one is deemed to be or deemed not to be a REC and/or a VEC. Applicants are cautioned that even if the environmental preparer (EP) who prepares the Phase I ESA determines that there are no RECs and no VECs and you therefore decide not to prepare a Phase II ESA (see below), HUD will review the Phase I ESA report to confirm that such determinations are reasonably warranted based on the information presented. Should HUD not concur with the Phase I ESA conclusions and should Phase II not be conducted nor the Phase II clean-up plan or equivalent submitted, your application will be rejected.

The applicant must inform the EP of the HUD requirements that must be included in the Phase I ESA and any required subsequent report such as a Phase II. These requirements are described in greater detail in Section 9.4 of the <u>MAP Guide</u>.

A previous Phase I ESA report will be allowed provided that the Phase I ESA was conducted within 180 days of the application deadline date and the report meets the above referenced MAP Guide requirements.

c. Phase II ESA. If the Phase I ESA indicates the need for further study or identifies any type of contamination or other issues, then a Phase II ESA is required. The Phase II ESA must address all RECs and VECs identified in the Phase I ESA report. The testing and sampling design shall be based on scientific methodology and shall proceed to the point that a reasonable determination can be made regarding each of the RECs and VECs.

d. Phase III Clean-Up Plan. A clean-up plan is required if the Phase II ESA determines that hazardous waste, petroleum products, or VECs exist on the site or hazardous waste, petroleum products or VECs have migrated onto the site or are likely to do so in the foreseeable future. If the Phase II ESA determines that a Phase III Clean-Up Plan or equivalent is required, then a report is required to be submitted following the requirements of Section 9.4 of the MAP Guide. The clean-up plan must be detailed in nature and must include:

(1) An estimate of clean-up costs.

(2) A description of the plan either to:

(a) Completely clean up the site, other than for contamination that would remain solely in the ground water that is at least 25 feet below the surface to comply with statewide, non-site-specific federal or state standards with no active or passive remediation still taking place after either final closing or initial occupancy, whichever comes first, no capping over of any contamination and no monitoring wells; or

(b) Clean up the site to federal or state Risk-Based Corrective Action ("RBCA") levels. The RBCA must allow for no active remediation (such as flushing wells or digging up and/or hauling away of contamination) to take place after either final closing or initial occupancy, whichever comes first.

(3) Either an approval letter of the clean-up plan from the relevant federal or state authority or a discussion of the feasibility of securing necessary approvals prior to HUD's completion of the environmental review.

(4) A discussion of the feasibility of completing necessary work prior to final closing or initial occupancy, whichever comes first.

NOTE: Following selection to participate, HUD will require a final clean-up plan. The final clean-up plan must include a remediation contract that specifies all clean-up costs and timelines for clean-up to ensure that it is completed prior to final closing or initial occupancy, whichever comes first, and approved documentation from the relevant regulatory authority. Furthermore, the final clean-up plan will be required to meet specific HUD criteria as outlined in the MAP Guide, Chapter 9 (see

<u>https://www.hud.gov/sites/dfiles/OCHCO/documents/4430GHSGG.pdf</u>), which Chapter as it may be amended from time to time is incorporated into this section by reference.

e. Post-Award. As HUD only performs a preliminary environmental screen at the application processing stage, site approval will not occur until after an award under this NOFO is made, HUD completes its environmental review, and HUD finds the site environmentally acceptable, all of which must be completed prior to closing on the award. All GRRP commitment letters will incorporate the recipient's responsibilities under this section, and will stipulate 1) that a GRRP award constitutes preliminary approval of an application; 2) that a GRRP award does not constitute an approval of the site, which may occur only upon completion of HUD's environmental review; and 3) that if HUD finds the site acceptable but only with mitigation and the applicant cannot meet the mitigation requirements, or if HUD determines that even with mitigation the site is unacceptable, the GRRP commitment letter will be terminated. Therefore, it is extremely important that applicants evaluate the site prior to application submission to ensure that it meets HUD's environmental requirements. In accordance with 24 CFR 50.3(h), the applicant's submission of an application constitutes an assurance that the applicant agrees to assist HUD with HUD's compliance with environmental review regulations in 24 CFR part 50 and that the applicant shall:

1. Supply HUD with all available and relevant information necessary for HUD to perform any environmental review required by 24 CFR part 50. HUD will require all award recipients to input any additional requested information into HEROS. Please note that if an application is selected for funding, HUD will require information about additional

laws and authorities for all projects and information about Environmental Assessment factors for new construction and substantial rehabilitation projects;

- 2. Carry out mitigating measures required by HUD or select alternate eligible property; and
- 3. Not acquire, rehabilitate, convert, demolish, lease, repair, or construct property, nor commit or expend HUD or local funds for these program activities with respect to any eligible property until HUD approval of the site is received.

Applicants may continue to perform obligations to sustain an existing leasehold or option to lease agreement. HUD will complete an environmental review under part 50 following the guidance set forth in the MAP Guide. As part of this process, HUD will determine the correct level of environmental review (for example, categorically excluded or environmental assessment).

When HUD continues its environmental review, it may find the site environmentally unacceptable, in which case the funding award may be cancelled. Applicants must be in compliance with the National Environmental Policy Act of 1969 ("NEPA") (42 U.S.C. 4321) and applicable related environmental authorities at 24 CFR 50.3(i) and 24 CFR 50.4, HUD's implementing regulations at 24 CFR part 50 and (where applicable) 24 CFR 891.155(b), especially, but not limited to the provisions of information to HUD at 24 CFR 50.31(b). Applicants must also comply with any environmental "conditions and safeguards" at 24 CFR 50.3(c).

Prohibition on Surveillance

Compliance with <u>2 CFR 200.216</u>, <u>Prohibition on Certain Telecommunication and Video</u> <u>Surveillance Services or Equipment</u> is required.

Remedies for Noncompliance

HUD may terminate a Federal award, in whole or in part, for any of the reasons specified in <u>2</u> <u>CFR 200.340</u>, <u>Termination</u>.

Remedies for noncompliance are detailed in Housing Notice H 2023-05.

Lead-Based Paint Requirements

When providing housing assistance funding for purchase, lease, support services, operation, or work that may disturb painted surfaces, of pre-1978 housing, you must comply with the lead-based paint evaluation and hazard reduction requirements of HUD's lead-based paint rules (Lead Disclosure; and Lead Safe Housing (24 CFR part 35)); and EPA's lead-based paint rules (e.g., Repair, Renovation and Painting; Pre-Renovation Education; and Lead Training and Certification (40 CFR part 745)).

C. Reporting

Requirements under this Award Term include filing subaward information in the Federal Funding Accountability and Transparency Act (FFATA) Sub-award Reporting System (FSRS.gov) by the end of the month following the month in which the recipient awards any sub-grant equal to or greater than \$30,000.

4. Program-Specific Reporting Requirements

Specific reporting requirements are detailed in Housing Notice H 2023-05.

D. Debriefing

For a period of at least 120 calendar days, beginning 30 calendar days after the public announcement of awards under this NOFO, HUD will provide a debriefing related to their application to requesting applicants. A request for debriefing must be made in writing or by email by the AOR whose signature appears on the SF-424 or by his or her successor in office and be submitted to the POC in Section VII Agency Contact(s) of this NOFO. Information provided during a debriefing may include the final score the applicant received for each rating factor, final evaluator comments for each rating factor, and the final assessment indicating the basis upon which funding was approved or denied.

APPENDIX I: HUD's Guidance for Preparing a Budget Request and Narrative

To fill out the budget information requested on the SF-424A, review the general instructions provided for the SF-424A and follow the instructions outlined below. The budget reported on SF-424A must include a yearly breakdown of costs for the entire project period. Specifically, the budget reported on SF-424A should provide a detailed cost breakdown for each line item outlined in the SF-424A by year, including a breakdown of costs for each activity/cost within the line item. The budget must separate out funding that is administered direct the applicant from any funding that will be subcontracted.

SF-424A Instructions

Section A – Budget Summary

- Grant Program Function or Activity (column a) = grant activity means the type of financial assistance expected under this NOFO: 1) grant/cooperative agreement; 2) non-cash contribution or donation of property; 3) direct appropriation; 4) food commodity; 5) other assistance, including: loan, loan guarantee, interest subsidy, and insurance.
- New or Revised Budget, Federal (column e) = Enter the Total Federal Budget Requested by grant activity for the project period, in rows 1 through 4. In row 5, reflect the sum of the amount for the Federal Total.
- New or Revised Budget, Non-Federal (column f) = Enter Total Amount of any Non-Federal Funds Contributed (if applicable), by grant activity for the project period, in rows 1 through 4. In row 5, reflect the sum of the amount for the Non-Federal Total.
- New or Revised Budget, Total (column g) = Enter Total Budget Proposed by grant activity for the project period in rows 1 through 4. In row 5, reflect the sum of the amount for the Federal and Non-Federal Totals.

Section B - Budget Categories

- Enter the total costs requested for each Object Class Category (Section B, number 6) for all years of the total project period.
- If the class categories are not known at the time of application, include the expected budget under row h.

• Unless the program section of the NOFO indicates otherwise, if indirect charges are expected and included on the form, the charges must be calculated based on either the federal-approved negotiated indirect cost rate, or the 10 percent de minimis rate, as allowed by <u>2 CFR 200.414</u>.

Section D – Forecasted Cash Needed

• Enter each quarter in the first year of the project period, enter the cash needs anticipated.

Section E - Budget Estimates of Federal Funds Needed for Balance of the Project

- Column (b)First = Enter the total federal funds needed for the second year of the project period, for each grant activity. Reflect the sum of funds from all activities for the second year in row 20.
- Column (c)Second = Enter the total federal funds needed for the third year of the project period, for each grant activity. Reflect the sum of funds from all activities for the third year in row 20.
- Column (d)Third = Enter the total federal funds needed for the fourth year of the project period, for each grant activity. Reflect the sum of funds from all activities for the fourth year in row 20.
- Column (e)Fourth = Enter the total federal funds needed for the second year of the project period, for each grant activity. Reflect the sum of funds from all activities for the second in row 20.
- If the NOFO is for a period longer than five years, complete a second SF-424A form and upload it as an attachment to the application (this specific attachment will not be counted towards the page limit). Year 6 information should be included in column (b)First of Section E. Then enter the total for years 1-5 (per the first SF-424A form) in column (c)Second of Section E. The second SF-424A form will compute columns (b) and (c), reflecting total costs for the entire project period. This total should be consistent with the total Federal costs requested on the SF-424, Application for Federal Assistance. APPENDIX II: Minimum Standards for Benchmarking Data Entered Into EPA's Portfolio Manager

Following selection, HUD may either provide direct support to the owner to secure and input benchmarking data or offer reimbursement to owner. In order for the benchmarking data to be acceptable for the owner to be eligible to receive an award to reimburse certain costs associated with benchmarking, pursuant to Section 30002(a)(4) of the IRA, the data must meet the minimum standards listed in this Appendix. Benchmarking shall use EPA's Portfolio Manager and shall report water, energy, and emissions data.

How to benchmark when using Portfolio Manager:

Applicants should follow the <u>Multifamily Utility Benchmarking Toolkit Utility Benchmarking</u> <u>Step-by-Step guide</u> available on HUD Exchange. Owners are encouraged to review the guide thoroughly. Resources linked in the guide and those on the <u>www.hud.gov/grrp</u> are available for applicant use but are not required. Note that all benchmarking for purposes of the GRRP application should occur at the property-level, not the building- or portfolio-level. If the property contains multiple buildings, follow EPA guidance for <u>benchmarking a campus</u> with the address used on the GRRP application as the "parent property" and each other building added as a "child property" under the "parent property" (see EPA guidance for <u>How to Benchmark and Campus</u> in Portfolio Manager for additional information).

Owners may conduct benchmarking themselves, or, alternatively, they may hire a qualified energy professional (defined below) to conduct benchmarking on their behalf. Those owners that would like to hire a qualified professional for benchmarking may use <u>Energy Star's Service and</u> <u>Product Provider</u> list, though using the list is not required nor are providers on this list preferred. Any party conducting benchmarking (owners or hired energy professionals) must follow the method and data requirements detailed below.

Owners should start by understanding which method they will use of those listed under "Step 2: Collect Utility Data" of the Multifamily Utility Benchmarking Toolkit Utility Benchmarking Step-by-Step guide. **Applicants or the professional hired to carry out these activities are required to use the first listed method that is available to them**. For example, if the applicant can acquire aggregated, whole-property utility data from their utility provider(s), the applicant must use Method B, rather than Methods C or D. See the benchmarking guide, Step 2 for more detail on each method. Owners may also choose to install monitoring meters to streamline future benchmarking.

- Method A: Properties with Only Owner-Paid Utility Bills The property owner pays for 100% of the property's utility bills and uses these bills as the source for whole-property utility data.
- Method B: Aggregated, Whole-Property Utility Data Regardless of the split of owner-paid and tenant-paid utility bills, the property owner requests aggregated, whole-property utility data from the utility provider(s).
 - Applicants should reference <u>EPA's map of utility providers</u>, <u>Utilities Providing</u> <u>Energy Data for Benchmarking</u> fact sheet, or <u>List of Utilities Offering Web</u> <u>Services</u>, and HUD's <u>Multifamily Utility Data Collection Database</u> for information about utilities that offer whole-property data. Even if the resources do not indicate that the utility provides aggregated data, applicants should contact their provider(s) to ask if the data is available before moving to Method C.
- Method C: Collection of 100% of Tenant-Paid Utility Data The property owner collects 100% of the individual tenant-paid utility data from the utility provider(s) or tenants.
 - Most utility providers require a signed release form before providing tenant-paid utility data.
 - $\circ\,$ Owners may rely on releases and/or data previously collected for required utility allowance analysis.
 - Owners may provide incentives to tenants for utility release forms or to provide a copy of utility bills, but they cannot use any IRA funds for this purpose, nor can owners withhold services as a negative incentive.
- Method D: Collection of a Sample of Tenant-Paid Utility Data The property owner collects a sample of individual tenant-paid utility data from the utility provider(s) or tenants, which is then used to produce an estimate of whole-property utility data.

- If using Method D, applicants **must follow the Tier 2 sampling methodology** outlined in the <u>Utility Benchmarking</u> guide. Applicants may use the <u>Tenant-Paid</u> <u>Utility Data Sampling Calculator</u> and the Tier 2 sampling protocol to identify the sample required at their property.
- Most utility providers require a signed release form before providing tenant-paid utility data.
- Owners may rely on releases and/or data previously collected for required utility allowance analysis.
- Owners may provide incentives to tenants for utility release forms or to provide a copy of utility bills, but they cannot use any IRA funds for this purpose, nor can owners withhold services as a negative incentive.

Applicants (or the professional hired to carry out these activities) may enter data into Portfolio Manager using any of the three options detailed in the <u>Utility Benchmarking Step-by-Step guide</u>: manual entry, spreadsheet upload, or web services. Those using collection Method D (sampled tenant-paid utility data) will need to account for missing data by computing the average utility consumption and cost for each utility and unit type, then multiplying each computed average by the number of units of that type and summing across unit and utility types. Please refer to the benchmarking guide, step 4 for more detail and examples of this process.

After entering data and receiving an Energy Star[®] score (if property has at least 20 units), owners must get their data verified and Statement of Energy Performance (SEP) signed by an energy professional. Owners may choose to consult <u>Energy Star's Service and Product Provider</u> list and/or provided resources on the <u>www.hud.gov/grrp</u> to find a verifier, but use of these resources is not required.

The MAP Guide defines "energy professional" as follows: Registered Architects or licensed professional engineers (PE) may serve as energy professionals provided that they have demonstrated the requisite experience. Other professional certifications for qualified energy professionals include one or more of the following: a) American Energy Engineers Association's Certified Energy Manager (CEM) or Certified Energy Auditor (CEA) designations; b) American Society of Heating, Refrigerating and Air Conditioning Engineers (ASHRAE) High Performance Building Design Professional (HPBDP) designation; c) Building Performance Institute (BPI) Multifamily Building Analyst (MFBA) designation; or d) for townhouses and buildings up to three stories with no common space, a Residential Energy Services Network (RESNET) Home Energy Rating System (HERS) Rater. When building energy modeling is employed the lead modeler or energy professional must hold a professional certification specific to simulation modeling: ASHRAE Building Energy Modeling Professional (BEMP) or Association of Energy Engineers Building Energy Simulation Analyst (BESA).

Data requirements:

Applicants or the professional entering the information on their behalf are required to enter at least the following information into Portfolio Manager:

- Property name
- Property address (must match address used in GRRP application)
- Total gross floor area of property
- Year built

- Occupancy
- Number of buildings
- 12 consecutive months of energy data (see details below)
- 12 months of water consumption data
- Total number of residential living units
- Number of residential living units in a low-rise setting (1-4 stories)
- Number of residential living units in a mid-rise setting (5-9 stories)
- Number of residential living units in a high-rise setting (10 or more stories)
- Number of bedrooms

For purposes of GRRP application, energy data used for benchmarking must meet the minimum standards of data used for HUD utility allowance analysis, be less than three years old (benchmarking Year Ending Date must be no earlier than three years before application due date), and be collected after the last significant retrofit action that would have impacted the property's energy efficiency. A significant retrofit action impacting a property's energy efficiency is defined as one of the following:

- Change of 25% or more to the building's square footage,
- Large-scale window replacement (with improved window types such as double pane),
- Updates to wall or roof insulation, or
- Replacement of the heating, ventilation, and air conditioning (HVAC) equipment.

Reimbursement Requirements:

Owners applying to GRRP will be eligible to receive a reimbursement for certain costs associated with benchmarking up to \$2,500 per property. Eligible benchmarking expenses include:

- Hiring a third-party energy professional to conduct benchmarking and to verify inputted data; or
- Owner and/or staff time spent benchmarking and hiring a third-party energy professional to verify inputted data; or
- Owner and/or staff time spent benchmarking, hiring a third-party to conduct tenant sampling, and hiring a third-party energy professional to verify inputted data.

To be eligible for a reimbursement for costs associated with benchmarking properties for GRRP applications, owners must submit the following with the GRRP Application:

- Energy Star[®] Statement of Energy Performance (SEP) signed and/or stamped by a verifying professional; and
- Portfolio Manager Water Scorecard signed by a verifying professional; and either
- Receipt showing the cost for an energy professional to conduct benchmarking and verify Portfolio Manager data; or
- Documentation of owner and/or staff time spent benchmarking with a signed certification of the validity of the information and receipt showing the cost for an energy professional to verify inputted data; or

• Documentation of owner and/or staff time spent benchmarking with a signed certification of the validity of the information, a receipt showing the cost for a third-party to conduct tenant sampling, and receipt showing the cost for an energy professional to verify inputted data.

APPENDIX III: Eligible Elements Investments

The below items are the eligible investments for Elements awards. Unless otherwise noted below under Funding Limitations, all investments will be funded at the lesser of the actual costs or the award maximum. Actual costs may include cost of installation, but any General Contractor profit, overhead, or general conditions must be separately listed and meet all requirements of the Financial Thresholds included in Exhibit B of Housing Notice H 2023-05. Applicants shall identify the selected investments and associated costs in the Application Form.
