HUD's mission is to create strong, sustainable, inclusive communities and quality affordable homes for all. HUD is working to strengthen the housing market to bolster the economy and protect consumers; meet the need for quality affordable rental homes; utilize housing as a platform for improving quality of life; build inclusive and sustainable communities free from discrimination, and transform the way HUD does business.

HUD's Buffalo Field Office, located in Downtown Buffalo, is responsible for administering and monitoring HUD programs throughout 23 counties in the State of New York. The Buffalo Field Office jurisdiction includes the central and western counties of New York State with the cities of Buffalo, Rochester, Syracuse, Niagara Falls, and scores of smaller cities and villages.

The Buffalo Field Office is a full-service office, providing all of HUD's major programs: Public and Indian Housing (PIH), Community Planning and Development (CPD), Multifamily Housing, Fair Housing and Equal Opportunity (FHEO), the Office of General Counsel (OGC), and additional functions.

Lisa Pugliese also serves as the Acting Albany Field Office Director. The Albany Field Office jurisdiction contains 25 counties which includes the eastern, northern, and central counties of New York with the cities of Amsterdam, Albany, Binghamton, Glens Falls, Plattsburgh, Rome, Schenectady, Troy, Utica, Watertown, and scores of smaller cities, towns, and villages.

## OFFICE OF COMMUNITY PLANNING AND DEVELOPMENT

The **Office of Community Planning and Development (CPD)** seeks to develop viable communities by promoting integrated approaches that provide decent housing, a suitable living environment, and expand economic opportunities for low and moderate income persons. The primary means towards this end is the development of partnerships among all levels of government and the private sector, including for-profit and non-profit organizations.

CPD Programs include:

- Community Development Block Grant (CDBG) Program
- Emergency Solutions Grants (ESG) Program
- HOME Investment Partnerships Program (HOME)
- Housing Opportunities for Persons With AIDS (HOPWA) Program

Continuum of Care Program is designed to promote communitywide commitment to the goal of ending homelessness. The HUD program provides funding for local governments and nonprofit providers to quickly rehouse homeless individuals and families.

# OFFICE OF FAIR HOUSING AND EQUAL OPPORTUNITY

The **Office of Fair Housing and Equal Opportunity (FHEO)** works to eliminate housing discrimination, promote economic opportunity, and achieve diverse, inclusive communities by leading the nation in the enforcement, administration, development, and public understanding of federal fair housing policies and laws.

If you believe your rights may have been violated, we encourage you to submit a complaint with FHEO. Because there are time limits on when a complaint can be filed with HUD after an alleged violation, you should submit a complaint as soon as possible.

<u>Discrimination Complaint</u>

#### Fair Housing Assistance Program (FHAP)

Through the Fair Housing Assistance Program (FHAP), HUD funds state and local agencies that administer fair housing laws that HUD has determined to be substantially equivalent to the Fair Housing Act.

The New York State Division of Human Rights and the Westchester County Human Rights Commission are the state agencies in New York participating in FHAP.

#### Fair Housing Initiatives Program (FHIP)

Fair housing organizations and other non-profits that receive funding through the Fair Housing Initiatives Program (FHIP) assist people who believe they have been victims of housing discrimination. FHIP organizations partner with HUD to help people identify government agencies that handle complaints of housing discrimination. FHIP also has initiatives that promote fair housing laws and equal housing opportunity awareness.

#### OFFICE OF HOUSING

The **Office of Housing** oversees the Federal Housing Administration (FHA), the largest mortgage insurer in the world. HUD's Multifamily programs provide mortgage insurance to HUD-approved lenders to facilitate the construction, substantial rehabilitation, purchase and refinancing of multifamily housing projects. HUD's Single Family programs include mortgage insurance on loans to purchase new or existing homes, condominiums, manufactured housing, houses needing rehabilitation, and for reverse equity mortgages to elderly homeowners.

- Multifamily Housing
- Single Family Housing



The **Rental Assistance Demonstration Program** (RAD) allows proven financing tools to be applied to at-risk public and assisted housing under two components: RAD for PHAs and RAD for Multifamily.

#### **Housing Counseling**

HUD provides support to a nationwide network of Housing Counseling Agencies (HCA) and counselors. HCA's are trained and approved to provide tools to current and prospective homeowners, renters so that they can make responsible choices to address their housing needs in light of their financial situations.

**Multifamily Housing** supports the development, rehabilitation and maintenance of multiple-unit affordable housing through FHA mortgage insurance programs. HUD provides capital grants to nonprofits for the construction and support of affordable housing for the elderly and persons with disabilities. Multifamily Housing Programs include:

Project-Based Rental Assistance (PBRA)
Housing for Persons with Disabilities (Section 811)
Housing for the Elderly (Section 202)

**HUD Homeownership Centers** insure single family FHA mortgages, assure FHA mortgage quality, and oversee the selling of HUD homes. The <a href="Philadelphia Homeownership">Philadelphia Homeownership</a> Center (PAHOC) serves multiple states, including New York.

# OFFICE OF PUBLIC AND INDIAN HOUSING

#### The Office of Public and Indian Housing (PIH)

oversees and monitors a range of programs for low-income households. Its three major business areas include the Housing Choice Voucher (HCV) program, Public Housing program, and Native American programs.

**Public housing** was established to provide decent and safe rental housing for eligible low-income families, the elderly, and persons with disabilities. HUD administers Federal aid to local housing agencies (HAs) that manage the housing for low-income residents at rents they can afford.

Housing Choice Vouchers Program allow very low-income families to choose and lease or purchase safe, decent, and affordable privately-owned rental housing. Housing choice vouchers are administered locally by public housing agencies (PHAs). The PHAs receive federal funds from HUD to administer the voucher program.

HCV Program Vouchers and Services include:

- Family Unification Program (FUP)
  - Foster Youth to Independence (FYI) initiative
- Mainstream vouchers to assist non-elderly persons with disabilities
- <u>HUD-Veterans Affairs Supportive Housing (HUD-VASH)</u>
- Family Self-Sufficiency (FSS).
