Emergency Housing Services

Are You Homeless? Get help today, follow these easy steps to start.

- 1. **Dial 2-1-1** to find a safe place to stay, 24 hours a day, 7 days a week.
- 2. Contact the Homeless Coordinated Entry System (CES) at (401) 277-4316.
- 3. Make an appointment to meet with a CES case manager and discuss your situation and immediate needs.
- 4. **Keep your appointments and stay connected** with your case worker to help get your family to the next step for finding a permanent home.

What are Emergency Housing Vouchers?

Emergency Housing Vouchers are specifically for homeless families and individuals. Limited availability, you need a referral from Coordinated Entry Systems CES to be eligible to apply for emergency housing vouchers. Referrals made through **Coordinated Entry System at (401) 277-4316.**

The coordinated entry system is for individuals and families to receive tailored services. As part of the Coordinated Entry process, housing stabilization case managers meet with individuals and families to better understand their specific circumstances and housing or service needs. Coordinated Entry staff utilizes evidence-informed assessment tools to prioritize clients on factors such as their history of homelessness, physical or mental illness and ability to live independently. These assessments are used to determine the best resources and next steps to help the individual or family address and overcome their homelessness.

Subsidized Housing (project-based)

Subsidized Housing Developments, also known as: Low-Income Housing, Public Housing, HUD Housing, Project-Based Housing, and Tax Credit Housing. HUD and other funding providers help private apartment building owners offer reduced rents to low-income tenants. There are various HUD programs and other funding sources for this type of housing, yet they all result in the resident of the unit benefiting. Tenants are required to pay approximately 30% to 40% of their gross household income. These developments are project-based, which means that the subsidy (financial assistance) is attached to the property itself, and not the tenant.

To apply for any one of this type of unit, contact or visit the management office of each apartment building that interests you. Search for a HUD subsidized apartment. The list in this booklet provides addresses and contact information for buildings offering low-income rental units in Rhode Island.

Housing Choice Voucher (HCV)

Also known as: Section 8, Tenant-Based Rental Assistance, or Mobile Vouchers. This HUD funded program allows low-income families and individuals to rent apartments from private landlords and pay approximately 30 to 40% of their gross income for rent. This type of subsidy, is tenant-based, meaning the financial assistance is tied to the tenant rather than the property, and assistance moves with voucher holders as-long-as they remain eligible.

To apply for a Housing Choice Voucher, visit your local Public Housing Authority (PHA). Some PHAs have long voucher waiting lists, so you may want to apply at more than one PHA. To apply, visit the housing authority, or use the Rhode Island Centralized Waitlist Portal.

Multiple RI housing authorities (listed below) use and pull your housing choice voucher application from this one electronic storage place. To use the portal, applications must be completed and submitted electronically. The PORTAL is the SOLE METHOD of submitting your Centralized Application. Do not mail, fax, e-mail, or hand deliver your application, it will not be processed, you must submit it electronically.

Participating Public Housing Authorities include Bristol, Central Falls, Coventry, Cumberland, East Greenwich, East Providence, Johnston, Lincoln, Newport, North Providence, Pawtucket, Portsmouth, Rhode Island Housing, Smithfield, South Kingstown, Warren, Warwick, and Woonsocket.

PHA (HCV) Homeownership Program allows families with a housing choice voucher to buy a home and receive monthly assistance for homeownership expenses. Check with your local PHA to get more information. Many people, starting as housing choice voucher residents, have successfully purchased homes using the HCV program in Rhode Island.

What is a Public Housing Authority (PHA)?

A Public Housing Authority is a city/town agency that runs HUD's rental programs including Section 8 Vouchers and Public Housing. While HUD places certain guidelines on housing authority's operations, in practice the authorities are independently run, with their own boards, managers and varying rules and guidelines from town to town. A housing authority's day-to-day operations are overseen by an Executive Director and the staff they choose. For Public Housing or Housing Choice Voucher applications contact each PHA where you would like to live.

Rental Tips For Everyone

Tip 1: Be prepared and keep good records.

Gather and keep your family's important papers in-order. Update things as needed, like birth and marriage certificate, identification, license, pay stub, landlord reference, and more.

Tip 2: Review the lease methodically.

Carefully review all the conditions of the tenancy before you sign on the dotted line. Your lease or rental agreement may contain a provision that you find unacceptable -- for example, restrictions on guests, pets, design alterations, or running a home business. Ask questions; make sure you fully understand the lease.

Tip 3: Get everything in writing and print it out.

To avoid disputes or misunderstandings with your landlord, get everything in writing. Keep printed copies of any correspondence and follow up an oral agreement with a letter, setting out your understandings. For example, if you ask your landlord to make repairs, put your request in writing and keep a copy for yourself. If the landlord agrees orally, send a letter confirming this. Store printed records in a safe place to avoid phone and email mishaps.

Tip 4: Protect your privacy rights.

Next to disputes over rent or security deposits, one of the most common and emotion-filled misunderstandings arises over the tension between a landlord's right to enter a rental unit and a tenant's right to be left alone. If you understand your privacy rights, for example, the amount of notice your landlord must provide before entering, it will be easier to protect them.

Tip 5: Demand repairs.

Know your rights to live in a healthy rental unit. Most landlords are required to provide tenants livable premises, including adequate weatherproofing; heat, water, and electricity; and clean, sanitary, and structurally safe premises. If your rental unit is not kept in good repair, you could call the city's building inspector, who may order the landlord to make repairs, and issue code violations.

Ask the Questions!

Ask about rental **PREFERENCES!** Some housing authorities and management agencies have preferences that include residency, military service, or homelessness status.



Did your rental application get denied? ASK for an APPEAL right away to give you an opportunity to explain past credit, criminal background, or rental history problems.
