**Subject**

Extension of Temporary Approval Provisions for the Federal Housing Administration (FHA) Condominium Project Approval Process

---

**Purpose**

This Mortgagee Letter (ML) announces an extension of the temporary condominium project approval policy provisions issued in ML 2012-18 and ML 2015-27. The extension is needed to allow time for completion of the condominium project approval and rulemaking process and its subsequent implementation.

---

**Effective Date**

The requirements established in ML 2012-18 and ML 2015-27, as modified by ML 2016-15, are extended until HUD publishes and implements the Final Rule of Condominium Project Approval through publication of the Condominium Project Approval Section of HUD Handbook 4000.1.

All policy updates will be incorporated into a forthcoming update of the HUD Single Family Housing Policy Handbook 4000.1 (Handbook 4000.1).

## Mortgagee Letter 2017-13

**Background** To ensure continued condominium project eligibility for FHA-insured mortgages, the temporary approval requirements initially issued in ML 2012-18 (previously extended by MLs 2014-17 and 2016-13, and as modified by ML 2016-15) and 2015-27 (previously extended by ML 2016-13, and as modified by ML 2016-15) will be extended. On September 27, 2016, HUD published a proposed rule entitled, “Project Approval for Single-Family Condominiums.” HUD received comments to the rule and is currently evaluating those comments. This extension will allow continuance of condominium project approval until the condominium rulemaking process is completed.

**Summary of Changes** No changes have been made to the policy announced in ML 2012-18 or ML 2015-27.
