- (2) There will not be made any sale, assignment, conveyance, or any other form of transfer of this Notification, the Fund Reservation, the property or project, or any interest therein, except transfer from the Sponsor to an approved single-purpose Owner organized by the Sponsor.
- (3) The Fund Reservation will be cancelled if the Sponsor/Owner fails to have control of an approvable site within 12 months of the date of this Notification or if construction, rehabilitation or acquisition has not commenced within 18 months from the date of this Notification, unless further extensions beyond the 18 months are approved by HUD. Such extensions will be based upon HUD's determination that the Owner has established a reasonable schedule and is making sufficient progress toward the start of construction.
