2. Explanation of Material:

This handbook contains most of the current forms, legal contracts and publications for the Section 8 Rental Certificate, Rental Voucher and Moderate Rehabilitation Programs. Many of these forms were previously located in Handbooks 7420.3, Section 8 Housing Assistance Payments Program Existing Housing and Moderate Rehabilitation Processing Handbook, and Handbook 7420.7, Public Housing Agency Administrative Practices Handbook for the Section 8 Existing Program. The appendices to these handbooks which are obsolete or superseded by Handbook 7420.8 are listed in paragraph 3 of this transmittal.

Forms which are reserved in the Table of Contents are being revised and will be issued soon. The forms, legal contracts and publications contained in Handbook 7420.8 are in or will be converted to the HUD distribution system so they may be requisitioned from the HUD Field Offices.
