Recipients may ensure additional confidentiality where doing so would not be inconsistent with the requirements of the Freedom of Information Act and the Privacy Act.

Column A. Type of Match. If more than one match contribution was made within any one type of match category, repeat the match contribution code.

Column B. Source of Match. State the source of each match contribution identified in Column A (e.g. recipient, City of X, ABC Construction).

Column C. Description. Describe how each match contribution identified in Column A was used (e.g. acquisition, BMIR financing, rehabilitation).

Definitions

- A. Racial and Ethnic Group Definitions: Below are definitions of the racial and ethnic groups used in this APR. The category that most closely reflects an individual's recognition in his/her community should be used for purposes of reporting on a person of mixed racial and/or ethnic origins.
 - Alaskan Native or Native American: A person having origins in any of the original peoples of the North American Continent, who maintains cultural identification through tribal affiliations or community recognition.
 - 2. Asian or Pacific Islander: A person having origins in any of the original peoples of the Subcontinent, or the Pacific Islands. For example, the area would include China, Japan, Korea, the Philippine Islands, or Samoa.
 - 3. Black Non-Hispanic: A person having origins in any of the black racial groups of Africa, but not of Hispanic origin.
 - 4. Hispanic: A person of Mexican, Puerto Rican, Cuban, Central or South American or other Spanish culture or origin, regardless of race.
 - 5. White Non-Hispanic: A person having origins in any of the original peoples of Europe, North America, or the Middle East, but not of Hispanic origin.

B. Other Definitions:

 Program Income: Gross income earned by the recipient or cooperating entity directly generated by a grant assisted activity during the grant period (see 24 CFR 85.25). When reporting program income in the APR, the recipient should deduct income received from activities where the costs are not paid for by the HOPE 3 grant or matching contributions. Examples of program income may include fees earned for services performed and paid for with grant funds or matching contributions, such as tuition for training courses or application processing fees. Another example may include fees earned from the use or rental of real or personal property acquired with grant or matching funds. In addition, program income may include income earned from lease payments where the payments are not dedicated to an escrow account to be used for the homebuyer's mortgage.

As provided in the HOPE 3 regulations, program income under the HOPE 3 Program does not include proceeds from the sale and resale of HOPE 3 properties or interest on such proceeds. Pursuant to 24 CFR 572.135(d), any HOPE 3 program income received by the recipient may be added to the funds committed to the grant agreement by HUD and the recipient.

- 2. Sales Proceeds: Proceeds received from the sale of a HOPE 3 assisted property by the recipient (or by the recipient's designee approved by HUD) after any debt (or other applicable charges) on the property has been satisfied.
- 3. Resale Proceeds: Resale proceeds include all amounts that may not be retained by the homebuyer upon resale of HOPE 3 properties (see 24 CFR 572.130©(d)(e) and 572.135(b). Such resale proceeds initially payable to the recipient or its HUD-approved designee should be reported in the APR; under 24 CFR 571.135(b), fifty percent of such resale proceeds are required to be returned to HUD within 15 days of the resale.
- 4. Minority Business Enterprise (MBE): A business enterprise which is at least 51 percent owned by one or more minority individuals, or in the case of any publicly owned business, at least 51 percent of the voting stock which is owned by one or more minority individuals, and whose management and daily operations are controlled by one or more such individuals. "Minority individuals" include Blacks Non Hispanic Origin, Native Americans, Hispanics, and Asians or Pacific Islanders. "Control" means exercising the power to make policy decisions.
- 5. Women's Business Enterprise (WBE): A business that is at least 51 percent owned by a woman or women who also control and operate it. "Control" means exercising the power to make policy decisions. "Operate" means being actively involved in day-to-day management.
