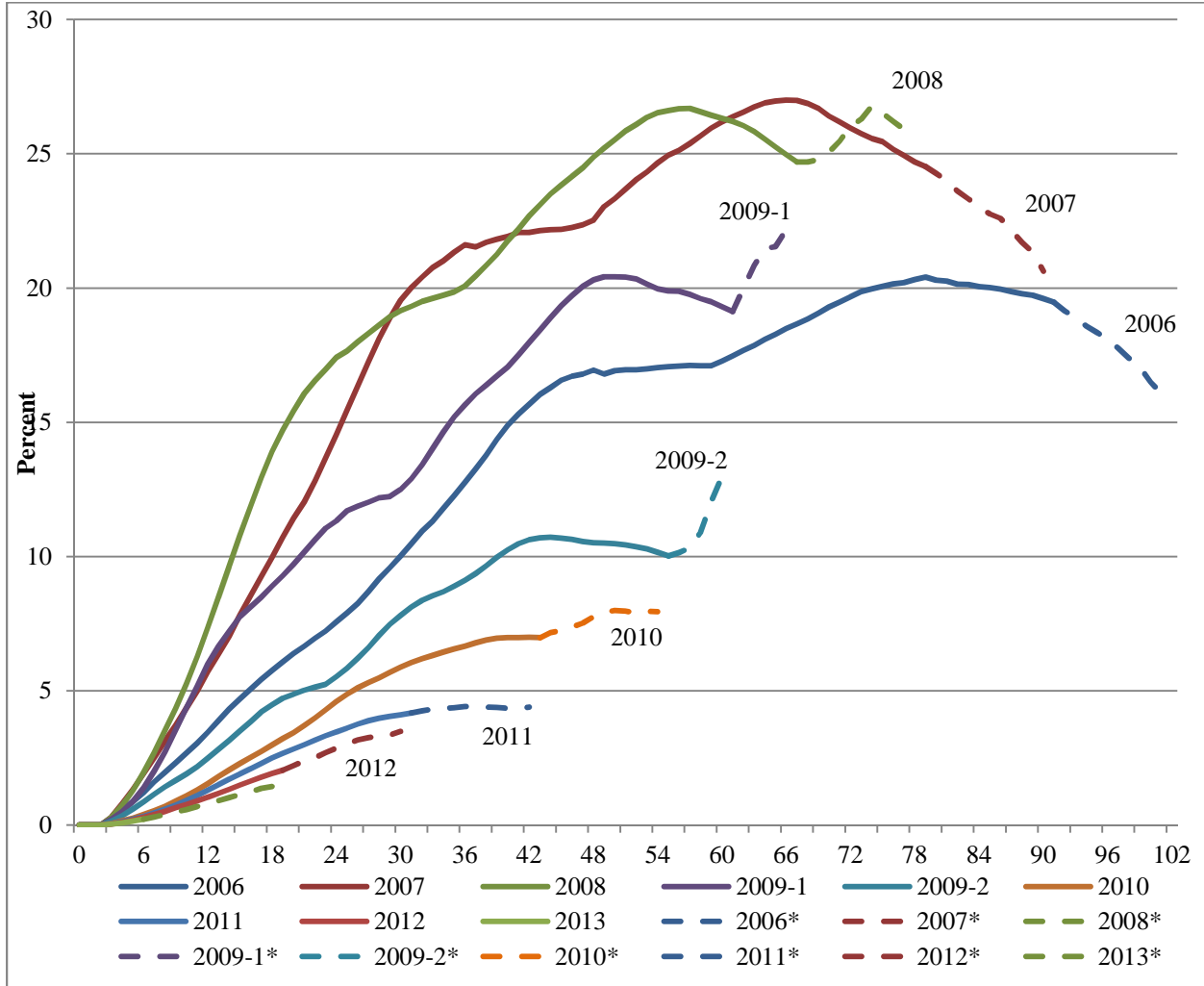

FY 2009 Shown in Two 6-month Periods^a

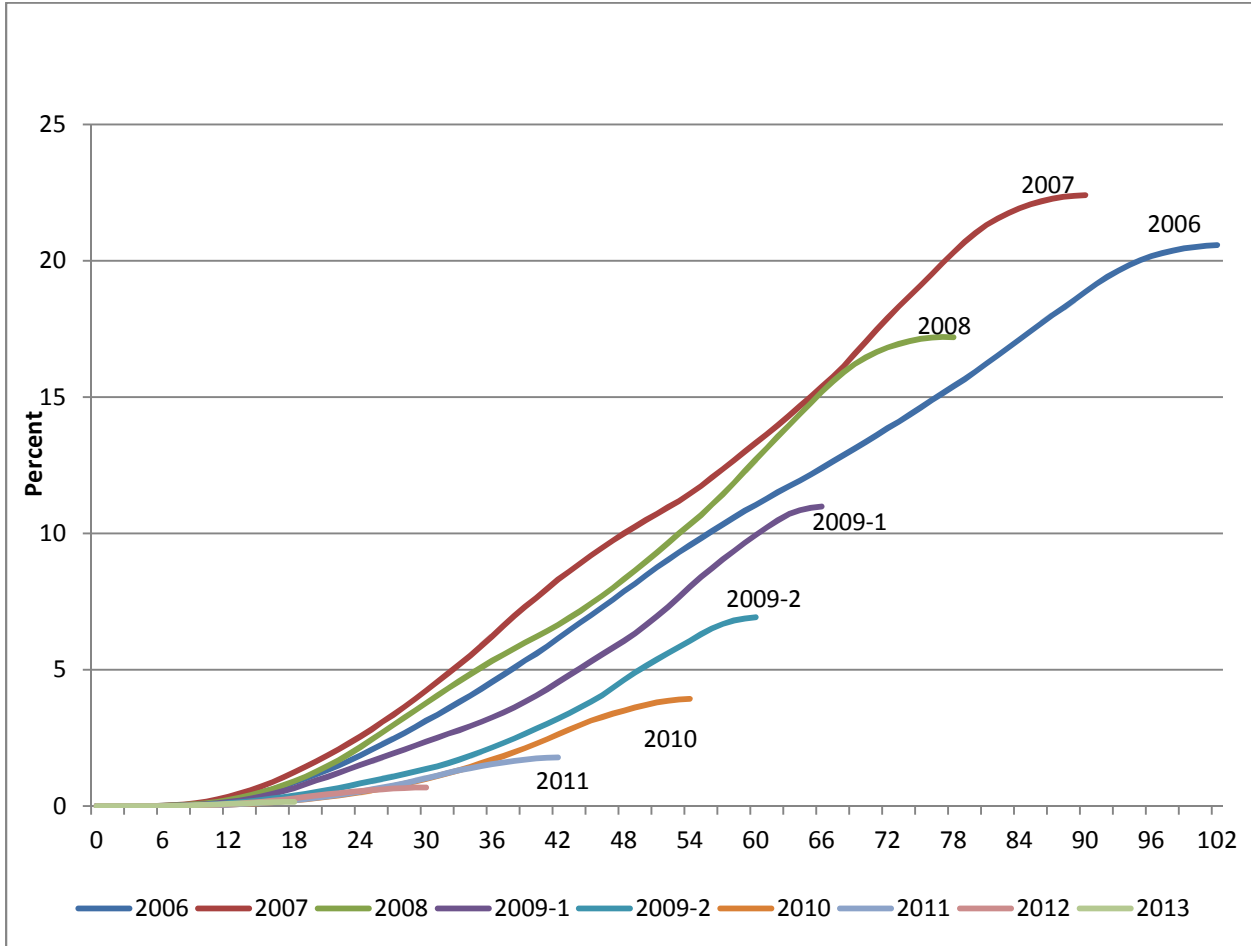
