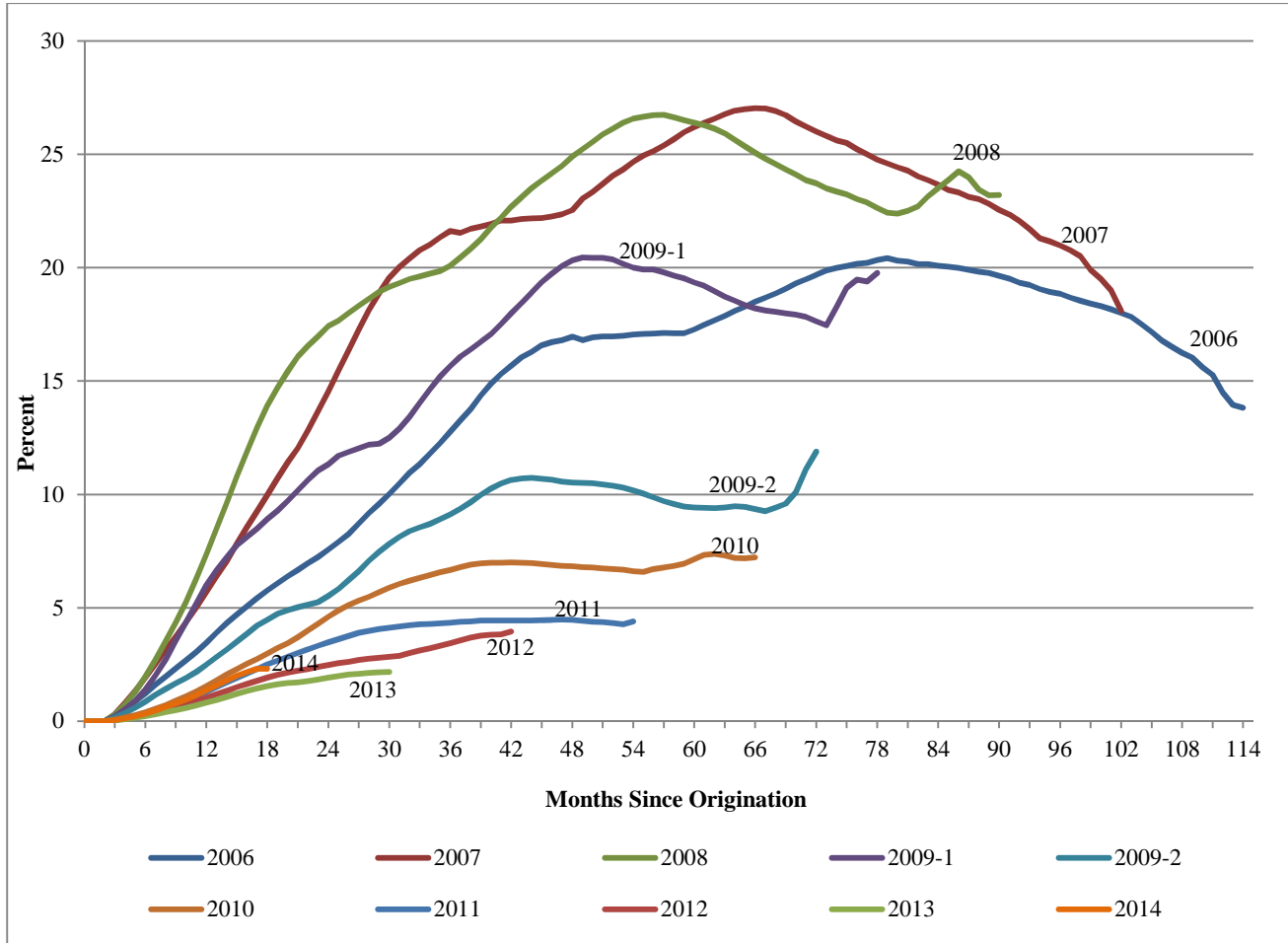

FY 2009 Shown in Two 6-month Periods <sup>a</sup>

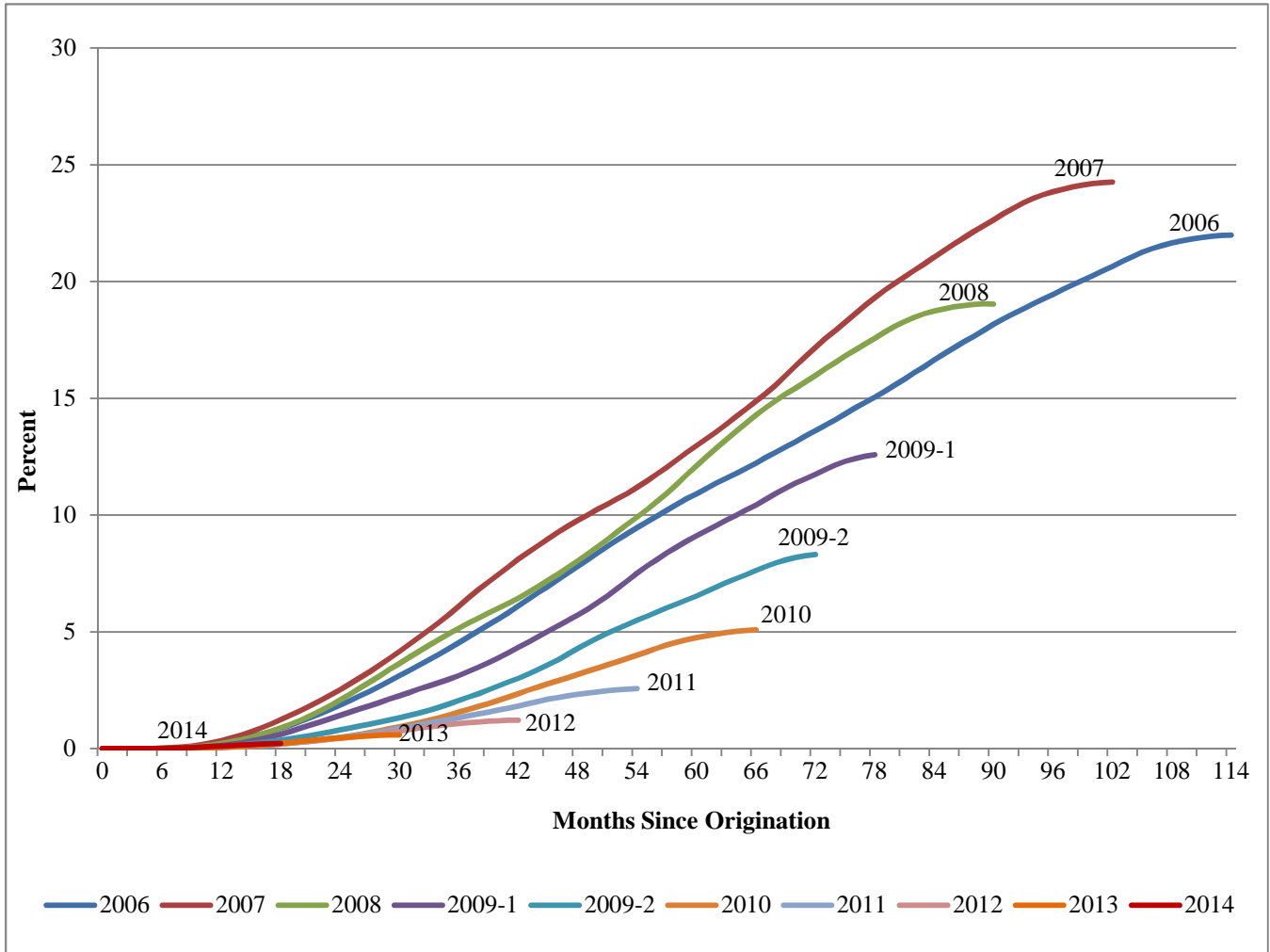
