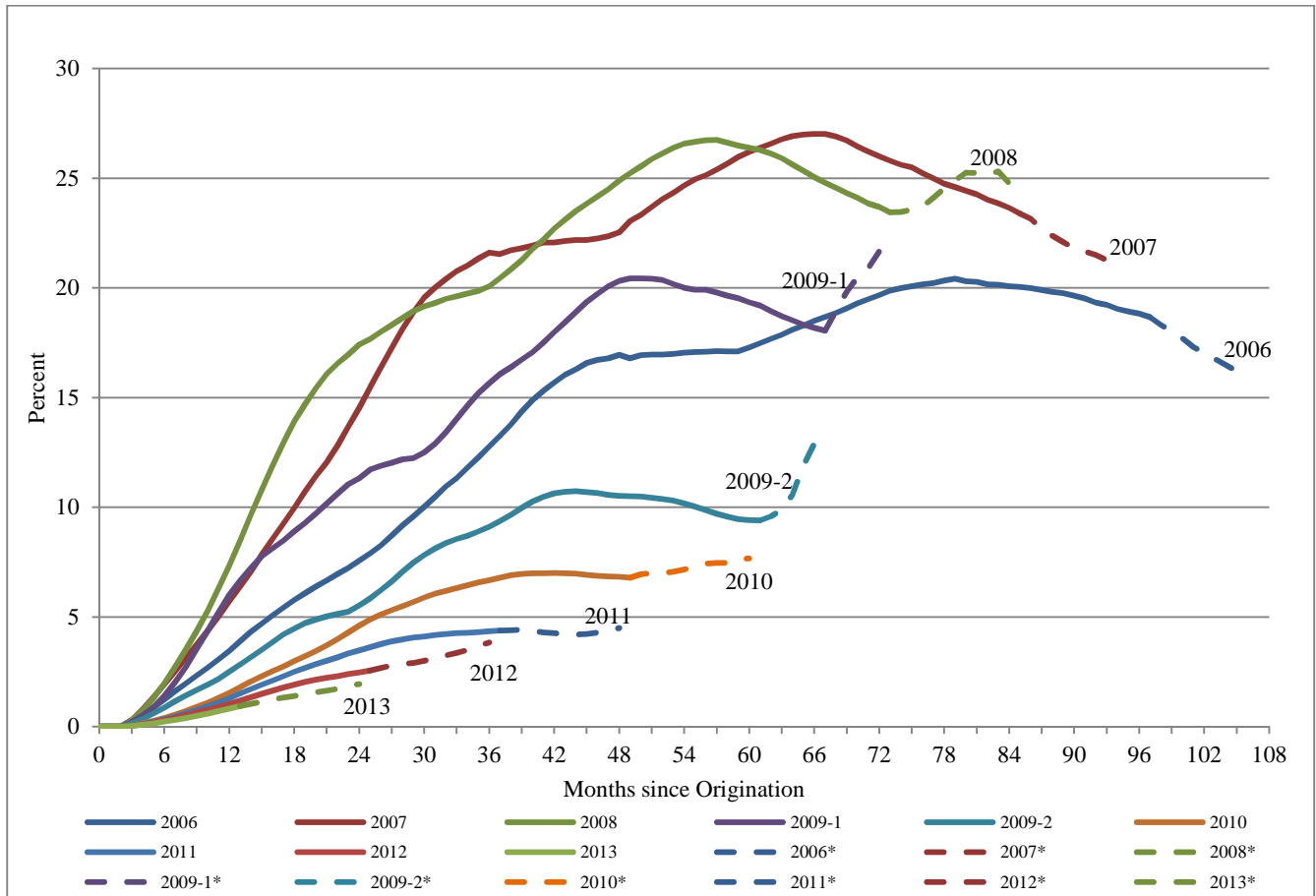

Figure 1: Seriously Delinquent Vintage Rate Curves by Fiscal Year (All Loans)

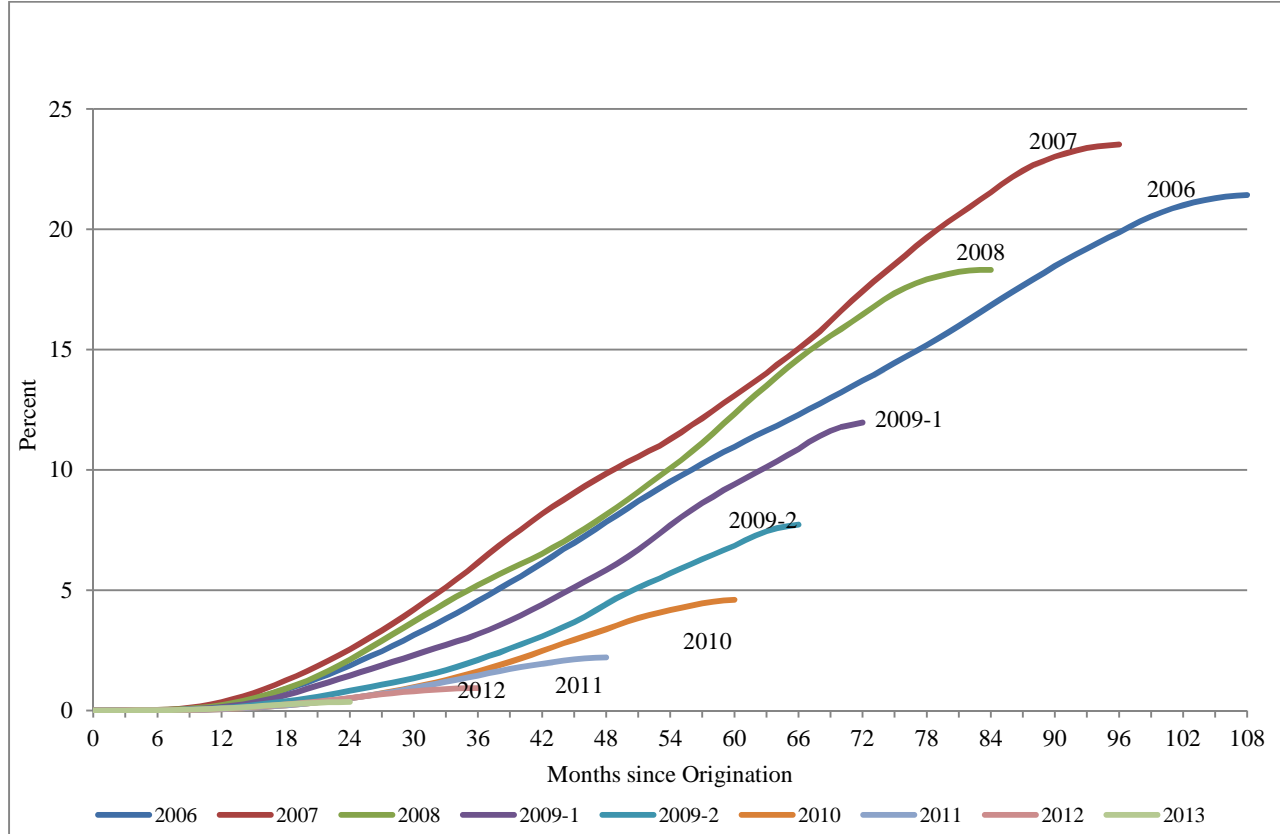
FY 2009 Shown in Two 6-month Periods^a
